Oregon Psychiatric Access Line about Kids (OPAL-K) was funded by the State of Oregon due to shortage of child mental health professionals in Oregon. OPAL-K continues its mission to expanding the availability of high quality mental health treatment to children in Oregon through the support of the "medical home" via timely psychiatric telephone consultation, clinician education, and primary care treatment algorithms. Since the launch of OPAL-K in June 2014, calls have been increasing at a linear rate (see graphs). Initially, we averaged two calls per week, we are now averaging 15-17 calls per week. There are times that we receive 8-10 consult calls in one day. After each call to ensure quality of the consultation service, a program evaluation questionnaire is sent to the PCP who received consultation. Approximately 35-40% of PCPs respond to the questionnaire indicating high satisfaction rate on the services they have received. (See attached PCPs' comments).

OPAL-K Symposium in Medford, Oregon

OPAL-K provided a free psychiatric symposium at the Jackson County Health Services in Medford on February 24, 2017. This symposium was a partnership between Oregon Heath & Science University (OHSU) and the Oregon Pediatric Society (OPS). This was a successful presentation where close to 40 medical providers from Jackson County area attended the meeting and received CMEs.

The following topics were presented:

- ADHD: What to do when stimulants don't work-Lewis Sprunger, MD
- Anxiety: Identifying and treating the anxious child- Ajit Jetmalani, MD
- Trauma: First step, be aware!- Teri Pettersen, MD
- Sleep: When Children don't sleep- Kyle Johnson, MD

• Adolescent Depression Screening, diagnosis, treatment, referral, and community resources- Keith Cheng, MD

Post survey evaluations of this presentation have shown high satisfaction from the medical providers attended the symposium. (See attached).

OPAL-K continues to strive for quality improvement in our major tasks that includes providing curbside phone consultation, educating the primary care providers, and continue outreach to various geographic locations in Oregon. OPAL-K's effort is to ensure providing continues support to the medical providers, in particular rural areas with limited or no mental health services.

Outreach and Registration

OPAL-K outreach continues to increase the number of clinicians presently enrolled. There are over 1300 medical providers enrolled in the program. As of March 21, 2017. We have received over 1400 consult calls. Some of the providers have made more than 30 calls to OPAL-K and received consultation at the time they made their call.

In an effort to increase provider enrollment our outreach staff continue to visit clinics, provide educational presentations to providers, and staff exhibit tables at conferences. These outreach efforts continue to generate robust enrollment and consult call activities from the medical providers in various demographic areas in Oregon. (See attached list of outreach)

All medical providers in Oregon can register directly for OPAL-K services on our website www.ohsu.edu/OPALK Some medical providers choose to register by calling the OPAL-K phone line: 503-346-1000 or 855-966-7255 at the same time that they call for their first consult. Approximately 98% of calls are hot-transfer, meaning that provider gets connected to one of our child psychiatrists at the time of their call.

Foster Care Support

In accordance with the State of Oregon legislative mandate, a psychiatric consultation program was created to provide a formal quality improvement process for supporting clinicians who care for youth in substitute care with particularly complex psychiatric needs. Annually the Oregon Division of Medical Assistance Programs (DMAP) reviews the psychotropic prescription regimen for every youth in substitute care. These reports are sent to the Oregon Department of Human Services, Office of Child Welfare Programs for review. If the prescription regimen meets one of the six criteria described below a referral is made to OPAL-K for a consultation with a board certified child and adolescent psychiatrist.

Since initiation of the program in November 2014, through March 2017, consultation has been

provided for the care of 129 youth in foster care.

The review and consultation process with the child and adolescent psychiatrist is a direct conversation between the treating clinician and the consulting psychiatrist. The conversation includes a review of the medical indications for the current psychotropic regimen, brainstorming strategies to revise the medication regimen if clinically indicated, identification of additional services that the youth in substitute care and their families may deserve including evidence-based psychotherapy, family support, and school services. Continued consultation is offered for very complex situations when multiple medication changes are recommended or there are changes in the treatment team. A summary of the discussion including recommendations is sent to the clinician and documented in a secure database for monitoring outcomes.

The following prescribing practices trigger a referral for psychiatric consultation:

- 1. Antipsychotics prescribed for an extended period without an FDA approved indication or without metabolic monitoring
- 2. Two or more chronic medications in the same pharmacological class
- 3. Four or more chronic psychotropic medications
- 4. Medications at higher doses than FDA recommendations
- 5. Medications prescribed off-label, outside of FDA approved use, or without evidence-supported use
- 6. Psychotropic medications for children younger than 6 years old, except stimulants in children at least 3 years old

Mental Health Care Guides:

Additionally, we are in process of development of care guides on autism, bullying, learning disorders, posttraumatic stress disorder, psychological first aid, psychotropic medication prescribing principles, and substance abuse.

Case Vignette

A pediatrician took over the care of a 12-year-old girl who previously lived out of state where provider had evaluated her for auditory and visual hallucinations along with out-of-control behaviors (at school and at home) and prescribed medications which the patient continues to take: Abilify/aripiprazole 10mg/day and Zoloft/sertraline 25mg/d. Since the now single mother and the patient's two siblings moved to Oregon, the girl is described as doing dramatically better in school and at home. It turns out that the patient witnessed significant domestic violence perpetrated against the mother. The pediatrician, concerned about the use of an atypical antipsychotic, notes that the patient is not reported to have gained weight while taking the medications (her weight and BMI are both 50-75th percentile), but she does have elevated lipids (confirmed by a repeat test). The pediatrician wants to get her patient off the antipsychotic, but the mother is anxious about rocking the family boat, what with so many changes in the past year.

The OPAL-K consultant agreed with the caller that tapering the patient off the medication was indicated that Trauma may have been the primary case of her original symptoms and the stable social situation is highly likely to be the chief explanation of the girl's improvements. Because hyperlipidemia does not represent a medical emergency, this is a situation where the pediatrician's trusting relationship with the mother and child can be used to come up with a collaborative treatment plan for tapering the patient off the antipsychotic. Elements of this plan would include making sure the mother (and patient at 12 years of age) understood the importance of the improved family setting, the risks of hyperlipidemia, establishing appropriate timing of the taper, and a clarification of what behaviors they would be monitoring. Parents in such situations often need to be reassured that stopping a medication is just as much of an intervention as starting it. If things do not go well, the pediatrician knew they could call OPAL K for additional support.







OPAL-K Registered Providers in Various Regions in Oregon









OPAL-K per Capita Incoming Calls Made by Medical Providers by County (per 1000 Population Age 0 to 17) May 2014-March 22, 2017




OPAL-K Age Distribution of Patients May 2014-March 22, 2017 n=1368
