Data used: Integrated Client System (ICS) data warehouse, as of March 2, 2017

This statistics is for OHP clients that meet both of the following two criterion:

- 1) adults only (ages 18-64)
- 2) they were enrolled in one of the Medicaid caseloads (OHP Plus, CAWEM, QMB, or BCCTP) in August of 2016 for Post-ACA analysis and August of 2013 for Pre-ACA analysis

OHP data is furnished from DSSURS/MMIS. The data was last updated on February 1, 2017.

Employment Department furnishes employment statistics into ICS. It was last updated in March, 2017. Employment data does not cover self-employed individuals.

There might be some double counting if client had more than one employment record for the quarter (only if the multiple records would fall into different employer size and type classifications). Employment data is for the 3rd quarter of 2016 for Post-ACA analysis and 3rd quarter of 2013 for Pre-ACA analysis.

Please note, that eligibility for OHP is not based on the wages of an individual, rather it's determined based on the family's adjusted gross income and household size.

Also, note that the employment data is a summary for the entire quarter, while OHP data represents the middle month of that quarter. The data is only reflective of the time for which data is provided. It is not representative of current caseload due to open enrollment and deferred redeterminations, neither it is representative of the future caseloads, as there is not enough data points to make assumptions about future trends.
