I wholeheartedly support Senator Laurie Monnes Anderson's proposed amendments on SB 1018 at which is outlined below on page 1 started on the line 22 to the page 4 on the strike of the section 10.

Additionally, please refer to current Oregon Administrative Rules (OAR) 411-019-0020 for the requirements of 12 members appointed by the Director of Department of Human Services (DHS). Please find enclosed OAR codes attached with this letter.

I add the proposals on amendments on page 1 from Lines 6 to 15.

It is my professional opinion that current rules are the best equipped to refer since all of the Deaf and Hard of Hearing community members, including for these who are Deaf-Blind have agreed on specific definitions of the various nature of disabilities. It is recommended to follow the definitions of these disabilities which are outlined under OAR 411-019-0010, as well.

I simply wish the current budget is better than I anticipate but it has forced us to roll back on some original versions of SB 1018. Nevertheless, I congratulate everyone who is working very hard on this legislation, including myself. I strongly encourage this committee to pass with a "to-do" pass recommendation for the floor's full votes.
