We've allowed pediatricians to erode, ignore, and violate parental and patient rights for far too long. It is time we put an end to the arrogant denial of informed consent occurring in pediatric practices today. The bottom line is that children are injured and killed by vaccines. Vaccines are not without risk. In fact, in America more infants die in the first year of life than in any other developed country. We rank 34th in year one infant mortality with 6.22 children out of every 1000 dying. At the very least, some of the blood of those infants is on the hands of the vaccine industry and the pediatricians that serve it. Vaccine risks cannot be denied and they MUST BE DISCLOSED to parents prior to vaccination.

Every day in Oklahoma parents are not only denied the truth, they are being exposed to risks they don't understand and sold on a medical procedure for the sake of physician convenience, efficiency, and profits. I think it is a travesty of justice and a violation of medical ethics.

I've heard so many stories from parents furious about the arrogant refusal of their pediatrician to discuss vaccination risks, ingredients, and alternative vaccine schedules with them. Somehow in American medicine, we've come to this intolerably unreasonable place in which doctors get away with denying patient/parent rights, patient autonomy, the right of patients/parents to be informed of the risks of vaccination, and even firing families that won't conform to their demands or the CDC vaccination schedule.

3.5 years ago my daughter called me crying from an exam room of a pediatrics clinic in Tulsa, OK. She was there for her first visit, 6 weeks after the birth of my grandson. She was crying because she was being bullied, harassed, and threatened with the removal of her child by Child Protective Services if she did not submit to immediate vaccination, including the hepatitis B vaccine that she refused in the hospital.

I was livid that a "medical professional" would use such ugly, abusive, and unethical tactics on a young, frightened mother, let alone the daughter of a physician. I told her to stay on the phone and immediately remove herself from the abusive pediatrician attempting to medically assault her child, my grandson. What happened in that pediatric clinic to my daughter happens to parents every day in Tulsa, in Oklahoma, and in America. It's unethical, unprofessional, and needs to be exposed for the abuse that it represents.

A Tulsa pediatrician bullied and threatened my daughter in an attempt to coerce and force her to inject my grandson with vaccines that she and I believe are unnecessary and potentially dangerous. That experience opened my eyes to a side of medicine that I had no idea existed. Now I realize it's everywhere. I won't tolerate it and allow it to continue. I will speak out against it at every opportunity. I will do my best to protect children and parents from the medical abuse occurring in pediatric offices every single day. It is time we demand and enforce the provision of INFORMED CONSENT for vaccines.
