### WHAT THE MEASURE DOES:

Establishes Oregon Deaf, Deaf-Blind, and Hard of Hearing Program (Program) within Department of Human Services (DHS). Establishes Oregon Deaf, Deaf-Blind, and Hard of Hearing Committee (Committee) to administer program. Specifies components of program and duties of committee. Becomes operative January 1, 2018. Takes effect 91st day following sine die.

### **ISSUES DISCUSSED:**

- Budget concerns and possible amendments
- Need for experienced professionals and balanced community representation on committee
- Necessity of Oregon to expand access to deaf and hard of hearing services; comparison to services in other states
- Differing services needs by different types of disabilities and role of services in accessing individual rights
- Need for services for deaf and hard of hearing community members with additional disabilities

# **EFFECT OF AMENDMENT:**

-1 Replaces provisions. Modifies definitions and requires DHS to define terms by rule. Modifies membership of Oregon Deaf, Deaf-Blind, and Hard of Hearing Committee to advise DHS. Establishes Oregon Deaf, Deaf-Blind, and Hard of Hearing Program administered by DHS in consultation with Committee. Specifies components and mandates of Program. Requires DHS contract with certified sign language interpreters in consultation with Committee.

### **BACKGROUND:**

Oregon law establishes the Oregon Deaf and Hard-of-Hearing Program in the Department of Human Services (DHS). That program gives technical assistance to make agency programs accessible to hearing disabled people, to advise policy makers, and promote information about the needs of hearing disabled people and available programs. The program serves in primarily an advisory role.

Senate Bill 1018 establishes the Oregon Deaf, Deaf-Blind, and Hard of Hearing Program (Program) in DHS, and establishes the Oregon Deaf, Deaf-Blind, and Hard of Hearing Committee (Committee) to administer the program. The measure also repeals the existing statutory program in DHS described above.

Senate Bill 1018 requires the Committee, as part of the Program, to: collect relevant data and act as a public information source; conduct studies on issues relating to people with hearing disabilities; submit reports and recommendations to the Governor's Office and Legislative Assembly; advocate for people with hearing disabilities;

maintain a sign language interpreter referral service; assist in making state programs accessible to those with hearing disabilities; and implement a long-term plan for providing essential services to people with hearing disabilities. The measure requires the State Board of Education to consult with the Committee on rules setting standards for interpreters in schools. It also permits public agencies to contract with the Committee for provision of sign language interpreter services.
