I am writing you today to give my input on the following gun bills.

SB 897

The term "militia" has been demonized by media and representatives in our State and Federal Government. Militia, as defined by http://www.dictionary.com/browse/militia?s=t, has the following definitions: 1. a body of citizens enrolled for military service, and called out periodically for drill, but serving full time only in emergencies. (This is the National Guard); 2. a body of citizen soldiers as distinguished from professional soldiers. (This is the rest of the nation); 3. all able bodied males considered by law eligible for military service (this is all males 18-35); a body of citizens organized in a paramilitary group and typically regarding themselves as defenders of individual rights against the presumed interference of the federal government (this is a small percentage of people). The way the media defines militia, is the fourth definition given, which is a very small percentage of the population in America. As the bill is written, a group of hunters can be charged with "militia terrorism" just by being on property armed if they are asked to leave. Let's say a family is camping on public lands and the parents are armed to protect their family from wild animals. If somebody sees that they are armed and reports it to "the authorities", who ask the family to leave, can they be charged as this bill is written? In my opinion, yes, they could. The only thing this bill does is strip rights away from law abiding individuals. Will YOU be charged if you are caught in a circumstance like the camping issue I mentioned? Probably not. Since you wrote the law, you probably have no intention of following it yourselves. You would use your name and influence to not be charged. How about you just let us live our lives and quit interfering, thinking you know what is best for me and my family. I strongly recommend that you oppose this bill.

SB 797

This bill is just poorly thought up and written. Oregon State Police being allowed to indefinitely deny a firearm purchase for no reason? That is beyond crazy, since most denials are the result of errors. Once again, our elected officials thinking they know what is best for us. I thought we were a representative republic, not peasants to be ruled over. This bill is dangerous and may prevent people from defending their families.
