

SB 48 -1, -2 STAFF MEASURE SUMMARY

WHAT THE MEASURE DOES:

Directs certain professional regulatory boards to adopt rules requiring professionals to complete continuing education requirements related to suicide prevention. Directs Oregon Health Authority (OHA) to oversee development of continuing education opportunities by relevant boards and submit a biennial report to Legislative Assembly documenting completion of training. Becomes operative January 1, 2018. Declares emergency, effective on passage.

ISSUES DISCUSSED:

- Importance of medical and behavioral health professionals in diagnosis and treatment of suicide risk
- Other state laws regarding suicide prevention continuing education

- Current medical and behavioral health professional continuing education requirements

EFFECT OF AMENDMENT:

-1 Replaces measure. Directs "boards" to collaborate with OHA to adopt rules regarding continuing education requirements related to suicide prevention upon reauthorization to practice. Requires professional associations to offer suicide prevention continuing education. Establishes record keeping and reporting requirements. Requires OHA to report compliance to Legislative Assembly by August 1 in even numbered years. Requires OHA approve and develop list of continuing education opportunities. Becomes operative January 1, 2018. Declares emergency, effective on passage.

SB 48 -1, -2 STAFF MEASURE SUMMARY

In Oregon, various medical and non-medical professionals are expected to care for people that are at risk of suicide and everyone may not have thorough or up-to-date suicide prevention before coming into contact with people who are at risk of suicide.

Senate Bill 48 directs state licensing boards for certain medical and non-medical professions to require regular continuing education in suicide risk assessment, treatment, and management. Certain non-medical professions are required to have suicide prevention training every six years, while certain medical professionals are required to complete such training at intervals determined by the relevant licensing board. The measure requires the Oregon Health Authority (OHA) to develop a list of continuing education opportunities for suicide prevention and approve each board's training. Senate Bill 48 also directs the relevant licensing boards to document completion of suicide prevention training and report that information to OHA, which OHA then includes in a biennial report to the Legislature. The measure also authorizes the relevant licensing boards to use budget appropriations to administer the new training requirements, and authorizes the boards and OHA to take appropriate action to prepare for implementation prior to the operative date.
