



#### E-Government Services Contract

The current E-Government Program Contract is with NICUSA



- 10 year master contract, renewable. Now in 4<sup>th</sup> year
- All data is owned by the agency
- Application source code is put into escrow and provided to state at end of contract
- Each new application is a work order to the Master Contract that complies with HB 2375, DAS documented review and DOJ Legal Sufficiency review for agency director
- Each Work Order executed against the master agreement receives oversight and prioritization via the *Electronic Governance Portal Advisory Board* per ORS 182.128
- Master Contract was reviewed and approved by the Electronic Governance Portal Advisory Board (EPAB)
