Senate Bill 5531 is the fee bill for the Health-Related Licensing Boards. The only fee included in this measure is for the Board of Medical Imaging for the workforce data licensee fee that is charged by the Oregon Health Authority (OHA).

The Board of Medical Imaging began providing licensee workforce data to OHA in November 2016. The data is collected by the regulatory boards from individuals at the time of renewal for their license to practice. By rule, OHA has established a per-license fee to cover the cost of collecting and reporting health care workforce information. The fee is set at \$4 per individual for a two-year license, and \$2 per individual for a one year license.

There are currently 17 health care workforce regulatory boards that provide, or will be providing beginning in 2017, information for the workforce database. The Board of Medical Imaging intends to pass on this \$4 fee for their biennial licenses to the licensee. Currently 12 of the 17 reporting boards pass on the fee to their respective licensees. The fee revenue is anticipated to be \$25,100 Other Funds, which will all be transferred to the Oregon Health Authority.
