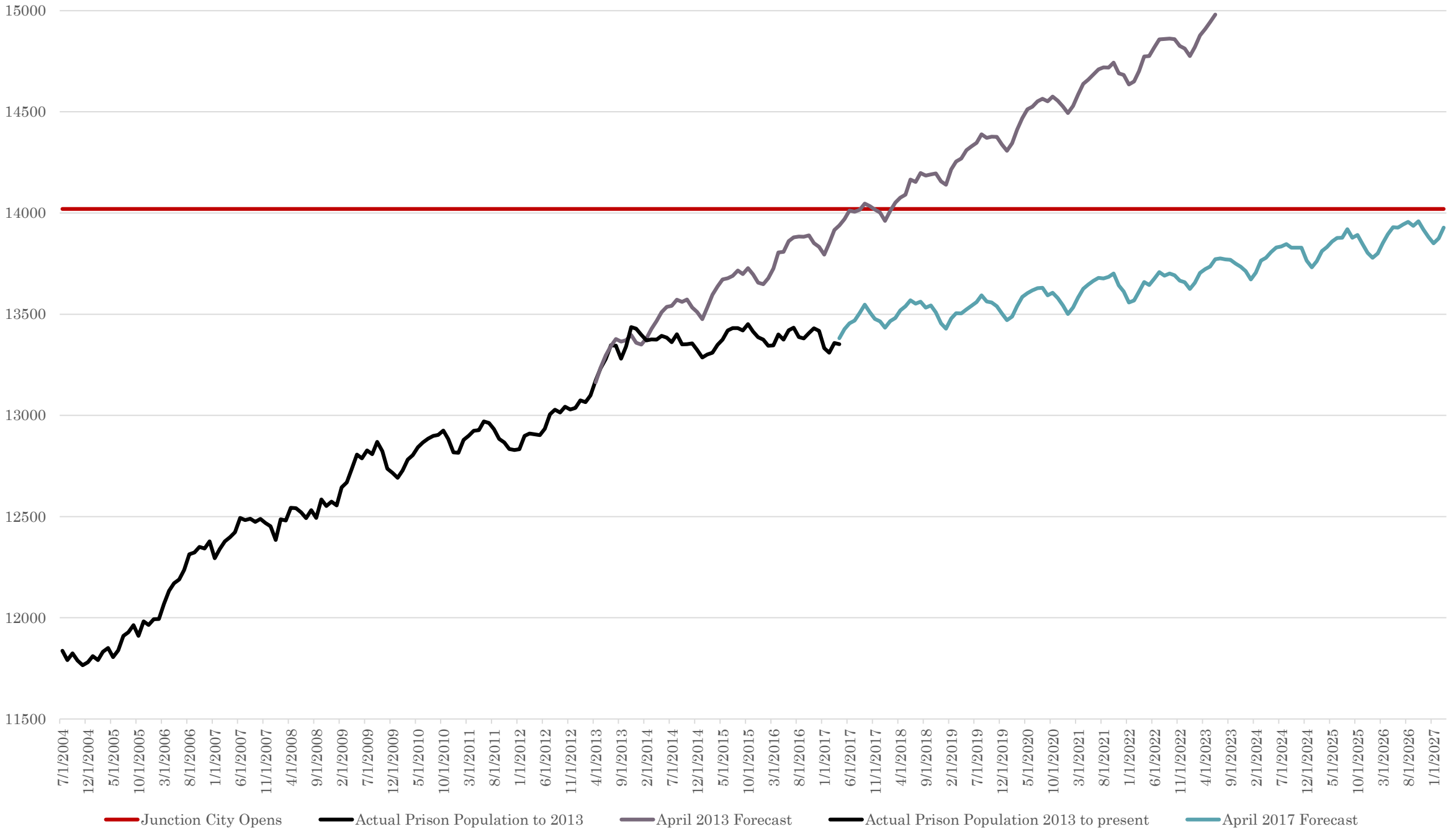

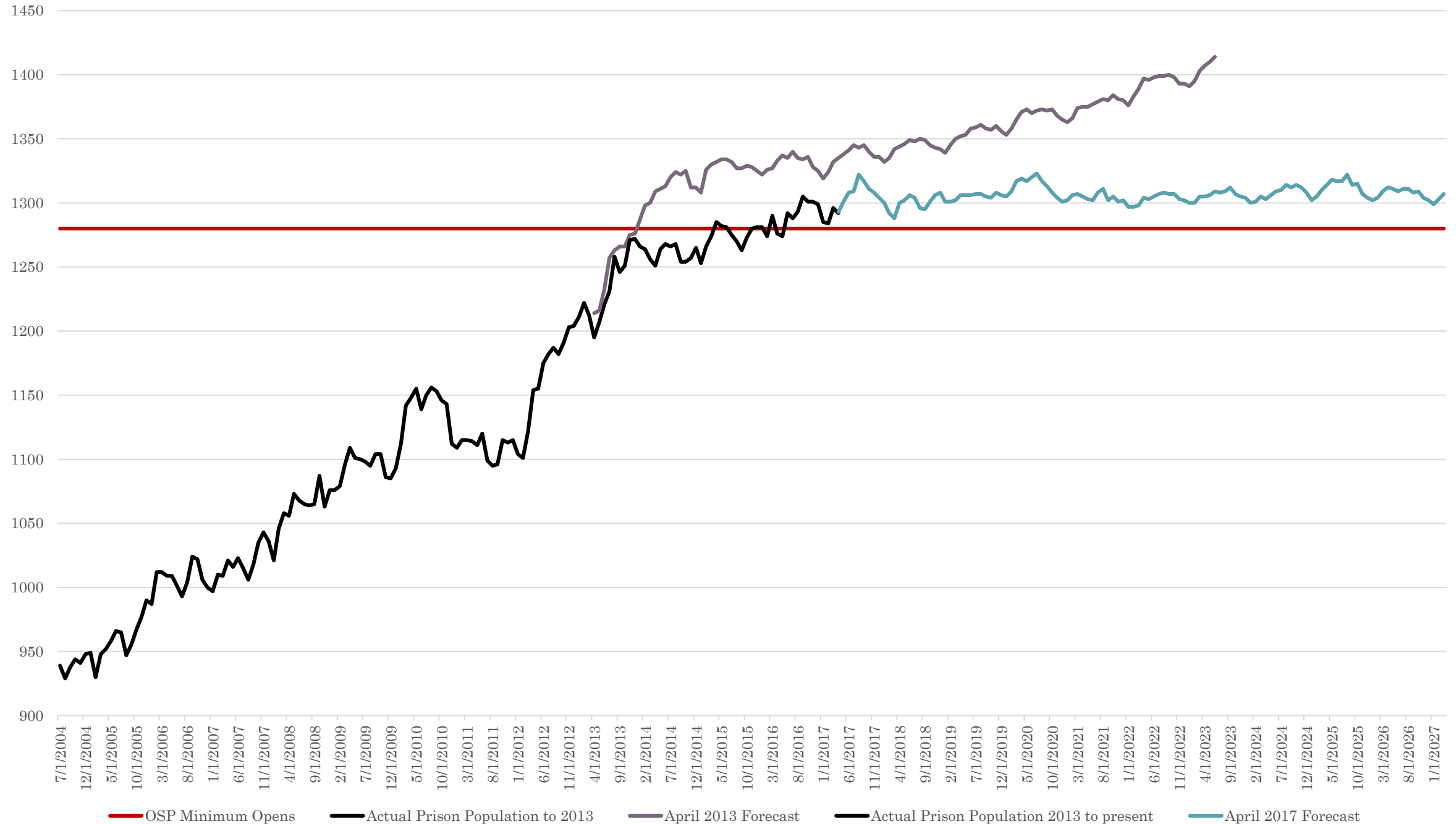
JRI Grant Process

- Grant Review Committee Begins Reviewing RFP's August 2017
- Victim Advisory Panel Begins Reviewing RFP's August 2017
- Recommendations made to CJC Commissioners September 2017
- Grants Awarded November 2017

Male Prison Population and Forecasts to 2027



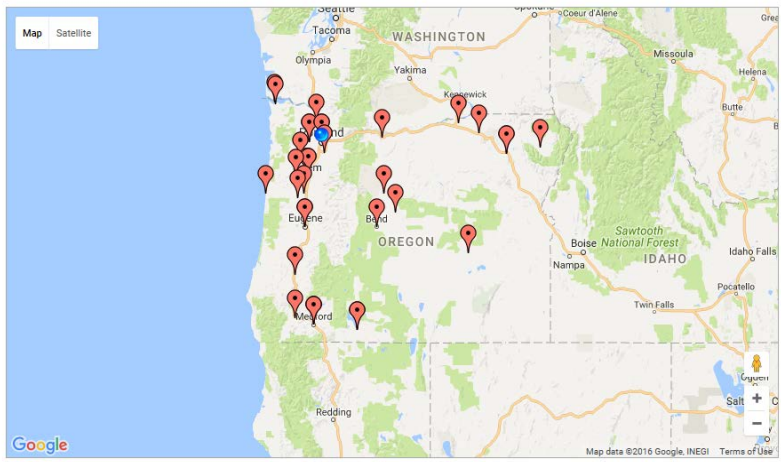
Female Prison Population and Forecasts to 2027





SPECIALTY COURTS GRANT PROGRAM

The agency is charged with serving as *a clearinghouse and information center for the collection, preparation, analysis and dissemination of the best practices applicable to specialty courts.*



The competitive grant program calls for evidence-based problem-solving court strategies designed to address the root causes of criminal activity and substance use disorders as an alternative to incarceration with the goal of teaching participants to become productive law abiding citizens, which reduces recidivism and provides for healthier communities.

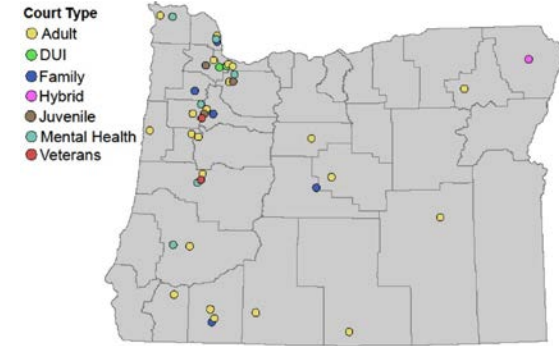

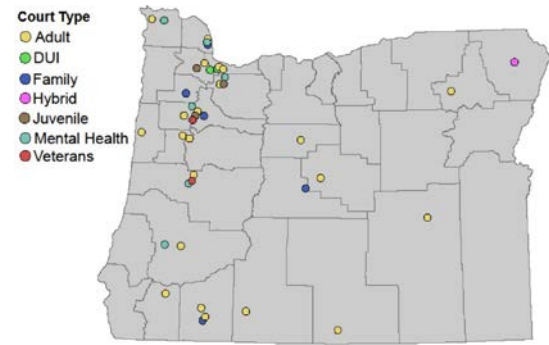

IMPACT ON SPECIALTY COURT BUDGET

Governor's Budget Impact:

- DECREASED General Fund by \$3,500,000
- INCREASED Other Fund by \$500,000
- INCREASED Federal Fund by \$3,000,000

Total: \$15,611,365



IMPACT ON SPECIALTY COURT BUDGET

Federal Fund

- Revenue is 2017 and 2018 Edward Byrne JAG federal grant
- Uncertainty around State of Oregon receiving federal grant funds due to federal sanctuary policy
- Uncertainty entities that will be eligible for pass through funds due to sanctuary designations
- Assumes federal grant formula allocations will remain stable

Other Fund

- Revenue for specialty courts collected through asset forfeiture seizures.
- Revenue is projected and not guaranteed



IMPACT ON BYRNE JAG GRANT FUNDS

\$3 million Federal Fund Shift Obligates 2017 and 2018 grant awards to specialty court program entirely.

Eliminates Commission's discretion to fund innovative criminal justice programs.

Eliminates Commission's ability to continue to fund existing programs including:

- Center for Policing Excellence Micro-grants
- Witness Intimidation Support Program
- Specialty Court Symposium
- Justice Reinvestment Summit
- Targeted Need Based Grants
- Victimization Survey
- Public Safety Checklist
- Specialty Court Peer Review Survey Processing



Criminal Justice Commission

Justice Reinvestment Summit

- 2 days of programming
- 36 counties represented
- 889 attendees
- 19 breakout sessions
- 4 work sessions
- Paid for by federal grants and sponsorships from counties and statewide associates.
- Speakers from around Oregon and around the country.

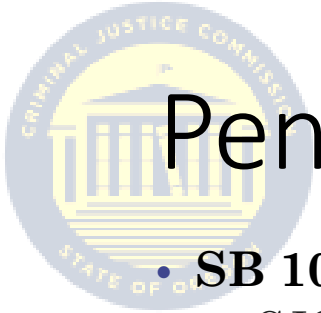

Pending Legislation

- **SB 1041**

- CJC Shall Track all Public monies spent on A&D
- CJC shall Analyze outcomes of A&D treatment where public monies are expended

- **HB 2238**

- Extends Public Safety Task Force
 - Study the Impact of Imposition of Criminal Fines and Fees
 - Study security release in Oregon, focusing on reducing racial and ethnic disparity in pretrial incarceration
 - Continue to oversee implementation of JRI
- Removes Sunset from Racial and Ethnic Impact statements

- **HB 2355**

- Racial Profiling Tracking and Analysis

- **HB 2600**

- CASA transferred to CJC
