


Union County's Living Room: The Liberty Theatre Campaign

Who We Are: The Liberty Theatre first opened its doors in 1910 as a venue for live performances. It later became a movie house and screened the classics of the day right up to its closure in 1959. It was a central icon in the landscape of downtown La Grande and served as a special entertainment space for many generations. In 2009, a group of La Grande citizens came together to form a nonprofit organization with the goal of restoring the Liberty. The Liberty Theatre Foundation (LTF) became an independent nonprofit, 501(c)3 organization in 2012. Its mission is to restore and operate the Theatre as a performing arts center, providing cultural and educational experiences.

The Vision: LTF envisions a vibrant community where people come together to experience great art, culture, and entertainment in an accessible, sustainable, and historic venue.


Project Scope: To reclaim, restore and refurbish the 1010 Adams Liberty Theatre building as a cultural center and Union County Living Room destination. LTF is actively seeking federal, regional, state and local support to preserve historic ambiance and improve community art opportunities, creating a magnet for reinvestment, downtown revitalization and economic development. LTF's revised campaign goal is a lean \$2.5 million with a focus on getting the theater up and running with the technical and theatrical equipment needed for live performances and screenings. LTF's revised campaign will retain original architectural elements of the Theatre's design as well as preserve existing historical layers.

The Challenge: The strengthening of community through historic preservation and creating "livability" as a funding priority requires leadership philanthropy, foundation and grant support leveraged by community investment at all levels. The hub of Union County is La Grande and creating a regional performing arts center with diversity of cultural and artistic opportunities is the goal of this campaign.

The Solution: The restored Liberty Theatre will seat up to 470 patrons at live performances, as well as showings of classic and independent films. The theater will be the home of the Eastern Oregon Film Festival as well as a host for local



performing groups, including the La Grande Shakespeare Company, Grande Ronde Symphony, Grande Ronde Community Choir, and the Eastern Oregon University theater department. The modern facility will also attract touring performers traveling to and from the Boise and Portland metro areas. Amenities will include concessions offering food and drink, handicap accessible restrooms, and a mezzanine lounge.

Economic Development: Each year, more than \$150 million is spent by Oregon's arts and culture consumers, over and above the cost of admission to art events. For every \$1 million in sales by Oregon's cultural nonprofits, \$1.1 million in sales is generated for other Oregon businesses. This means local restaurants, retailers, hotels, and other businesses benefit from a thriving arts scene, and Union County is no different. LTF anticipates the creation of 2 FTEs upon opening, in addition to the Executive Director. Within five years as programming grows, LTF anticipates employing 5 FTES (artistic direction, stage management, business/marketing) with that number doubling by Year 10 of operation. These positions will offer competitive wages and benefits. These numbers do not include other payroll employees such as concession workers, janitors, ushers, etc., or contract employees hired for specific projects and events.

Project History: To date LTF has nearly completed exterior facade improvements, including brick repointing, mansard and window repair, and the installation of a replica "blade" sign. Interior demolition has opened up the auditorium and stage area for the first time since the early 1960s, and recent work has stabilized the auditorium ceiling. This work represents more than \$670,000 or 27% of the total campaign goal of \$2.5 million.


Status: LTF is engaged in philanthropic outreach within Union County. It has also issued challenge requests to the City of La Grande and Union County to leverage a 2017 Oregon Legislative request of \$1 million. A team from LTF testified in March 2017 before the Joint Ways & Means Committee and will return to Salem this spring.

Honorable Co-Chairs Girod and Holvey, and members of the Joint Committee on Ways and Means Subcommittee on Capital Construction:

Good afternoon. My name is Kelly Ducote and I sit on the Board of Directors for the Liberty Theatre Foundation. Four years ago my family moved to La Grande from out of state. We came for a job; we stay because we see so much potential in La Grande, and the Liberty Theatre plays a major role in that.

La Grande is proud to be the home of its own Shakespeare Company; a number of great bands; talented youth who bring fantastic theatrical and musical performances and accolades to our valley; and even a film festival. Many of these groups have already used the theater in an interim state and look forward to a grand reopening, as you will note in the support letters provided.

We have raised nearly \$680,000 in cash, in-kind donations, and grant awards for the restoration of our facility. This includes a \$150,000 contribution from the La Grande Urban Renewal Agency. Our nearly complete major gift study suggests we can count on additional local support of up to \$200,000, including county funding of \$50,000. In addition, identified private foundation support that will become available with your favorable funding of this project will more than match the \$1 million we request before you today.

La Grande's largest employer, Grande Ronde Hospital, and the Union County
Chamber of Commerce support this project as a major community amenity needed to
retain quality professionals in La Grande and the greater Grande Ronde Valley. Our Urban
Renewal Agency sees this project as one that will drive foot traffic and help revitalize La
Grande's downtown core. Well positioned on the I-84 corridor, this venue will not only be a
home for our local arts community but also a prime stop for performers traveling between
Boise and the Portland metro areas.

As we presented to the Ways and Means Committee recently on Feb. 17 at Hermiston High School, we are requesting Honorary Co-Chairs and Members of the Committee for your support to fund our \$1 million request to restore and reopen the Liberty Theatre on Adams, next to City Hall, in La Grande as a regional economic driver, attraction for tourism and performing arts venue for local and travelling performances. We are confident in our ability to match this request and complete the project as a public asset to Eastern Oregon. Thank you for your consideration.

Honorable Co-Chairs Girod and Holvey, and members of the Joint Committee on Ways and Means Subcommittee on Capital Construction:

Cities across America are restoring their historic downtowns in an effort to both preserve their past and ensure a vibrant future. At the core of these initiatives are the restoration of performing arts venues, primarily old theaters having been shuttered or repurposed from their former glory. Why are there so many cities investing in the performing arts as essential aspect of urban renewal?

Economists have demonstrated through case after case the impact of a restored theatre in a down town. Larger cities like Durham, NC (\$7-13M/year impact), Grand Rapids, MI (\$369M), Birmingham, AL (\$27M) have demonstrated significant economic impact in the community as result of a downtown transformation. Smaller towns as well show proportional impacts, Boone, NC (\$4.5M), Fort Pierce, FL (\$2.3M), and Shirlytown, VA (\$4.0M). These are just a few of the dozens of current projects that urban renewal districts and cities have taken on to directly impact the economic vitality of their regions.

In both small and large centers, how these numbers are determined is a matter of vetted impact models that economists use to determine both direct and indirect effects. The direct effects are immediate changes in jobs created through construction and restoration, jobs for performing artists, and jobs for all those who are involved in maintaining and managing the venue. The activity that a performing arts center offers has a tangible effect on area retail and service businesses as it increases visibility, sales, and land value in adjacent properties. Indirectly, a restored theatre serves as a catalyst in a community. It is a signal that the community has a cultural soul, a point of prosperity. Communities experience a revival, of sorts, as businesses and activities seem to add arithmetically around these developments.

La Grande is on the edge of such a revival. The community and region needs a trigger to stimulate the attention to the downtown, to focus investment in the community, and to attract new business and enterprises. Like many other cities who have experienced the same effects, we believe that supporting the rebuilding of the Liberty Theatre is not only an effort to preserve our legacy as a community and to impact the quality of life in the region, but it will also serve as an economic stimulus that will bring jobs and economic sustainability. The dollars that are invested in this project will be returned to the community many times over. It is not only a preservation of the past, but also an investment in the future.

Honorable Co-Chairs Girod and Holvey, and members of the Joint Committee on Ways and Means Subcommittee on Capital Construction:

My name is Dale Mammen. I am Co-Chairman of the Liberty Theatre Foundation Board of Directors in La Grande.

The Liberty Theatre enhanced the life of La Grande from November 1910 when it opened as "one of the finest vaudeville houses in the northwest" until it went dark in May 1959 and was turned into commercial space.

In 1999 the City formed a Historic District and the theatre was placed on the National Register of Historic Places. In 2010 a group formed to explore the restoration of the Liberty and in 2012 the Liberty Theatre Foundation secured ownership.

La Grande's need for such a theatre did not die in 1959. Since 2012 the Liberty has been transformed from commercial space to a bare bones form of its former self. During the last five years and the various states of demolition it has provided a home for the growing Eastern Oregon Film Festival, a temporary stage for an active new Shakespeare troupe, and a theatre lab for Eastern Oregon University students to direct and perform plays.

There is no other venue like this available in La Grande. Now is the time to preserve not only the historic fabric of the building, but to provide a fully functional theatre to again provide a significant contribution in which current and future generations can be creative, entertained, educated and inspired. Honorable Chair Girod, Honorable Co-chair Holvey and Members of the Joint Committee on Ways and Means on Capital Construction:

I apologize I cannot be physically present for the hearing today. So, in writing, I present myself to you as a citizen and leader from the City of La Grande, and as a supporter of the efforts to restore the historic Liberty Theater. While these efforts have been local to date, it is time for a financial boost to push the project to the next levels; the funding request before you is that boost.

The theater restoration project is an important piece of economic development in downtown La Grande for visual appeal and sustainable business activity. Until the restoration project began, the theater building was partitioned into two retail spaces and the façade no more distinct than other structures along Adams Avenue. Pedestrians passing these spaces knew little to nothing of the history or potential behind the retail offerings. With the incredible efforts of volunteers and private donations, the rudimentary features of the theater are now visible, including a full view from sidewalk to stage, remnants of past wall coverings, and a lighted marquee sign. These simple, yet important visual changes, have generated curiosity and hope about the offerings the theater will bring to downtown.

There is no venue in La Grande, other than a dedicated movie theater, as close to restaurants, pubs and retail shops as the Liberty. Evidence from communities throughout Oregon and the Pacific Northwest indicates events held at multi-purpose theaters have a multiplier effect on local businesses. People coming to and leaving daytime and evening events at the Liberty will frequent nearby businesses and increase foot traffic along Adams Avenue. In a rural community like La Grande, sustainability is built on diversifying the economy, and a restored and operational Liberty Theater will add to that diversity. An investment by the State of Oregon in the Liberty Theater will go a long way to improving the economic sustainability and quality of life La Grande needs to continue growing and serving as the business and public hub of Northeast Oregon.

As the Mayor of La Grande, my sights are set not so much on what happens today, but where the community is headed. I see the Liberty Theater as a focal point of community activity, a place residents can boast about to friends and family in other areas of the state and region. The Agency wants to assist in the Foundation's effort to receive this vital State funding to help make this project a reality. Therefore, at their April, 2017, meeting, the Agency unanimously voted to forgive the \$150,000 loan, including interest, contingent upon the State Legislature approving their request for \$1 million.

The Agency believes the restoration of this historic theater will be of significant benefit to the immediate downtown core as well as the broader region. It is our hope that the restoration will prompt interest in preserving other contributing buildings in our Historic Commercial District, resulting in more private investment, and the corresponding increase in property values.
