Consolidation of Oregon Transparency Program datasets that began in 2015, continued in 2016.

<u>Current Status</u>: The Oregon Transparency Program datasets are now **44.6%** of the total datasets residing on Data.Oregon.gov.

What is a Public Meeting?

The 2011 Oregon Legislature passed <u>House Bill 2788</u>. HB 2788 requires State Agencies, Boards, Commissions, and Education Service Districts (ESDs) to "...post on the Oregon Transparency website notices of public meetings required to be provided by the state agency under <u>ORS 192.640</u>."

As State Agencies, Boards, Commissions, and Education Service Districts (ESDs) determine which meeting notices to post on this site they will be asking themselves:

Is it a "public meeting"?

- Does the meeting involve a government entity of any type local, regional or otherwise? (This entity is known as a "public body.")
- Do the people attending the meeting have authority to make decisions or recommendations to the public body? (This group is known as a "governing body.")
- Is a quorum required for the governing body to meet in order to make a decision?
- Is the governing body planning to make a decision or deliberate toward a decision of any type at the meeting?

If the answer to <u>all</u> questions is "Yes", the meeting is a "public meeting" and falls under the requirements of <u>HB2788</u>. For additional detail, refer to <u>ORS 192.610 to 192.690</u>.

New: 2016 Composite Datasets

The OSCIO\Oregon Transparency Program working pro-actively and collaboratively with partners at various agencies and groups, resulted in the creation of additional composite datasets that are now available through the Oregon Transparency Website.

New: DAS Contracts – ORPIN System Contract Data

New - ORPIN: Contracts - Composite Report

Department of Administrative Services Procurement Services (DASPS) is the central procurement authority for those state agencies that are subject to DAS authority. The office develops, establishes, and administers statewide contracts for goods and services on behalf of state government and Oregon Cooperative Procurement Program (ORCPP) members. The reports and descriptions listed below reflect the diversity of the environment in state government contracting and procurement.

State law gives many agencies authority to enter into contracts outside the State Procurement Office. Examples include the Oregon Lottery, Judicial Department, Department of Transportation, and the Oregon University System.

New this year, a **composite report** that contains all versions of contracts and amendments issued in ORPIN (Oregon Procurement Information Network) from **July 1, 2009 through June 30, 2016** is provided below. This report is sorted by agency number and is machine readable.

The following data is provided as an extract from the Statewide Procurement System (Oregon Procurement Information Network - ORPIN).

New this year, a composite report that contains a list of ORPIN contracts that expired between July 1, 2009 and June 30, 2016 is provided below. This report represents the full extent of electronic records of expired contracts that are tracked within ORPIN. The contract values reflected in this report are estimates only. This report is sorted by agency number and is machine readable.

Note: A number of contracts may indicate an "Amendment Date" that may exceed the "Expiration Date". In these instances, the "Amendment Date" reflects an automated system time/date stamp that the system appended to the contract when the electronic version was accessed or modified, not necessarily when the legal instrument (the contract itself) was modified.

This report may not include contract information for the Oregon Judicial Department, Oregon State Lottery, Oregon University System, Oregon State Treasurer, or semi-independent state agencies, boards, and commissions. Some executive branch agencies have independent contracting authority for specific goods and services (e.g., Transportation, Secretary of State, State Treasurer, Human Services, Fish and Wildlife, Parks and Recreation, Aviation, Economic and Community Development, Housing, Corrections, Veterans Affairs, Military, Education, and state agencies "specifically authorized" by any law outside the Code to "enter into a contract"). The ORPIN system may not capture contract information about those activities.

New - Enterprise Zone (EZ) County Assessor & Local Zone Manager Reports

Oregon's enterprise zones offer a unique resource to Oregon communities, and an excellent opportunity for businesses growing or relocating in Oregon. Primarily, enterprise zones exempt businesses from local property taxes on new investments.

Sponsored by municipal or tribal governments, an enterprise zone typically serves as a focal point for local development efforts. There are <u>69</u> enterprise zones creating better opportunities for business investments across Oregon: <u>54</u> rural and <u>15</u> urban.

New this year, **composite reports** that includes data and information from all Enterprise Zone County Assessor Reports for both 2015 *and* 2016 are provide below. These reports have three (3) parts, are sorted by *year reported* for each County Enterprise Zone, and are machine readable.

Oregon Film: Oregon Governor's Office of Film & Television

The following reporting topics are managed by the Oregon Governor's Office of Film & Television.

Greenlight Oregon Labor Rebate

The Greenlight Oregon Labor Rebate (Greenlight) is designed to recruit film, television, interactive media, and commercial production as well as post-production to Oregon. Through a combination of these programs (Greenlight, OPIF and iOPIF [see below]), the Oregon Film & Video Office recruited and tracked over \$169,000,000 of film, television and media production spending in the state as well as an estimated \$20,000,000 of television commercial spending during the fiscal year 2015-2016 supporting more than 2200 jobs and countless local vendors. Greenlight is an essential tool along with the Oregon Production Investment Fund in recruiting film, TV and media production and Greenlight, specifically, is an invaluable tool in expanding the TV commercial sector. In order for a producer to qualify for Greenlight, they must meet a set of criteria including:

- Submit an application (found via http://oregonfilm.org/incentives/).
- Film and TV producers must spend at least \$1,000,000 in Oregon on a project.
- TV Commercial producers must spend at least \$1,000,000 in Oregon over one calendar year.
- Submit detailed report of Oregon expenses subject to an audit.

Greenlight provides a 6.2% rebate on qualified Oregon labor expenditures. This is currently defined as labor expenditures subject to Oregon withholding taxes.

In previous years, a text based PDF styled report was posted, but was not machine readable for ease of use.
