

For Every Kid Coalition requests changes in Transportation Package
June 7, 2017

Long version: Spoken testimony on 6/7 by LeeAnne Ferguson

Good evening, Co-Chairs Beyer and McKeown and Committee Members. My name is LeeAnne Ferguson. I am here representing the 125 organizations and thousands of individuals that make up the For Every Kid Coalition.

On behalf of everyone, I urge you to support increased funding for SRTS projects, include projects with in a 1 mile radius of schools, include funding for SRTS program, prioritize Title 1 schools, reduce the 40% local match for underserved communities and make comprehensive and effective Safe Routes to School a priority.

Over the past ten years, I have had the opportunity to teach walking and biking classes to thousands of kids, lead walking school buses, facilitate street safety needs assessments at schools, and organize walk to school days. Over the last 6 months our Coalition held 6 town hall meetings across Oregon. We heard how SRTS programs help kids with behavior issues succeed, how a student was hit in an intersection that was supposed to get a safety improvement but hadn't gotten it yet due to funding, how families and students need options for getting to school so they can graduate on time.

Safe Routes to School is so much more than words on a piece of paper, it's safe, healthy, happy kids, as well as teachers, parents, grandparents, and neighbors.

Safe Routes to School infrastructure projects alone can increase walking and biking to school by 20% and when you combine that with education and encouragement programs, 40% more kids will walk and bike to school. That's 40% more kids getting 66% of their daily recommended exercise, less parents dropping their kids off at school, and increased safety on streets around schools. This is a return on investment that we cannot ignore. Please fund education programs at \$6M annually and safety projects at \$15M annually.

Last year Washington County prepared a report (https://s3.amazonaws.com/washcomultimedia/CMSBigFiles/Final_SAIS_Report_11062015_DMoo.pdf) on Safe Routes to School needs for 53 schools. The street safety improvements were estimated at \$100M. This is the most thorough estimate of Safe Routes to School infrastructure improvements that I have seen. This information makes me suspect that investing \$10M for 10 years to fill all Safe Routes to School projects with in a ¼ mile radius of school won't be enough. Please remove the 10 year sunset on the program. Please prioritize Title 1 schools so that Safe Routes to School programs and safety projects can first reach the students that need it most.

Children in Oregon schools are not bussed if they live with in a one-mile radius of the school. With out safe streets and education programs parents will choose to drive these students to school, they will walk anyway in unsafe conditions, or they

will miss school making them very vulnerable to not graduating on time. Please expand the radius for eligible projects around schools to 1 mile.

Between 2008 and 2015, SRTS in Oregon was funded at the level of \$12M for infrastructure and \$4.7M for programs. Now only \$500,000 is dedicated to SRTS programs and zero is dedicated to infrastructure. These past and current investments only reach about 20% of schools with a partial SRTS program. That is 80% of schools, 80% of kids that we are leaving behind. The Transportation Bill can help close that gap by including these SRTS priorities:

- **Remove the ten-year sunset on the program**
- **Expand street safety funding to \$15M per year**
- **Fund in-classroom education with \$6M per year**
- **Include Title 1 prioritization for street safety projects**
- **Create flexibility in local funding match requirements for Title 1 schools**
- **Expand the radius for eligible projects around schools to 1 mile**

The For Every Kid Coalition and I urge you to support these policy changes and make comprehensive and effective Safe Routes to School a priority.
