Subject: SB 143-B – Relating to Provision of Campus Veteran Resources

Work Session Recommendations

Senate Bill 143-B requires the Department of Veterans' Affairs (ODVA) to develop and implement one or more competitive grant programs to expand and enhance existing veteran programs on college campuses that help veterans successfully transition from military service to college life. Grants of up to \$100,000 will be awarded to community colleges and public universities based on criteria specified in the bill. Both ODVA and the Advisory Committee are directed to report to an interim committee of the Legislature on the implementation and merits of the grant program, no later than August 31, 2018 and September 15, 2018, respectively.

The original staff measure summary and fiscal impact statement are available on the Oregon Legislative Information System (OLIS). The measure previously had hearings in the Senate Committee on Veterans and Emergency Preparedness on 2/7/2017, 2/21/2017, and 4/4/2017 and in the House Committee on Veterans and Emergency Preparedness on 4/27/2017, 5/18/2017, and 6/1/2017.

ODVA has determined that a Program Analyst 2 position (0.92 FTE) will be required to serve as the Student Veterans' Coordinator and administer the \$1 million grant program.

The -B5 amendment to the bill removes the provision that allows the Department to allocate up to 10% of total funds appropriated for the grant program for administering the program and the language appropriating \$1,100,000 from the Veterans' Services Fund. Language establishing Lottery Funds expenditure limitation of \$1,187,194 is added for grants to campuses and costs to administer the program. The amendment also adds an emergency clause.

Recommended Changes

LFO recommends adoption of the -B5 amendment.
