Establishes limitations and deadlines for legislative measures for 2018 regular session of Seventy-ninth Legislative Assembly.

CONCURRENT RESOLUTION

2 Be It Resolved by the Legislative Assembly of the State of Oregon:

3 (1) This resolution constitutes a rule of proceeding of the Senate and the
4 House of Representatives of the Seventy-ninth Legislative Assembly.

5 (2) The Senate and the House of Representatives agree to the following 6 limitations for the 2018 regular session:

(a) Each Senator and each Representative may request the Office of the
Legislative Counsel to prepare, and may submit for introduction, no more
than two drafts of measures.

10 (b) Each interim committee of the Senate and each interim committee of 11 the House of Representatives may request the Office of the Legislative 12 Counsel to prepare, and may submit for introduction, no more than three 13 drafts of measures.

(c) The Governor may request the Office of the Legislative Counsel to
prepare, and may submit for introduction, no more than five drafts of measures on behalf of the executive branch of state government.

(d) The Chief Justice of the Supreme Court may request the Office of the
Legislative Counsel to prepare, and may submit for introduction, no more
than five drafts of measures on behalf of the judicial branch of state government.

(3) The limitations on introduction of measures in subsection (2) of this

1 resolution do not apply to:

2 (a) The Joint Committee on Ways and Means, with respect to appropri3 ation or fiscal measures;

4 (b) Measures requested and approved for introduction by the President 5 of the Senate; or

6 (c) Measures requested and approved for introduction by the House 7 Committee on Rules.

8 (4) All requests to prepare drafts of measures must be accompanied by a 9 brief summary of the problem sought to be addressed, the proposed solution 10 to the problem and any other relevant information about the proposed 11 measure.

(5) The Senate and the House of Representatives shall adhere to the following schedule and deadlines for the 2018 regular session of the Seventyninth Legislative Assembly:

(a) Members, committees, the Governor and the Chief Justice shall submit
requests for drafts of measures to the Office of the Legislative Counsel on
or before 5 p.m. on November 21, 2017.

(b) The Office of the Legislative Counsel shall deliver drafts of measures
to requesters on or before 5 p.m. on January 8, 2018.

(c) Requesters shall submit drafts of measures for introduction to the
Senate Desk or the House Desk no later than 5 p.m. on January 16, 2018.

(6) The President of the Senate, the House Committee on Rules and the
Joint Committee on Ways and Means are not subject to the deadlines described in subsection (5) of this resolution.

(7) The rules of the Senate and the House of Representatives apply tomatters not specified in this resolution.
