

TO WHOM IT MAY CONCERN,

I am extremely concerned about the SB 60 which amends 677.234 for the following reasons

1. there will be even less checks and balances over the Oregon Medical Board
2. comprising of balanced Board member. this leads to the concept of market competition and was an important issue in the North Carolina Dental Board who lost due to this issue when investigated by the FTC.
3. We absolutely need to change the totalitarian approach by State Medical Boards especially Oregon Medical Board. Concerns have already been raised in Oct 2012 by Senator Bates and Senator Elizabeth Steiner Hayward.

I have personally been a victim of the physician abuse that arose from an improper investigation and improper/no due process.

Please when we as a country are so sympathetic to refugees who are being tortured we also need to be sympathetic to countless medical professionals who have suffered, lives have been ruined, families have been destroyed and emotional trauma no less than any refugee or a victim of gang rape would experience. No one is looking at the medical professionals/physicians/psychologists who are being abused in such a manner.

In my case I had no patient harm, no impairment, no fraud, yet my treatment was not equal. I was severely punished with a 144 revocation order whereas other colleagues who have killed patients, sexual offenders etc were not revoked. I chose to fight for my due process rights and was an integrative doctor and in return was punished rather than my colleagues. Unfortunately the attorneys are simply not motivated nor have any incentive to go against a powerful Oregon Medical Board,

WE are in a FREE country who takes immigrants who have been suppressed yet why are you ignoring the totalitarian control and discretionary control Oregon Medical Board has.

SB60 would just support the totalitarianism of Oregon Medical Board.

Please reconsider this bill and help restore balance and there has to be a more human way to deal with complaints and disciplining medical professionals.

I am fully able to volunteer my time to help form committees to act as liaison between the first initial complaint against a medical professional and Oregon Medical Board,
