## SUMMARY

Provides that person may not dispose of material or media that display Social Security number unless person, before disposing of material or media, makes Social Security number unreadable or prevents reconstruction of Social Security number.

## A BILL FOR AN ACT

2 Relating to disposing of material that displays Social Security numbers;  
3 amending ORS 646A.620.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 646A.620 is amended to read:

6 646A.620. (1) Except as otherwise specifically provided by law, a person  
7 [*shall*] **may** not:

8 [*(a) Print a consumer's Social Security number on any materials not re-*  
9 *quested by the consumer or part of the documentation of a transaction or ser-*  
10 *vice requested by the consumer that are mailed to the consumer unless*  
11 *redacted;*]

12 **(a) Print a consumer's Social Security number on mail to the con-**  
13 **sumer that is:**

14 **(A) Material the consumer did not request; or**

15 **(B) Part of any documentation the consumer requested for a**  
16 **transaction or service, unless the Social Security number is redacted.**

17 (b) Print a consumer's Social Security number on any card required for  
18 the consumer to access products or services provided by the person; *or*].

19 (c) Publicly post or publicly display a consumer's Social Security number  
20 unless **the Social Security number is** redacted. As used in this paragraph,

1 “publicly post or publicly display” means to communicate or otherwise make  
2 available to the public.

3 **(d) Dispose of material or media that display a consumer’s Social**  
4 **Security number unless, before disposing of the material or media, the**  
5 **person makes the Social Security number unreadable or prevents the**  
6 **reconstruction of the Social Security number.**

7 (2) This section does not prevent the collection, use[,] or release of a So-  
8 cial Security number as required by state or federal law[, *including statute,*  
9 *Oregon Rules of Civil Procedure*] or rule adopted by the Chief Justice of the  
10 Supreme Court, the Chief Judge of the Court of Appeals or the judge of the  
11 Oregon Tax Court[, *or*] **and does not prevent** the use or printing of a Social  
12 Security number for internal verification or administrative purposes or [*for*  
13 *enforcement of*] **to enforce** a judgment or court order.

14 (3) This section does not apply to records that [*are required by*] **must be**  
15 **made available to the public under** state or federal law[, *including statute,*  
16 *Oregon Rules of Civil Procedure*] or rule adopted by the Chief Justice of the  
17 Supreme Court, the Chief Judge of the Court of Appeals or the judge of the  
18 Oregon Tax Court[, *to be made available to the public*].

19 (4) This section does not apply to a Social Security number in any of the  
20 following records or copies of records in any form or storage medium main-  
21 tained or otherwise possessed by a court, the State Court Administrator or  
22 the Secretary of State:

23 (a) A record received on or before October 1, 2007;

24 (b) A record received after October 1, 2007, if, by state or federal statute  
25 or rule, the person that submitted the record could have caused the record  
26 to be filed or maintained in a manner that protected the Social Security  
27 number from public disclosure; or

28 (c) A record, regardless of the date created or received, that is:

29 (A) An accusatory instrument charging a violation or crime;

30 (B) A record of oral proceedings in a court;

31 (C) An exhibit offered as evidence in a proceeding; or

1 (D) A judgment or court order.
