# ADVANCED PLACEMENT AND INTERNATIONAL BACCALAUREATE STATEWIDE COURSE CREDIT POLICY

The Advanced Placement and International Baccalaureate Statewide Course Credit Policy represents consensus among Oregon institutions on minimum scores and transferrable credits. The Policy is designed to provide transparency and consistency to Students as they plan their high school course taking, exam taking, and post-secondary degrees and certificates.

#### **HISTORY**

The HECC inherited the statewide workgroup for Advanced Placement and International Baccalaureate course credit from the former Oregon University System in 2014. The AP/IB Policy workgroup has been meeting since 2005, when, upon passage of SB 342, Oregon's public colleges and universities were directed to develop uniform standards for awarding college credit for Advanced Placement. Later, the Joint Boards of Education directed the Workgroup to include the International Baccalaureate program in their work. The policy includes a tabulated list of Exam Subjects, Scores, and Number of Credits or Courses to be awarded.

#### **ANNUAL PROCESS**

Each academic year our review process uses the following steps: the policy is updated over three Workgroup meetings (one in person meeting and two phone meetings). Ahead of the first Workgroup meeting, staff connects with the higher education liaisons from the College Board and International Baccalaureate organization to confirm the subjects to be reviewed in the given year. Early in October the work group has a first meeting to establish the annual review subjects, meeting dates, and to confirm receipt of materials that are shared with academic departments:

AP Curriculum Framework(s)

IB Subject Guide(s)

As available – summary briefs outlining only the changes to curriculum

In January, the Workgroup has a second meeting, to compare the department faculty recommendations and recommended equivalencies, and make tentative revisions to the policy. In February or early March, the Workgroup meets a third and last time to share any additional department feedback, and the adjustments are made for subjects under review. During the spring, a Workgroup recommended policy is presented to the Provosts Council, Council of Instructional Administrators, Joint Articulation and Transfer Committee, State Board of Education, and the Student Success and Institutional Collaboration Subcommittee of the Higher Education Coordinating Commission. The Higher Education Coordinating Commission adopts the fully vetted policy in May or June. The adopted Policy is posted on the HECC website and distributed to Workgroup members and to others as needed.



The Statewide Advanced Placement Policy was adopted per Senate Bill 342 in 2005, and updated each year since (to reflect changes to the AP curricula). The Statewide International Baccalaureate Policy was adopted in January 2010 and first updated in 2014. Each year, the Statewide AP/IB Workgroup reviews the policy in light of curricular changes. Faculty on the Oregon public university and community college campuses review the curricular changes and provide input for the statewide policy. Members of the Statewide AP/IB Workgroup are listed on the next page.

#### Advanced Placement (AP):

- The College Board develops copyrighted materials and examinations
- In Oregon: 37 AP subjects offered in 286 high schools
- Typically, a score of 3 or higher (out of 5) is considered satisfactory
- In 2015, 18,943 students took an AP Exam in Oregon (total of 30,672 exams)
- In 2015, 11,965 students in Oregon scored a 3 or higher on at least one exam (or 63%)

#### International Baccalaureate (IB):

- The IB authorizes schools to offer an IB Diploma Programme to students aged 16-19. The IB oversees the curricula and produces examinations for the IB courses
- In Oregon: 17 high schools offer IB Courses in the IB Diploma Programme
- The courses (and, hence, exams) are separated into a Standard Level and a High Level. Typically, a score of 5 or higher (out of 7) is considered satisfactory

#### 2016-2017 AP Policy Highlights:

#### AP Policy Highlights

Calculus and World History were reviewed. Our policy on Calculus remains the same with a note that a student will get credit for a maximum of three courses for completion the AB/BC course sequence with a score of 4 or higher. World History was reviewed, and the committee recommends that the credits previously awarded for a score of 3 be discontinued from the policy. Institutions would still be able to award credit in World History for a score of 3, but it would no longer be the agreed upon minimum award.

#### IB Policy Highlights

There were 3 updates to IB courses and exams to review for the 2016-2017 academic year. One new course was reviewed: Design Technology. Revised courses reviewed were: History and History with Regional Foci, and Environmental Systems and Societies. The subjects reviewed/changed for 2016-2017 are highlighted with yellow in the electronic document.

The following pages present the recommended Statewide AP/IB Policy for the 2016-2017 academic year, and represent consensus among Oregon institutions on minimum scores and transferrable credits.
