## Senate Bill 1511 (2016)

Allows the Oregon Liquor Control Commission to register licensees of the commission for medical purposes

#### Senate Bill 1511 (2016)

- Registered producers of marijuana may enter into contractual agreements with Oregon Medical Marijuana Program patient cardholders, under which patient cardholder may receive marijuana directly from the producer and the producer may increase the producer's canopy size
- Registered processors of marijuana may process marijuana into medical products
- Registered wholesalers and registered retailers of marijuana may sell marijuana that is a medical product

## Senate Bill 306 (2017)

Requires regulatory consolidation of businesses related to the production, processing and sale of marijuana

#### Senate Bill 306 (2017)

- 91<sup>st</sup> Day After Adjournment Sine Day
  - Oregon Health Authority may no longer register grow sites, processing sites or dispensaries
- June 30, 2018
  - All grow sites, processing sites or dispensaries must be licensed by the Oregon Liquor Control Commission

## House Bill 2200 (2017)

Requires regulatory consolidation of businesses related to the production, processing and sale of marijuana

Changes name and composition of Oregon Liquor Control Commission

Requires Oregon Liquor Control Commission and State Department of Agriculture to coordinate efforts in regulating the production of marijuana

#### House Bill 2200 (2017)

- 91st Day After Adjournment Sine Day
  - Oregon Health Authority may no longer register grow sites, processing sites or dispensaries
  - Oregon Liquor Control Commission renamed Oregon Liquor and Cannabis Commission
  - Changes composition of Oregon Liquor and Cannabis Commission
  - Requires Oregon Liquor and Cannabis Commission and State Department of Agriculture to coordinate efforts in regulating the production of marijuana
- June 30, 2018
  - All grow sites, processing sites or dispensaries must be licensed by the Oregon Liquor Control Commission

## House Bill 2198 (2017)

Requires regulatory consolidation of businesses related to the production, processing and sale of marijuana

Changes name and composition of Oregon Liquor Control Commission

Creates Medical Use of Cannabis Board

Creates program in State Department of Agriculture for regulation of medical marijuana grow sites

Requires Oregon Liquor Control Commission and State Department of Agriculture to coordinate efforts in regulating the production of marijuana

#### House Bill 2198 (2017)

- 91st Day After Adjournment Sine Day
  - Oregon Health Authority may no longer register grow sites, processing sites or dispensaries
  - Oregon Liquor Control Commission renamed Oregon Liquor and Cannabis Commission
  - Changes composition of Oregon Liquor and Cannabis Commission
  - Creates program in State Department of Agriculture for regulation of medical marijuana grow sites (but see section 312m)
  - Requires Oregon Liquor and Cannabis Commission and State Department of Agriculture to coordinate efforts in regulating the production of marijuana

#### House Bill 2198 (2017)

- June 30, 2018
  - All grow sites, processing sites or dispensaries must be licensed by the Oregon Liquor Control Commission
  - Creates Medical Use of Cannabis Board within the Oregon Health Authority to oversee remaining functions of the Oregon Medical Marijuana Program

# Senate Bill 300 (2017)

Creates Oregon Cannabis Commission to oversee the Oregon Medical Marijuana Program

#### Senate Bill 300 (2017)

- January 1, 2018
  - Creates Oregon Cannabis Commission
  - Transfers all duties, functions and powers relating to the Oregon Medical Marijuana Program from the Oregon Health Authority to the Oregon Cannabis Commission
  - Includes mission statement for Oregon Cannabis Commission that includes duties beyond those necessary to regulate Oregon Medical Marijuana Program
