


### Almost 40% of Children are NonWhite and/or Hispanic

White; Non-Hispanic =


Hispanic; Any Race = 🔵

### Type of Care Varies by Age of Child









### OREGON CURRENTIY HAS **17 VISIBLE SLOTS** PER 100 CHILDREN





### Child Care Prices Likely to Exceed College Tuition









### **Child Care Center Finances**

- 80% of child care costs are linked to personnel
- Center teacher median wages range from \$20.320 to \$30, 160
- Almost half of teachers have a BA or higher
  - 48% of head teachers
  - 40% of teachers
- Typically operate with less than 3% profit



### Family Child Care Finances

- Charge lower prices and serve smaller numbers of children
- National study documents that they work long hours:
  - Average 57 hours directly working with children
  - Average 14 hours in additional hours related to providing care
- A quarter or less have a BA or higher
  - 28% of large home-based providers
  - 12% of small home-based providers



### Parents Pay almost Three Fourths of Child Care Expenditures




\$919,509,590 (72%) paid by families



\$119,771,366 (9%) paid by the state




\$248,551,703 (19%) paid by the federal government





### Public Programs Can't Reach All Eligible Children

Child care subsidy Program served 18% of eligible children in 2013. Cap now at 8,100 families or approximately 15,000 children.



- = 140,651 children
  allowed to be served by the state of oregon under rules established by the federal government
- = 79,189 children
  eligible for a child care subsidy in
  2013 under rules established by the
  state of oregon
- = 14,291 children
  actually served by the state of oregon
  in 2013 (18% of state allowance, 10%
  of federal allowance)

Oregon Head Start Prekindergarten and Preschool Promise serve:

- 62% of 3 & 4 year olds up to 100% of Federal Poverty Level
- 37% of 3 & 4 year olds up to 200% of Federal Poverty Level Oregon Early Head Start serves 8% of age & income eligible

### Size of the 2014 Early Learning Workforce




### Workforce is More Diverse than Oregon Adult But Less than Oregon Children

### **Education by Type of Care**





### Retention/Turnover

- Low levels of retention represent instability for children
- 76% one-year rate of retention (2013-2014)
  - Compares to a national K-12 retention rate of 92%
- 65% two-year rate of retention (2012-2014)
- Participation in professional development is associated with remaining in the workforce
- Lower retention rates are associated with lower wages



### **Effect of Teacher Education on Child Outcomes**

- Both education and training are associated with more positive teacher behavior and child outcomes.
- Early research shows association between BA and child outcomes.
- Later research indicates that we do not know the level of education required to achieve positive outcomes.
- Education matters but research is not settled on how much is needed.



### **Education and Training Often Follow Employment**

- Employment often precedes education and training in early childhood:
  - Degrees in unrelated fields.
  - No degrees or formal training
- After entry workforce members use training and college course work to increase knowledge and skills:
  - 20% of workforce has no degree beyond high school/GED but has some college, a certificate, or a foreign degree
  - 13% have an Associate degree
  - Annual training ranges from 14 to 28 hours annually



### **Early Learning Workforce Needs**

- Children benefit from teachers who understand their culture and speak their language
  - Increase access for targeted populations
- Barriers prevent workforce from participating in professional development
  - Reduce barriers and provide navigators
- Pathways to certificates and degrees are often blocked
  - Higher education, the Child Care Resource and Referral Agencies and others develop a system of portable, stackable professional development units
- Low wages are associated with low retention and thus increased instability for children
  - Improve compensation
