Summary of Revenue Changes

Aviation and jet fuel tax revenues are the primary source of funding for the agency's operations. These fuel taxes make up approximately half of the agency's Other Funds revenues. Additional sources of Other Funds revenue include aircraft registration fees, hangar and site leases and other charges for services. In 2015, legislation was passed to increase the taxes and fees that support the state's aviation system. Specifically, House Bill 2075 (2015) raised aviation and jet fuel taxes by two cents per gallon, and Senate Bill 269 (2015) increased pilot registration fees, aircraft registration fees and airport licensing fees. The department receives Federal Funds from the Federal Aviation Administration (FAA) for aviation system planning and construction projects. Federal Funds account for about 40 percent of total agency revenues.

<u>Summary of Transportation and Economic Development Subcommittee Action</u>

The Department of Aviation manages and maintains 28 state-owned airports, conducts mandatory compliance inspections of the state's 97 public use airports and plans for the safe operation, growth and improvement of aviation in Oregon. In addition, the agency registers all pilots and nonmilitary aircraft based in Oregon. The Subcommittee approved a budget of \$16,747,277 total funds and 14.25 full-time equivalent positions.

Operations

The Operations Division oversees the administration, operations and maintenance of 28 state-owned, public use airports. The division also provides the core government services of the Department: planning, land use, evaluation of tall structures, inspections of airports, and site surveys of proposed new airports. The Subcommittee approved a budget of \$5,251,610 total funds (\$4,216,965 Other Funds and \$1,034,645 Federal Funds) and 12.25 full-time equivalent positions for the program.

The Subcommittee approved the following recommendations:

• Package 102, Oregon Aviation Plan Update II - provides one-time limitation of \$450,000 Federal Funds and \$50,000 Other Funds to complete Phase II of the Oregon Aviation Plan update. The plan serves as a critical tool for managing the state's distinct system of airports.

Search and Rescue

The Search and Rescue Division registers pilots and collects pilot registration fees, which support the Search and Rescue Program administered by the Office of Emergency Management. Since Senate Bill 27 (2017) abolishes pilot registration, the Search and Rescue Division has been eliminated from the department's budget structure. Beginning in 2017-19, the Search and Rescue Program will be funded using aircraft registration revenues.

The Subcommittee approved the following recommendations:

• Package 100, Abolish Pilot Registration - contingent on passage of Senate Bill 27 (2017), which deletes the requirement for pilots to register and abolishes the Aviation Search and Rescue Account. The rationale for the bill is that state-level registration does not provide public safety benefits above and beyond those provided by FAA certification. All pilots are required to obtain FAA certification, which requires passing both written and practical tests.

General Aviation Entitlement Program

The General Aviation Entitlement Program administers FAA funded capital improvement projects to address safety, operations and development needs at airports in Oregon. FAA grants generally cover 90 percent of project costs with the remaining 10 percent paid by the airport owner. The Subcommittee approved a budget of \$9,075,020 total funds (\$5,593,166 Other Funds and \$3,481,854 Federal Funds).

The Subcommittee approved the following recommendations:

• Package 103, General Aviation Entitlement Projects - provides limitation of \$3,111,111 total funds (\$2,800,000 Federal Funds and \$311,111 Other Funds) for projects that address safety and operational needs at five state-owned airports. The projects are part of a five-year capital improvement plan annually reviewed and approved by the Oregon Aviation Board.

Pavement Maintenance

There are 66 paved public use airports in the state. The Pavement Maintenance Program evaluates the condition of pavement at these airports and assists the airports in undertaking preventative maintenance, the most cost-effective means to preserve pavement infrastructure. Preventive maintenance includes patching, crack sealing and global fog seal treatments. The program funds projects that are not eligible for FAA funding. The Subcommittee approved a budget of \$2,266,612 Other Funds and 1.00 full-time equivalent position for the program.

The Subcommittee approved the following recommendations:

• Package 101, Pavement Maintenance Program Design - provides limitation of \$60,000 Other Funds on a one-time basis to allow Aviation to complete design services for the Pavement Maintenance Program earlier in the year, allowing more time for construction during the summer months.

Aircraft Registration

The Aircraft Registration Program registers over 3,700 aircraft per year. The program manages and administers the AERO II software system that houses aircraft and pilot registration information. Aircraft registration fees are the primary source of funding for the required 10 percent match on federal airport improvement grants from the FAA. The Subcommittee approved a budget of \$154,035 Other Funds and 1.00 full-time equivalent position for the program.

The Subcommittee approved the following recommendations:

• Package 100, Abolish Pilot Registration - transfers projected year-end pilot registration revenues (\$77,931 Other Funds), as well as staff (0.50 FTE) and expenses for the abolished Search and Rescue Division to the Aircraft Registration Program.
