#### WHAT THE MEASURE DOES:

Transfers duties, functions and powers of Oregon Department of Energy (ODOE) related to oil heated dwellings (ORS 469.673 to ORS 469.683) to Oregon Housing and Community Services Department (OHCSA). Establishes that transfer becomes operative January 1, 2018 and authorizes ODOE and OHCSA to take any action necessary before operative date. Repeals statutes directing fuel oil dealers to prepare a residential energy conservation program. Makes conforming changes in program definitions. Directs that moneys received from petroleum supplier assessment be deposited in Oil-Heated Dwellings Energy Account. Specifies Account to be used to fund provision of ODOE information, assistance and technical advice to residential customer of fuel oil dealers; cash payments to dwelling owner or contractor for energy conservation measures; and program administration and enforcement. Makes conforming changes to statute authorizing tax credit allowed to commercial lending institution making energy conservation loans. Takes effect on 91st day following adjournment sine die.

#### EFFECT OF AMENDMENT:

Transfers duties, functions and powers of Oregon Department of Energy (ODOE) related to oil heated dwellings (ORS 469.673 to ORS 469.683) to Oregon Housing and Community Services Department (OHCSA). Establishes that transfer becomes operative January 1, 2018; authorizes ODOE and OHCSA to take any action necessary before operative date.

#### BACKGROUND:

The Oregon Residential Energy Conservation Act of 1981 made basic energy conservation services available to all Oregon households. The Act required investor-owned and publicly owned utilities to provide energy audits, grants and loans to their space heating customers. The Act also directed the Oregon Department of Energy (ODOE) to offer similar incentives to households that received space heating from a fuel oil dealer through the State Home Oil Weatherization (SHOW) program. SHOW serves these Oregon households by providing assistance and technical advice for saving energy at home. Under the program, ODOE provides cash payments to homeowners who purchase and install energy conservation measures. ODOE also provides cash payments for households at or below eligibility levels that receive weatherization and energy conservation measure services from a Community Action Agency or other agencies serving low-income households. Funding for the SHOW program is provided annually by six petroleum suppliers operating in Oregon in accordance with ORS 469.681, and is limited to \$400,000 per year by ORS 469.681.

Senate Bill 100A would update statutes governing the SHOW program and transfer authority for the SHOW program from ODOE to Oregon Housing and Community Services Department.
