**Summary of Revenue Changes**

House Bill 3355 provides Other Funds expenditure limitation to the Board of Psychologist Examiners to issue full or conditional certificates of prescriptive authority. The agency has sufficient Other Funds revenue to support the limitation increase.

**Summary of Education Subcommittee Action**

This bill authorizes the Board of Psychologist Examiners to establish a nine-member Committee on Prescribing Psychologists within the Board of Psychologist Examiners to advise the Board on the psychologist prescriptive authority certificate program.

The certificate program would allow the Board to issue either full or conditional certificates authorizing licensed psychologists with certain experience and education to prescribe drugs, excluding opiate-based narcotics, which are used in mental health treatment.

The Subcommittee approved \$55,762 Other Funds expenditure limitation and one limited duration position (0.25 FTE). This amount includes personal services for an Operations and Policy Analyst 3 position for six months to work with existing staff to promulgate rules and develop the certificate program.
