

# House Bill 2020

Sponsored by Representative HOLVEY

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes Oregon Energy and Climate Board as oversight and advisory body for Oregon Department of Energy and Climate.

Establishes Interagency Climate Coordinating Committee to make recommendations to board on ways to coordinate state policies and programs related to energy and climate.

Changes name of State Department of Energy to Oregon Department of Energy and Climate. Changes name of Director of State Department of Energy to Energy and Climate Director.

Abolishes Oregon Global Warming Commission.

Modifies state energy policy.

Modifies general duties of department.

Requires board and department to develop report on existing policies and programs of agencies of executive department that are related to greenhouse gas emissions or climate change, and to include in report proposal for restructuring policies and programs in pursuance of certain goals. Requires board and department to submit report to appropriate interim committees of Legislative Assembly no later than September 15, 2018.

Becomes operative January 1, 2018.

Takes effect on 91st day following adjournment sine die.

## A BILL FOR AN ACT

Relating to State Department of Energy; creating new provisions; amending ORS 176.820, 244.050, 352.823, 401.054, 458.505, 469.010, 469.020, 469.030, 469.040, 469.060, 469.110, 469.120 and 469.605; repealing ORS 468A.215, 468A.220, 468A.225, 468A.230, 468A.235, 468A.240, 468A.245, 468A.250, 468A.255, 468A.260 and 469.426; and prescribing an effective date.

**Be It Enacted by the People of the State of Oregon:**

## ENERGY POLICY

**SECTION 1.** ORS 469.010 is amended to read:

469.010. The Legislative Assembly finds and declares that:

(1) Continued growth in demand for [*nonrenewable energy forms*] **energy, at affordable cost,** poses a serious and immediate, as well as future, **concern.** [*problem. It is essential that future generations not be left a legacy of vanished or depleted resources, resulting in massive environmental, social and financial impact.*]

(2) It is the goal of Oregon to promote the efficient use of energy resources [*and to develop permanently sustainable energy resources. The need exists for comprehensive state leadership in energy production, distribution and utilization.*] **consistent with state environmental policy.** It is, therefore, the policy of Oregon:

(a) That **the** development and use of a diverse array of **affordable, sustainable energy resources be encouraged.** [*permanently sustainable energy resources be encouraged utilizing to the highest degree possible the private sector of our free enterprise system.*]

(b) **That the development of energy resources be accomplished consistent with state**

1 **greenhouse gas reduction goals.**

2 [(b)] (c) That through state government example and **policy** [*other effective communications*], en-  
3 ergy conservation and elimination of wasteful and uneconomical uses of energy and materials be  
4 promoted. [*This conservation must include, but not be limited to, resource recovery and materials re-*  
5 *cycling.*]

6 [(c) *That the basic human needs of every citizen, present and future, shall be given priority in the*  
7 *allocation of energy resources, commensurate with perpetuation of a free and productive economy with*  
8 *special attention to the preservation and enhancement of environmental quality.*]

9 (d) That state government assist every citizen and industry in adjusting to [*a diminished avail-*  
10 *ability of energy*] **changes in the available mix of energy resources and to climate change.**

11 (e) That energy-efficient modes of transportation [*for people and goods*] shall be encouraged[,  
12 *while energy-inefficient modes of transportation shall be discouraged*].

13 (f) That cost-effectiveness, **balanced with environmental policy considerations**, be considered  
14 in [*state*] agency decision-making relating to energy sources, facilities or conservation[, *and that*  
15 *cost-effectiveness be considered in all agency decision-making relating to energy facilities*].

16 (g) That state government shall provide a source of impartial and objective information in order  
17 that this energy policy may be enhanced.

18  
19 **OREGON ENERGY AND CLIMATE BOARD**

20  
21 **SECTION 2.** Sections 3, 4, 6 and 7 of this 2017 Act are added to and made a part of ORS  
22 **469.010 to 469.155.**

23  
24 **(Establishment)**

25  
26 **SECTION 3.** (1) **In order to ensure close correspondence among Oregon Department of**  
27 **Energy and Climate policies and programs, the public interest and state climate policies,**  
28 **there is created the Oregon Energy and Climate Board.**

29 (2) **The Energy and Climate Director and an Oregon member of the Pacific Northwest**  
30 **Electric Power and Conservation Planning Council shall serve as ex officio members of the**  
31 **board.**

32 (3) **The Governor shall appoint five members to the board, subject to confirmation by the**  
33 **Senate as provided in ORS 171.562 and 171.565. Members of the board appointed under this**  
34 **subsection must be residents of this state well informed in energy and climate issues and**  
35 **shall include the following:**

36 (a) **One member who is an economist;**

37 (b) **One member from an institution of higher education in Oregon with expertise in en-**  
38 **ergy and climate issues;**

39 (c) **One member who represents residential energy users;**

40 (d) **One member who represents commercial or industrial energy users; and**

41 (e) **One member with expertise in transportation issues.**

42 (4) **A member of the board may not hold any pecuniary interest in, have any contract**  
43 **of employment with, or have any substantial voluntary transactions with any business entity**  
44 **conduction operations which if conducted in this state would be subject to the energy re-**  
45 **source supplier assessment imposed under ORS 469.421 (8).**



1 (4) The board shall receive regular reports from the Energy Facility Siting Council and  
2 the Oregon Hanford Cleanup Board.

3  
4 INTERAGENCY CLIMATE COORDINATING COMMITTEE

5  
6 **SECTION 7.** (1) The Interagency Climate Coordinating Committee is established, con-  
7 sisting of the following ex officio members:

- 8 (a) The Director of Transportation;
- 9 (b) The chairperson of the Public Utility Commission of Oregon;
- 10 (c) The Director of the Department of Environmental Quality;
- 11 (d) The Director of Agriculture;
- 12 (e) The State Forester;
- 13 (f) The Water Resources Director;
- 14 (g) The Director of the Oregon Business Development Department;
- 15 (h) The State Fish and Wildlife Director; and

16 (i) Any number of additional ex officio members, each from a state agency, as the Oregon  
17 Energy and Climate Board determines are necessary to ensure that all state agencies  
18 charged with administering policies or programs related to energy and climate are repres-  
19 ented on the committee.

20 (2) The committee shall, as requested by the Oregon Energy and Climate Board, collab-  
21 orate to identify, evaluate and make recommendations to the Oregon Energy and Climate  
22 Board on ways to coordinate state policies and programs related to energy and climate, with  
23 a focus on better coordination of policies or programs so as to increase the effectiveness of  
24 efforts to reduce greenhouse gas emissions in Oregon consistent with the greenhouse gas  
25 emissions reduction goals established by ORS 468A.205.

26 (3) The committee shall meet with the Oregon Energy and Climate Board at such times  
27 and places as are specified by the call of the chairperson of the Oregon Energy and Climate  
28 Board.

29  
30 CLIMATE CENSUS REPORT

31  
32 **SECTION 8.** (1) The Oregon Energy and Climate Board and the Oregon Department of  
33 Energy and Climate shall review and develop a report on the existing policies and programs  
34 of all agencies of the executive department, as defined in ORS 174.112, that relate to  
35 greenhouse gas emissions or climate change. For each climate policy or program, the report  
36 shall describe:

- 37 (a) The policy or program and its goals;
- 38 (b) Implementation and budget information related to the policy or program;
- 39 (c) Any metrics that have been applied to measure the progress of the agency toward  
40 achieving the goals of the policy or program, and the results of the policy or program based  
41 on those metrics or on other measures of performance; and
- 42 (d) Any other relevant data or information.

43 (2) Based on the review and cataloging of existing climate policies and programs by the  
44 board and the department under subsection (1) of this section, the board and the department  
45 shall include in the report a proposal, which may include recommendations for legislation,

1 for restructuring this state's policies and programs that relate to greenhouse gas emissions  
2 or climate change, with the goals of ensuring that:

3 (a) The State of Oregon has an identified agency that is charged with a definitive lead-  
4 ership role in climate policy and program coordination, development, analysis and  
5 prioritization;

6 (b) All state climate policies and programs are being administered in a manner that is  
7 well-coordinated and that positions this state to achieve the greenhouse gas emissions re-  
8 duction goals set forth in ORS 468A.205; and

9 (c) All agencies of the executive department have systems in place to accurately evalu-  
10 ate:

11 (A) The effectiveness of climate policies or programs administered by the agencies;

12 (B) Future objectives related to climate and how those objectives may be best achieved  
13 in a coordinated manner; and

14 (C) Additional greenhouse gas mitigation strategies that may be pursued by agencies.

15 (3) The board and the department shall submit the report required by this section to the  
16 appropriate interim committees of the Legislative Assembly no later than September 15,  
17 2018.

18 **SECTION 9.** Section 8 of this 2017 Act is repealed on December 31, 2018.

19  
20 **PROVISIONS ABOLISHING GLOBAL WARMING COMMISSION**

21  
22 **SECTION 10.** The Oregon Global Warming Commission is abolished.

23 **SECTION 11.** ORS 468A.210, 468A.215, 468A.220, 468A.225, 468A.230, 468A.235, 468A.240,  
24 468A.245, 468A.250, 468A.255 and 468A.260 are repealed.

25 **SECTION 12.** (1) The Chairperson of the Oregon Global Warming Commission shall:

26 (a) Deliver to the Oregon Department of Energy and Climate all records, property and  
27 work product within the jurisdiction of the chairperson that relate to the duties, functions  
28 and powers of the Oregon Global Warming Commission as those duties, functions and powers  
29 existed prior to the effective date of the abolishment of the commission by section 10 of this  
30 2017 Act.

31 (2) The Energy and Climate Director shall take possession of the records, property and  
32 work product.

33 (3) The Governor shall resolve any dispute between the Oregon Global Warming Com-  
34 mission and the Oregon Department of Energy and Climate relating to transfers of records,  
35 property and work product under this section, and the Governor's decision is final.

36 **SECTION 13.** ORS 352.823 is amended to read:

37 352.823. (1) The Oregon Climate Change Research Institute is established at Oregon State Uni-  
38 versity. In administering the institute, Oregon State University may seek the cooperation of other  
39 public universities listed in ORS 352.002.

40 (2) The purpose of the Oregon Climate Change Research Institute is to:

41 (a) Facilitate research by faculty at public universities listed in ORS 352.002 on climate change  
42 and its effects on natural and human systems in Oregon;

43 (b) Serve as a clearinghouse for climate change information;

44 (c) Provide climate change information to the public in integrated and accessible formats; **and**

45 *[(d) Support the Oregon Global Warming Commission in developing strategies to prepare for and*

1 *to mitigate the effects of climate change on natural and human systems; and]*

2 [(e)] (d) Provide technical assistance to local governments to assist them in developing climate  
3 change policies, practices and programs.

4 (3) The Oregon Climate Change Research Institute shall assess, at least once each biennium, the  
5 state of climate change science, including biological, physical and social science, as it relates to  
6 Oregon and the likely effects of climate change on the state. The institute shall submit the assess-  
7 ment to the Legislative Assembly in the manner provided in ORS 192.245 and to the Governor.

8 (4) State agencies may contract with the Oregon Climate Change Research Institute to fulfill  
9 agency needs regarding the collection, storage, integration, analysis, dissemination and monitoring  
10 of climate change information, research and training.

11  
12 **STATE DEPARTMENT OF ENERGY**

13  
14 **(Modification of General Duties; Name Change)**

15  
16 **SECTION 14.** ORS 469.030 is amended to read:

17 469.030. (1) There is created the [State] **Oregon** Department of Energy and Climate.

18 (2) [*The State Department of Energy shall:*] **Subject to the policy direction of the Oregon**  
19 **Energy and Climate Board, and in furtherance of the energy policies stated in ORS 469.010**  
20 **and 469.310, the Oregon Department of Energy and Climate shall:**

21 **(a) Provide technical analysis and expert advice to the Governor and the Legislative As-**  
22 **sembly on energy and climate policy;**

23 [(a)] (b) [*Be*] **Collect, compile and analyze energy data and serve as** the central repository  
24 within the state government for [*the collection of data on energy resources;*] **energy and climate**  
25 **information, to which all agencies shall send information on all energy and climate-related**  
26 **research;**

27 **(c) Monitor energy industry research and developments;**

28 [(b) *Endeavor to utilize all public and private sources to inform and educate the public about en-*  
29 *ergy problems and ways in which the public can conserve energy resources;*]

30 **(d) Track and evaluate:**

31 **(A) Progress toward achieving the greenhouse gas emissions reduction goals established**  
32 **by ORS 468A.205;**

33 **(B) The advancement of regional, national and international policies to reduce**  
34 **greenhouse gas emissions;**

35 **(C) Local and regional efforts to prepare for the effects of climate change; and**

36 **(D) Other information, policies or analyses that the department determines will aid in the**  
37 **achievement of the greenhouse gas emissions reduction goals established by ORS 468A.205;**

38 [(c)] (e) Engage in research, but whenever possible, contract with appropriate public or private  
39 agencies and dispense funds for research projects and other services related to energy resources  
40 **and climate**, except that the State Department of Energy shall endeavor to avoid duplication of  
41 research whether completed or in progress;

42 [(d)] (f) Qualify for, accept and disburse or utilize any private or federal moneys or services  
43 available for the administration of ORS [176.820,] 192.501 to 192.505, [192.690,] 469.010 to 469.155,  
44 469.300 to 469.563, 469.990, 757.710 and 757.720;

45 [(e)] (g) Administer federal and state energy allocation and conservation programs and energy

1 research and development programs and apply for and receive available funds *[therefor]* **for the**  
 2 **programs;**

3 *[(f) Be a clearinghouse for energy research to which all agencies shall send information on all*  
 4 *energy related research;]*

5 *[(g) (h) Prepare contingent energy programs to include all forms of energy not otherwise pro-*  
 6 *vided pursuant to ORS 757.710 and 757.720;*

7 *[(h) Maintain an inventory of energy research projects in Oregon and the results thereof;]*

8 *[(i) Collect, compile and analyze energy statistics, data and information;]*

9 *[(j) (i) Contract with public and private agencies for energy activities consistent with ORS*  
 10 *469.010 and this section;*

11 *[(k) (j) Upon request of the governing body of any affected jurisdiction, coordinate a public re-*  
 12 *view of a proposed transmission line according to the provisions of ORS 469.442; and*

13 *[(L) Advise the Governor on energy-related matters.]*

14 **(k) Provide staff support to the Oregon Energy and Climate Board, the Oregon Hanford**  
 15 **Cleanup Board and the Energy Facility Siting Council.**

16 **SECTION 15. (1) The amendments to ORS 469.030 by section 14 of this 2017 Act are in-**  
 17 **tended to change the name of the “State Department of Energy” to the “Oregon Department**  
 18 **of Energy and Climate.”**

19 **(2) For the purpose of harmonizing and clarifying statute sections published in Oregon**  
 20 **Revised Statutes, the Legislative Counsel may substitute for words designating the “State**  
 21 **Department of Energy,” wherever they occur in Oregon Revised Statutes, other words des-**  
 22 **ignating the “Oregon Department of Energy and Climate.”**

26 **SECTION 16. ORS 469.040 is amended to read:**

27 469.040. (1) The *[State]* **Oregon** Department of Energy and Climate shall be under the super-  
 28 vision of the **Energy and Climate** Director *[of the State Department of Energy]*, who shall, **subject**  
 29 **to the policy direction of the Oregon Energy and Climate Board:**

30 (a) Supervise the day-to-day functions of the *[State]* **Oregon** Department of Energy and  
 31 **Climate;**

32 (b) Supervise and facilitate the work and research on energy facility siting applications at the  
 33 direction of the Energy Facility Siting Council;

34 (c) Hire, assign, reassign and coordinate personnel of the *[State]* department *[of Energy]*, pre-  
 35 scribe their duties and fix their compensation, subject to the State Personnel Relations Law; and

36 (d) Adopt rules and issue orders to carry out the duties of the director and the *[State]* depart-  
 37 ment *[of Energy]* in accordance with ORS chapter 183 and the policy stated in ORS 469.010.

38 (2) The director may delegate to any officer or employee the exercise and discharge in the  
 39 director’s name of any power, duty or function of whatever character vested in the director by law.

6 **SECTION 18.** ORS 469.110 is amended to read:

7 469.110. (1) At the direction of the **Energy and Climate** Director [*of the State Department of*  
 8 *Energy*] **and of the Oregon Energy and Climate Board**, the [*State*] **Oregon** Department of Energy  
 9 **and Climate** may represent the state’s energy-related interests in any matter involving the federal  
 10 government, its departments or agencies, which is within the scope of the power and duties of the  
 11 [*State*] **Oregon** Department of Energy **and Climate**, and may, upon request, represent the interest  
 12 of a county, city, state agency, federally recognized Native American or American Indian tribe,  
 13 special district or owner or operator of an energy facility.

14 (2) At the direction of the director **and the board**, the department may intervene in any pro-  
 15 ceeding undertaken by an agency for the purpose of expressing its views as to the effect of an  
 16 agency action, upon state energy resources and state energy policy.

(2) The members of the Oregon Energy and Climate Board may be appointed, and the Oregon Energy and Climate Board, the Energy and Climate Director and the Oregon Department of Energy and Climate may take any action, before the operative date provided for in subsection (1) of this section that is necessary to enable the board, the director and the department to exercise, on and after the operative date specified in subsection (1) of this section, the duties, functions and powers of the administrator, the board and the department pursuant to sections 2 to 10, 12, 15 and 17 of this 2017 Act, the amendments to statutes by sections 1, 13, 14, 16, 18 and 20 to 27 of this 2017 Act and the repeal of statutes by sections 11 and 19 of this 2017 Act.
