

## SENATE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2099

By COMMITTEE ON ENVIRONMENT AND NATURAL RESOURCES

1 On page 1 of the printed A-engrossed bill, line 2, after the first semicolon delete the rest of the  
2 line and line 3 and insert “amending ORS 537.230, 537.250, 537.409 and 537.630; and declaring an  
3 emergency.”.

4 Delete lines 4 through 15.

5 Delete lines 17 through 21 and delete pages 2 through 6 and insert:

6 “**SECTION 1.** ORS 537.230 is amended to read:

7 “537.230. (1) **As used in this section, ‘undeveloped portion’ means the difference between**  
8 **the maximum rate or duty specified in a water right permit and the maximum rate or duty**  
9 **diverted as of the later of:**

10 “(a) **June 29, 2005;**

11 “(b) **The time specified in the permit to perfect the water right; or**

12 “(c) **The time specified in the last-approved extension of time to perfect the water right.**

13 “(2) Except for a holder of a permit for municipal use, the holder of a water right permit shall  
14 prosecute the construction of any proposed irrigation or other work with reasonable diligence and  
15 complete the construction within a reasonable time, as fixed in the permit by the Water Resources  
16 Department, not to exceed five years from the date of approval.

17 “[2] (3) The holder of a permit for municipal use shall commence and complete the construction  
18 of any proposed works within 20 years from the date on which a permit for municipal use is issued  
19 under ORS 537.211. The construction must proceed with reasonable diligence and be completed  
20 within the time specified in the permit, not to exceed 20 years. However, the department may order  
21 and allow an extension of time to complete construction or to perfect a water right beyond the time  
22 specified in the permit under the following conditions:

23 “(a) The holder shows good cause. In determining the extension, the department shall give due  
24 weight to the considerations described under ORS 539.010 (5) and to whether other governmental  
25 requirements relating to the project have significantly delayed completion of construction or per-  
26 fection of the right;

27 “(b) **The extension of time is conditioned to require that the holder submit, and obtain**  
28 **department approval of, a water management and conservation plan;**

29 “[b] (c) The extension of time is conditioned to provide that the holder may divert [*water be-*  
30 *yond the maximum rate diverted for beneficial use before the extension*] **the undeveloped portion of**  
31 **the permit** only upon approval by the department of [a] **the** water management and conservation  
32 plan; and

33 “[c] (d) For the first extension issued after June 29, 2005, for a permit for municipal use issued  
34 before November 2, 1998, the department finds that the undeveloped portion of the permit is condi-  
35 tioned to maintain, in the portions of waterways affected by water use under the permit, the per-

1 sistence of fish species listed as sensitive, threatened or endangered under state or federal law. The  
2 department shall base its finding on existing data and upon the advice of the State Department of  
3 Fish and Wildlife. An existing fish protection agreement between the permit holder and a state or  
4 federal agency that includes conditions to maintain the persistence of any listed fish species in the  
5 affected portion of the waterway is conclusive for purposes of the finding.

6 “[3] (4) Except as provided in ORS 537.240 and 537.248 and subsection [(2)] (3) of this section,  
7 the Water Resources Department, for good cause shown, shall order and allow an extension of time,  
8 including an extension beyond the five-year limit established in subsection [(1)] (2) of this section  
9 within which irrigation or other works shall be completed or the right perfected. In determining the  
10 extension, the department shall give due weight to the considerations described under ORS 539.010  
11 (5) and to whether other governmental requirements relating to the project have significantly de-  
12 layed completion of construction or perfection of the right.

13 “[4] (5) Except as provided in subsection [(5)] (6) of this section and ORS 537.409, upon com-  
14 pletion of beneficial use as required under this section, the [permittee] **holder of a permit** shall hire  
15 a water right examiner certified under ORS 537.798 to survey the appropriation. Within one year  
16 after application of water to a beneficial use or the beneficial use date allowed in the permit, the  
17 [permittee] **holder** shall submit a map of the survey as required by the Water Resources Department,  
18 [which] **that** shall accompany the request for a water right certificate submitted to the department  
19 under ORS 537.250. If any property described in the permit is not included in the request for a water  
20 right certificate, the [permittee] **holder** shall state the identity of the record owner of that property.

21 “[5] (6) The Water Resources Director may waive the requirement under subsection [(4)] (5)  
22 of this section that a [permittee] **holder of a permit** hire a water right examiner certified under ORS  
23 537.798 if:

24 “(a) The permit is a supplemental water right that shares the same distribution system and same  
25 place of use as the primary water right; and

26 “(b) The department determines that there is sufficient information in the records of the de-  
27 partment to determine proof of beneficial use.

28 “[6] (7) Notwithstanding ORS 537.410, for purposes of obtaining a water right certificate under  
29 ORS 537.250 for a supplemental water right, the [permittee] **holder of a permit** shall have a facility  
30 capable of handling the full rate and duty of water requested from the supplemental source and be  
31 otherwise ready, willing and able to use the amount of water requested, up to the amount of water  
32 approved in the water right permit. To obtain a certificate for a supplemental water right, the  
33 [permittee] **holder** is not required to have actually used water from the supplemental source if:

34 “(a) Water was available from the source of the primary water right and the primary water right  
35 was used pursuant to the terms of the primary water right; or

36 “(b) The nonuse of water from the supplemental source occurred during a period of time within  
37 which the exercise of the supplemental water right permit was not necessary due to climatic con-  
38 ditions.

39 “**SECTION 2.** ORS 537.250 is amended to read:

40 “537.250. (1) After the Water Resources Department has received a request for issuance of a  
41 water right certificate accompanied by the survey required under ORS 537.230 [(4)] that shows, to  
42 the satisfaction of the department, that an appropriation has been perfected in accordance with the  
43 provisions of the Water Rights Act, **except as provided in subsection (4) of this section**, the de-  
44 partment shall issue to the applicant a certificate of the same character as that described in ORS  
45 539.140. The certificate shall be recorded and transmitted to the applicant as provided in that sec-

1 tion.

2 “(2) When issuing a water right certificate under [subsection (1) of] this section in the name of  
3 a district as defined in ORS 540.505, or in the name of a government agency for a district, the de-  
4 partment may issue the water right certificate for land not described in the permit in accordance  
5 with ORS 537.252.

6 “(3) Rights to the use of water acquired under the provisions of the Water Rights Act, as set  
7 forth in a certificate issued under [subsection (1) of] this section, shall continue in the owner thereof  
8 so long as the water shall be applied to a beneficial use under and in accordance with the terms  
9 of the certificate, subject only to loss:

10 “(a) By nonuse as specified and provided in ORS 540.610; or

11 “(b) As provided in ORS 537.297.

12 “(4) **The department may not issue a water right certificate for municipal use under this**  
13 **section if:**

14 “(a) **An extension of time is required; and**

15 “(b) **The order approving the extension of time has not become final by operation of law**  
16 **or on appeal.**

17 “**SECTION 3.** ORS 537.409 is amended to read:

18 “537.409. (1) In lieu of the process set forth in ORS 537.140 to 537.211 for applying for a water  
19 right permit, an owner of a reservoir may submit an application to the Water Resources Department  
20 to issue a water right permit under ORS 537.211 or a certificate under ORS 537.250 according to the  
21 process set forth in this section if the reservoir:

22 “(a) Has a storage capacity of less than 9.2 acre-feet or a dam or impoundment structure less  
23 than 10 feet in height;

24 “(b) Does not injure any existing water right;

25 “(c) Does not pose a significant detrimental impact to existing fishery resources as determined  
26 on the basis of information submitted by the State Department of Fish and Wildlife; and

27 “(d) Is not prohibited under ORS 390.835.

28 “(2) An application for a water right permit for a reservoir under subsection (1) of this section  
29 shall provide sufficient information to demonstrate compliance with the criteria set forth in sub-  
30 section (1) of this section. The application shall:

31 “(a) Include the quantity of water to be stored by the reservoir, a map indicating the location  
32 of the reservoir and the source of the water used to fill the reservoir; and

33 “(b) Be accompanied by the fee established in ORS 536.050 (1)(q).

34 “(3) The map required under subsection (2) of this section need not be prepared by a water right  
35 examiner certified under ORS 537.798. The map submitted with the application shall comply with  
36 standards established by the Water Resources Commission.

37 “(4) Within 60 days after receiving an application under subsection (1) of this section, the Water  
38 Resources Department shall provide public notice of the application in the manner the department  
39 determines to be the most appropriate.

40 “(5) Within 60 days after the department provides public notice under subsection (4) of this  
41 section, any person may submit detailed, legally obtained information in writing, requesting the de-  
42 partment to deny the application for a permit on the basis that the reservoir:

43 “(a) Would result in injury to an existing water right; or

44 “(b) Would pose a significant detrimental impact to existing fishery resources.

45 “(6) In accordance with rules established by the Water Resources Commission for an expedited

1 public interest review process for applications submitted under this section or in response to a re-  
2 quest under subsection (5) of this section, the department shall conduct a public interest review of  
3 the reservoir application. The review shall be limited to issues pertaining to:

4 “(a) Water availability;

5 “(b) Potential detrimental impact to existing fishery resources; and

6 “(c) Potential injury to existing water rights.

7 “(7) Within 180 days after the department receives an application for a permit under subsection  
8 (1) of this section, the department shall issue a final order granting or denying the permit or  
9 granting the permit with conditions.

10 “(8) If the department issues an order under subsection (7) of this section denying the permit,  
11 the applicant may request a contested case hearing, which shall be conducted in accordance with  
12 applicable provisions of ORS chapter 183.

13 “(9) If the department does not find injury or impact under subsection (6) of this section and the  
14 department issues a final order under subsection (7) of this section allowing the issuance of a permit,  
15 the order shall be subject to judicial review of orders in other than contested cases as provided in  
16 ORS chapter 183.

17 “(10) Notwithstanding the requirement for a survey under ORS 537.230 [(4)], a survey of the  
18 appropriation is not required for a reservoir that has a storage capacity of less than 9.2 acre-feet  
19 of water. For a reservoir qualifying under this subsection, a permittee shall submit to the depart-  
20 ment a claim of beneficial use within one year after the date of completion of construction. A claim  
21 of beneficial use for a reservoir qualifying under this subsection shall require only a written affi-  
22 davit signed by the permittee that includes the following:

23 “(a) The dimensions of the reservoir.

24 “(b) The maximum capacity of the reservoir in acre-feet.

25 “(c) A map identifying the location of the reservoir. The map shall comply with standards es-  
26 tablished by the Water Resources Commission. The map required under this subsection need not be  
27 prepared by a water right examiner certified under ORS 537.798.

28 “(11) Any person applying for a secondary permit for the use of stored water from a reservoir  
29 qualifying under subsection (10) of this section shall submit a survey prepared by a water right ex-  
30 aminer certified under ORS 537.798. The survey required under this subsection shall apply to the  
31 storage reservoir and to the secondary use of the water in the reservoir.

32 “**SECTION 4.** ORS 537.630 is amended to read:

33 “537.630. (1) **As used in this section, ‘undeveloped portion’ means the difference between**  
34 **the maximum rate or duty specified in a water right permit and the maximum rate or duty**  
35 **appropriated as of the later of:**

36 “(a) **June 29, 2005;**

37 “(b) **The time specified in the permit to perfect the water right; or**

38 “(c) **The time specified in the last-approved extension of time to perfect the water right.**

39 “(2) Except for the holder of a permit for municipal use, the holder of a permit issued pursuant  
40 to ORS 537.625 shall prosecute the construction of a well or other means of developing and securing  
41 the ground water with reasonable diligence and complete the construction within a reasonable time  
42 fixed in the permit by the Water Resources Department, not to exceed five years after the date of  
43 approval of the application. However, the department, for good cause shown, shall order and allow  
44 an extension of time, including an extension beyond the five-year period, for the completion of the  
45 well or other means of developing and securing the ground water or for complete application of

1 water to beneficial use. In determining the extension, the department shall give due weight to the  
2 considerations described under ORS 539.010 (5) and to whether other governmental requirements  
3 relating to the project have significantly delayed completion of construction or perfection of the  
4 right.

5 “[2] (3) The holder of a permit for municipal use shall commence and complete the construction  
6 of any proposed works within 20 years from the date on which the permit for municipal use is issued  
7 under ORS 537.625. The construction must proceed with reasonable diligence and be completed  
8 within the time specified in the permit, not to exceed 20 years. However, the department may order  
9 and allow an extension of time to complete construction or to perfect a water right beyond the time  
10 specified in the permit under the following conditions:

11 “(a) The holder shows good cause. In determining the extension, the department shall give due  
12 weight to the considerations described under ORS 539.010 (5) and to whether other governmental  
13 requirements relating to the project have significantly delayed completion of construction or per-  
14 fection of the right;

15 “(b) **The extension of time is conditioned to require that the holder submit and obtain**  
16 **department approval of a water management and conservation plan;**

17 “[b] (c) The extension of time is conditioned to provide that the holder may [*divert water be-*  
18 *yond the maximum rate diverted for beneficial use before the extension*] **appropriate the undeveloped**  
19 **portion of the permit** only upon approval by the department of a water management and conser-  
20 vation plan; and

21 “[c] (d) For the first extension issued after June 29, 2005, for a permit for municipal use issued  
22 before November 2, 1998, the department finds that the undeveloped portion of the permit is condi-  
23 tioned to maintain, in the portions of waterways affected by water use under the permit, the per-  
24 sistence of fish species listed as sensitive, threatened or endangered under state or federal law. The  
25 department shall base its finding on existing data and upon the advice of the State Department of  
26 Fish and Wildlife. An existing fish protection agreement between the permit holder and a state or  
27 federal agency that includes conditions to maintain the persistence of any listed fish species in the  
28 affected portion of the waterway is conclusive for purposes of the finding.

29 “[3] (4) If the construction of any well or other means of developing and securing the ground  
30 water is completed after the date of approval of the application for a permit under ORS 537.625,  
31 within 30 days after the completion, or if the construction is completed before the date of approval,  
32 within 30 days after the date of approval, the permit holder shall file a certificate of completion with  
33 the Water Resources Department, disclosing:

34 “(a) The depth to the water table;

35 “(b) The depth, diameter and type of each well, and the kind and amount of the casing;

36 “(c) The capacity of the well pump in gallons per minute and the drawdown thereof;

37 “(d) The identity of the record owner of any property that was described in the application for  
38 a permit under ORS 537.625 but is not included in the certificate of completion; and

39 “(e) Any other information the department considers necessary.

40 “[4] (5) Upon completion of beneficial use necessary to secure the ground water as required  
41 under this section, the permit holder shall hire a water right examiner certified under ORS 537.798  
42 to survey the appropriation. Within one year after applying the water to beneficial use or the ben-  
43 efiticial use date allowed in the permit, the permit holder shall submit the survey as required by the  
44 Water Resources Department to the department along with the certificate of completion required  
45 under subsection [3] (4) of this section. If any property described in the permit is not included in

1 the request for a water right certificate, the [permittee] **holder of the permit** shall state the identity  
2 of the record owner of that property.

3 “[5] **(6)** After the department has received a certificate of completion and a copy of the survey  
4 as required by subsections [(3) and] (4) **and (5)** of this section that show, to the satisfaction of the  
5 department, that an appropriation has been perfected in accordance with the provisions of ORS  
6 537.505 to 537.795 and 537.992, **except as provided in subsection (7) of this section**, the depart-  
7 ment shall issue a ground water right certificate of the same character as that described in ORS  
8 537.700. The certificate shall be recorded and transmitted to the applicant as provided in ORS  
9 537.700.

10 **“(7) The department may not issue a water right certificate for municipal use under this**  
11 **section if:**

12 **“(a) An extension of time is required; and**

13 **“(b) The order approving the extension of time has not become final by operation of law**  
14 **or on appeal.**

15 “[6] **(8)** The procedure for cancellation of a permit shall be as provided in ORS 537.260.

16 “[7] **(9)** Notwithstanding ORS 537.410, for purposes of obtaining a water right certificate under  
17 subsection [(5)] **(6)** of this section for a supplemental water right, the [permittee] **holder of a permit**  
18 shall have a facility capable of handling the full rate and duty of water requested from the supple-  
19 mental source and be otherwise ready, willing and able to use the amount of water requested, up  
20 to the amount of water approved in the water right permit. To obtain a certificate for a supple-  
21 mental water right, the [permittee] **holder** is not required to have actually used water from the  
22 supplemental source if:

23 **“(a)** Water was available from the source of the primary water right and the primary water right  
24 was used pursuant to the terms of the primary water right; or

25 **“(b)** The nonuse of water from the supplemental source occurred during a period of time within  
26 which the exercise of the supplemental water right permit was not necessary due to climatic con-  
27 ditions.

28 **“SECTION 5. This 2017 Act being necessary for the immediate preservation of the public**  
29 **peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect**  
30 **on its passage.”.**
