

# House Bill 2149

Sponsored by Representative JOHNSON; Representatives BARKER, OLSON, PARRISH, WHISNANT, WITT (at the request of Alfred H. Gilbert Sr.) (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Provides for one-time, decreased vehicle registration fee for former prisoners of war.

## A BILL FOR AN ACT

1  
2 Relating to special vehicle registration for persons who qualify as former prisoners of war; creating  
3 new provisions; and amending ORS 801.041, 801.042, 803.350, 803.415, 803.420 and 805.110.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 805.110 is amended to read:

6 805.110. (1) In the absence of just cause for refusal, the Department of Transportation shall  
7 provide for registration of any motor vehicle required to be registered by this state in a manner  
8 consistent with this section for persons who qualify as former prisoners of war under this section.  
9 The special registration provisions under this section are subject to all of the following:

10 *[(a) The fee to register or renew registration under this section shall be the regular registration fee*  
11 *for the vehicle.]*

12 **(a) The fee is the one-time registration fee established under ORS 803.420 for vehicles**  
13 **registered under this section.**

14 (b) The department *[shall]* **may** not register a motor vehicle under this section if another vehicle  
15 owned by the applicant or a member of the applicant's household has been registered under this  
16 section.

17 (c) The department *[shall]* **may** not register any commercial vehicle under this section or any  
18 motor vehicle with a loaded weight in excess of 10,000 pounds.

19 (2) A person is a former prisoner of war who qualifies for registration of a vehicle under this  
20 section if the person, while serving in the active military, naval or air service of the United States  
21 or any of its Allies, was forcibly detained or interned in line of duty:

22 (a) By an enemy government or its agents, or a hostile force, during a period of war; or

23 (b) By a foreign government or its agents, or a hostile force during a period other than a period  
24 of war in which such person was held under circumstances which the department finds to have been  
25 comparable to the circumstances under which persons have generally been forcibly detained or  
26 interned by enemy governments during periods of war.

27 (3) The surviving spouse of a former prisoner of war who was issued registration under this  
28 section may, upon the death of the former prisoner of war, continue to use the registration plates  
29 on a motor vehicle or may keep the plates as a memento.

30 (4) The department may suspend or revoke any registration issued under this section if the de-  
31 partment determines that the vehicle is owned by a person not qualified for registration under this

1 section or the vehicle is a kind not qualified for registration under this section.

2 **SECTION 2.** ORS 801.041 is amended to read:

3 801.041. The following apply to the authority granted to counties by ORS 801.040 to establish  
4 registration fees for vehicles:

5 (1) An ordinance establishing registration fees under this section must be enacted by the county  
6 imposing the registration fee and filed with the Department of Transportation. Notwithstanding  
7 ORS 203.055 or any provision of a county charter, the governing body of a county with a population  
8 of 350,000 or more may enact an ordinance establishing registration fees. The governing body of a  
9 county with a population of less than 350,000 may enact an ordinance establishing registration fees  
10 after submitting the ordinance to the electors of the county for their approval. The governing body  
11 of the county imposing the registration fee shall enter into an intergovernmental agreement under  
12 ORS 190.010 with the department by which the department shall collect the registration fees, pay  
13 them over to the county and, if necessary, allow the credit or credits described in ORS 803.445 (5).  
14 The intergovernmental agreement must state the date on which the department shall begin collect-  
15 ing registration fees for the county.

16 (2) The authority granted by this section allows the establishment of registration fees in addition  
17 to those described in ORS 803.420. There is no authority under this section to affect registration  
18 periods, qualifications, cards, plates, requirements or any other provision relating to vehicle regis-  
19 tration under the vehicle code.

20 (3) Except as otherwise provided for in this subsection, when registration fees are imposed under  
21 this section, they must be imposed on all vehicle classes. Registration fees as provided under this  
22 section may not be imposed on the following:

- 23 (a) Snowmobiles and Class I all-terrain vehicles.
- 24 (b) Fixed load vehicles.
- 25 (c) Vehicles registered under ORS 805.100 to disabled veterans.
- 26 (d) Vehicles registered as antique vehicles under ORS 805.010.
- 27 (e) Vehicles registered as vehicles of special interest under ORS 805.020.
- 28 (f) Government-owned or operated vehicles registered under ORS 805.040 or 805.045.
- 29 (g) School buses or school activity vehicles registered under ORS 805.050.
- 30 (h) Law enforcement undercover vehicles registered under ORS 805.060.
- 31 (i) Vehicles registered on a proportional basis for interstate operation.
- 32 (j) Vehicles with a registration weight of 26,001 pounds or more described in ORS 803.420 (10)  
33 or (11).
- 34 (k) Vehicles registered as farm vehicles under the provisions of ORS 805.300.
- 35 (L) Travel trailers, campers and motor homes.

36 (m) Vehicles registered to an employment address as provided in ORS 802.250 when the eligible  
37 public employee or household member's residence address is not within the county of the employ-  
38 ment address. The department may adopt rules it considers necessary for the administration of this  
39 paragraph.

40 **(n) Vehicles registered under ORS 805.110 to former prisoners of war.**

41 (4) Any registration fee imposed by a county must be a fixed amount not to exceed, with respect  
42 to any vehicle class, the registration fee established under ORS 803.420 (1). For vehicles on which  
43 a flat fee is imposed under ORS 803.420, the fee must be a whole dollar amount.

44 (5) Moneys from registration fees established under this section must be paid to the county es-  
45 tablishing the registration fees as provided in ORS 802.110. The county ordinance shall provide for

1 payment of at least 40 percent of the moneys to cities within the county unless a different distrib-  
 2 ution is agreed upon by the county and the cities within the jurisdiction of the county. The moneys  
 3 for the cities and the county shall be used for any purpose for which moneys from registration fees  
 4 may be used, including the payment of debt service and costs related to bonds or other obligations  
 5 issued for such purposes.

6 (6) Two or more counties may act jointly to impose a registration fee under this section. The  
 7 ordinance of each county acting jointly with another under this subsection must provide for the  
 8 distribution of moneys collected through a joint registration fee.

9 **SECTION 3.** ORS 801.042 is amended to read:

10 801.042. The following apply to the authority granted to a district by ORS 801.040 to establish  
 11 registration fees for vehicles:

12 (1) Before the governing body of a district can impose a registration fee under this section, it  
 13 must submit the proposal to the electors of the district for their approval and, if the proposal is  
 14 approved, enter into an intergovernmental agreement under ORS 190.010 with the governing bodies  
 15 of all counties, other districts and cities with populations of over 300,000 that overlap the district.  
 16 The intergovernmental agreement must state the registration fees and, if necessary, how the revenue  
 17 from the fees shall be apportioned among counties and the districts. Before the governing body of  
 18 a county can enter into such an intergovernmental agreement, the county shall consult with the  
 19 cities in its jurisdiction.

20 (2) If a district raises revenues from a registration fee for purposes related to highways, roads,  
 21 streets and roadside rest areas, the governing body of that district shall establish a Regional Ar-  
 22 terial Fund and shall deposit in the Regional Arterial Fund all such registration fees.

23 (3) Interest received on moneys credited to the Regional Arterial Fund shall accrue to and be-  
 24 come a part of the Regional Arterial Fund.

25 (4) The Regional Arterial Fund must be administered by the governing body of the district re-  
 26 ferred to in subsection (2) of this section and such governing body by ordinance may disburse mon-  
 27 eys in the Regional Arterial Fund. Moneys within the Regional Arterial Fund may be disbursed only  
 28 for a program of projects recommended by a joint policy advisory committee on transportation  
 29 consisting of local officials and state agency representatives designated by the district referred to  
 30 in subsection (2) of this section. The projects for which the joint policy advisory committee on  
 31 transportation can recommend funding must concern arterials, collectors or other improvements  
 32 designated by the joint policy advisory committee on transportation.

33 (5) Ordinances establishing registration fees under this section must be filed with the Depart-  
 34 ment of Transportation. The governing body of the district imposing the registration fee shall enter  
 35 into an intergovernmental agreement under ORS 190.010 with the department by which the depart-  
 36 ment shall collect the registration fees, pay them over to the district and, if necessary, allow the  
 37 credit or credits described in ORS 803.445 (5). The intergovernmental agreement must state the date  
 38 on which the department shall begin collecting registration fees for the district.

39 (6) The authority granted by this section allows the establishment of registration fees in addition  
 40 to those described in ORS 803.420. There is no authority under this section to affect registration  
 41 periods, qualifications, cards, plates, requirements or any other provision relating to vehicle regis-  
 42 tration under the vehicle code.

43 (7) Except as otherwise provided for in this subsection, when registration fees are imposed under  
 44 this section, the fees must be imposed on all vehicle classes. Registration fees as provided under this  
 45 section may not be imposed on the following:

- 1 (a) Snowmobiles and Class I all-terrain vehicles.

- 12 (k) Vehicles registered as farm vehicles under the provisions of ORS 805.300.
- 13 (L) Travel trailers, campers and motor homes.

14 (m) Vehicles registered to an employment address as provided in ORS 802.250 when the eligible  
15 public employee or household member's residence address is not within the county of the employ-  
16 ment address. The department may adopt rules it considers necessary for the administration of this  
17 paragraph.

18 **(n) Vehicles registered under ORS 805.110 to former prisoners of war.**

19 (8) Any registration fee imposed by the governing body of a district must be a fixed amount not  
20 to exceed, with respect to any vehicle class, the registration fee established under ORS 803.420 (1).  
21 For vehicles on which a flat fee is imposed under ORS 803.420, the fee must be a whole dollar  
22 amount.

23 **SECTION 4.** ORS 803.350 is amended to read:

24 803.350. This section establishes the requirements for qualification for registration. The De-  
25 partment of Transportation shall not issue registration to a vehicle if the requirements under this  
26 section are not met. The department, in the absence of just cause for refusing to register a vehicle  
27 upon application, shall assign a distinctive number or other distinctive means of identification and  
28 shall issue registration for a vehicle if all of the following requirements are met:

29 (1) The applicant applies for and is granted title in the applicant's name at the same time the  
30 person makes application for registration, or presents satisfactory evidence that title covering the  
31 vehicle has been previously issued to the applicant.

32 (2) The applicant completes an application described under ORS 803.370. If the vehicle is a re-  
33 constructed or assembled vehicle or a replica, the person must indicate that fact in the application  
34 or be subject to ORS 803.225.

35 (3) The applicant pays the department the registration fee established under ORS 803.420 and  
36 any applicable fees for issuance of registration plates.

37 (4) For motor vehicles, proof of compliance with pollution control equipment requirements is  
38 provided to the department. Proof required to comply with this subsection is described under ORS  
39 815.310. This subsection does not apply if the vehicle is exempt from the requirements for proof of  
40 compliance under ORS 815.300.

41 (5) The applicant is domiciled in this state, as described in ORS 803.355, if required by ORS  
42 803.360 to be domiciled in the state in order to register a vehicle. If the department has reason to  
43 believe that the applicant is not domiciled in this state and is required to be in order to register a  
44 vehicle, the department may require the person to submit proof of domicile. The department shall  
45 determine by rule what constitutes proof of domicile.

1 (6) The applicant owns a vehicle that qualifies under ORS 803.360 (2) for registration in this  
 2 state, if the owner is not domiciled in this state and is not required by ORS 803.200, or any other  
 3 provision of law, to register the vehicle in this state.

4 (7) The applicant surrenders all evidence of any former registration or title as required by ORS  
 5 803.380.

6 (8)(a) Beginning with 2009 model year new motor vehicles, the applicant provides proof of com-  
 7 pliance with low emission motor vehicle standards adopted pursuant to ORS 468A.360. The depart-  
 8 ment shall determine by rule what constitutes proof of compliance with low emission motor vehicle  
 9 standards.

10 (b) The department shall determine by rule which new motor vehicles are exempt from the re-  
 11 quirements of this subsection. Any rules adopted pursuant to this paragraph shall be consistent with  
 12 the Environmental Quality Commission standards adopted pursuant to ORS 468A.360.

13 (c) For purposes of this subsection, “new motor vehicle” means a motor vehicle with 7,500 miles  
 14 or less on the odometer when the vehicle is initially registered under ORS 803.420 (1), 805.100,  
 15 **805.110** or 805.120.

16 (9) If required to do so by the department, the applicant provides the department with satisfac-  
 17 tory proof that the vehicle was designed to be operated on highways and meets equipment require-  
 18 ments imposed by statute or rule for the lawful operation of a vehicle on highways. The department  
 19 may adopt rules specifying the kinds of vehicles that are subject to this subsection and what con-  
 20 stitutes satisfactory proof under this subsection.

21 **SECTION 5.** ORS 803.415 is amended to read:

22 803.415. This section establishes registration periods for vehicles. The registration periods are  
 23 periods described under ORS 803.400. Except as provided in the following, the registration period for  
 24 any vehicle registered in this state by the Department of Transportation is a biennial registration  
 25 period:

26 (1) The following vehicles have permanent registration:

27 (a) Antique vehicles registered under ORS 805.010.

28 (b) Vehicles of special interest registered under ORS 805.020.

29 (c) Trailers that will be operated on the highways at a loaded weight of more than 8,000 pounds  
 30 and are not travel trailers, fixed load vehicles or special use trailers.

31 (2) Government-owned vehicles registered under ORS 805.040 have ownership registration.

32 (3) The following vehicles may be registered under annual or quarterly registration unless the  
 33 vehicles are registered under proportional registration under ORS 826.009 or proportional fleet  
 34 registration under ORS 826.011:

35 (a) Vehicles required to establish a registration weight under ORS 803.430.

36 (b) Commercial buses.

37 (c) Vehicles registered as farm vehicles under ORS 805.300.

38 (4) Snowmobiles are registered as provided in ORS 821.080.

39 (5) Vehicles operated by dealers who hold certificates under ORS 822.020 are as provided under  
 40 ORS 822.040.

41 (6) Trailers for hire that will be operated at a loaded weight of 8,000 pounds or less may be  
 42 registered as follows:

43 (a) Annual registration; or

44 (b) If registered under an agreement pursuant to ORS 802.500, for a period of time determined  
 45 as specified in the agreement or as determined by the department.

1 (7) Except as otherwise provided in subsection (10) of this section, the registration period for  
 2 electric vehicles and hybrid vehicles that use electricity and another source of motive power is a  
 3 biennial registration period except that the registration period for the following electric or hybrid  
 4 vehicles is an annual registration period:

5 (a) Commercial buses.

6 (b) Electric or hybrid vehicles registered as farm vehicles under ORS 805.300.

7 (c) Vehicles required to establish registration weight under ORS 803.430.

8 (8) Vehicles registered under ORS 805.100 have an ownership registration period.

9 (9) School vehicles registered under ORS 805.050 have ownership registration except that the  
 10 registration shall continue to be valid if ownership of the vehicle is transferred to a person who  
 11 continues to use the vehicle for purposes authorized by ORS 805.050.

12 (10) The following vehicles have a four-year registration period:

13 (a) New vehicles registered under ORS 803.420 (1) for which new registration plates will be is-  
 14 sued;

15 (b) New mopeds registered under ORS 803.420 (2) for which new registration plates will be is-  
 16 sued;

17 (c) New motorcycles registered under ORS 803.420 (3) for which new registration plates will be  
 18 issued; and

19 (d) New vehicles registered under ORS 803.420 (9)(a) for which new registration plates will be  
 20 issued.

21 (11) A rental or leasing company, as defined in ORS 221.275, may elect an annual, a biennial or  
 22 a four-year registration period for the initial registration of a new vehicle registered under ORS  
 23 803.420 (1) or (9)(a) for which new registration plates will be issued if the company owns the vehicle  
 24 that is being registered. The subsequent renewal or reregistration periods for the vehicle are  
 25 biennial.

26 **(12) Vehicles registered under ORS 805.110 have ownership registration except that the**  
 27 **registration shall continue to be valid if ownership of the vehicle is transferred to a spouse**  
 28 **who is authorized to retain the former prisoner of war registration plates under ORS 805.110.**

29 **SECTION 6.** ORS 803.420 is amended to read:

30 803.420. This section establishes registration fees for vehicles. If there is uncertainty as to the  
 31 classification of a vehicle for purposes of the payment of registration fees under the vehicle code,  
 32 the Department of Transportation may classify the vehicle to assure that registration fees for the  
 33 vehicle are the same as for vehicles the department determines to be comparable. The registration  
 34 fees for the vehicle shall be those based on the classification determined by the department. Except  
 35 as otherwise provided in this section, or unless the vehicle is registered quarterly, the fees described  
 36 in this section are for an entire registration period for the vehicle as described under ORS 803.415.  
 37 The department shall apportion any fee under this section to reflect the number of quarters regis-  
 38 tered for a vehicle registered for a quarterly registration period under ORS 803.415. The fees are  
 39 payable when a vehicle is registered and upon renewal of registration. Except as provided in ORS  
 40 801.041 (3) and 801.042 (7), the fee shall be increased by any amount established by the governing  
 41 body of a county or by the governing body of a district, as defined in ORS 801.237, under ORS  
 42 801.041 or 801.042 as an additional registration fee for the vehicle. The fees for registration of ve-  
 43 hicles are as follows:

44 (1) Vehicles not otherwise provided for in this section or ORS 821.320, \$43 for each year of the  
 45 registration period.

- 1 (2) Mopeds, \$24 for each year of the registration period.
- 2 (3) Motorcycles, \$24 for each year of the registration period.
- 3 (4) Government-owned vehicles registered under ORS 805.040, \$3.50.
- 4 (5) State-owned vehicles registered under ORS 805.045, \$3.50 on registration or renewal.
- 5 (6) Undercover vehicles registered under ORS 805.060, \$3.50 on registration or renewal.
- 6 (7) Antique vehicles registered under ORS 805.010, \$54.
- 7 (8) Vehicles of special interest registered under ORS 805.020, \$81.
- 8 (9) Electric vehicles and hybrid vehicles that use electricity and another source of motive power,
- 9 as follows:
  - 10 (a) The registration fee for an electric or hybrid vehicle not otherwise described in this sub-
  - 11 section is \$43 for each year of the registration period.
  - 12 (b) The registration fee for electric or hybrid vehicles that have two or three wheels is \$43. This
  - 13 paragraph does not apply to electric or hybrid mopeds. Electric or hybrid mopeds are subject to the
  - 14 same registration fee as otherwise provided for mopeds under this section.
  - 15 (c) The registration fees for the following electric or hybrid vehicles are the same as for com-
  - 16 parable nonelectric vehicles described in this section plus 50 percent of such fee:
    - 17 (A) Motor homes.
    - 18 (B) Commercial buses.
    - 19 (C) Vehicles registered as farm vehicles under ORS 805.300.
    - 20 (D) Vehicles required to establish registration weight under ORS 803.430 or 826.013.
  - 21 (10) Motor vehicles required to establish a registration weight under ORS 803.430 or 826.013,
  - 22 tow vehicles used to transport property for hire other than as described in ORS 822.210, and com-
  - 23 mercial buses, as provided in the following chart, based upon the weight submitted in the declara-
  - 24 tion of weight prepared under ORS 803.435 or 826.015:

(c) The owner of a vehicle described in paragraphs (a) and (b) of this subsection must certify at the time of initial registration, in a manner determined by the department by rule, that the motor vehicle will be used exclusively to transport manufactured structures or exclusively as described in ORS 822.210, unless the motor vehicle is registered under subsection (10) of this section, or as described in ORS 825.015 or 825.017 (13). Registration of a vehicle described in paragraphs (a) and (b) of this subsection is invalid if the vehicle is operated in any manner other than that described in the certification under this paragraph.

(12) Trailers registered under permanent registration, \$10.

(13) Fixed load vehicles as follows:

(a) If a declaration of weight described under ORS 803.435 is submitted establishing the weight of the vehicle at 3,000 pounds or less, \$54.

(b) If no declaration of weight is submitted or if the weight of the vehicle is in excess of 3,000 pounds, \$75.

(14) Trailers for hire that are equipped with pneumatic tires made of an elastic material and that are not travel trailers or trailers registered under permanent registration, \$27.

(15) Trailers registered as part of a fleet under an agreement reached pursuant to ORS 802.500, the same as the fee for vehicles of the same type registered under other provisions of the Oregon Vehicle Code.

(16) Travel trailers, campers and motor homes as follows, based on length as determined under ORS 803.425:

(a) For travel trailers or campers that are 6 to 10 feet in length, \$81.

(b) For travel trailers or campers over 10 feet in length, \$81 plus \$6.75 a foot for each foot of length over the first 10 feet.

(c) For motor homes that are 6 to 14 feet in length, \$54.

(d) For motor homes over 14 feet in length, \$126 plus \$7.50 a foot for each foot of length over the first 10 feet.

(17) Special use trailers as follows, based on length as determined under ORS 803.425:

(a) For lengths 6 to 10 feet, \$54.

(b) For special use trailers over 10 feet in length, \$54 plus \$3 a foot for each foot of length over the first 10 feet.

(18) Fees for vehicles with proportional registration under ORS 826.009, or proportioned fleet registration under ORS 826.011, are as provided for vehicles of the same type under this section

1 except that the fees shall be fixed on an apportioned basis as provided under the agreement estab-  
 2 lished under ORS 826.007.

3 (19) For any vehicle that is registered under a quarterly registration period, a minimum of \$15  
 4 for each quarter registered plus an additional fee of \$1.

5 (20) In addition to any other fees charged for registration of vehicles in fleets under ORS  
 6 805.120, the department may charge the following fees:

7 (a) A \$2 service charge for each vehicle entered into a fleet.

8 (b) A \$1 service charge for each vehicle in the fleet at the time of renewal.

9 (21) The registration fee for vehicles with special registration **is \$15** for:

10 (a) Disabled veterans under ORS 805.100 [*is a fee of \$15*].

12 (22) Subject to subsection (19) of this section, the registration fee for motor vehicles registered  
 13 as farm vehicles under ORS 805.300 is as follows based upon the registration weight given in the
