

# House Bill 2185

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Business and Labor)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Higher Education Coordinating Commission for Office of Community Colleges and Workforce Development for Oregon Youth Employment Program, local workforce investment boards and Oregon Youth Conservation Corps.

Appropriates moneys from General Fund to Department of Education for Youth Development Council programs that support youth employment and career and technical education programs that offer employment experiences for students.

Declares emergency, effective July 1, 2017.

## A BILL FOR AN ACT

2 Relating to state financial administration; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. In addition to and not in lieu of any other appropriation, there is appropri-**  
5 **ated to the Higher Education Coordinating Commission, for the Office of Community Colleges**  
6 **and Workforce Development, for the biennium beginning July 1, 2017, out of the General**  
7 **Fund, the amount of \$\_\_\_\_\_ for the Oregon Youth Employment Program.**

8 **SECTION 2. In addition to and not in lieu of any other appropriation, there is appropri-**  
9 **ated to the Higher Education Coordinating Commission, for the Office of Community Colleges**  
10 **and Workforce Development, for the biennium beginning July 1, 2017, out of the General**  
11 **Fund, the amount of \$\_\_\_\_\_ for local workforce investment boards for youth work experi-**  
12 **ence programs.**

13 **SECTION 3. In addition to and not in lieu of any other appropriation, there is appropri-**  
14 **ated to the Higher Education Coordinating Commission, for the Office of Community Colleges**  
15 **and Workforce Development, for the biennium beginning July 1, 2017, out of the General**  
16 **Fund, the amount of \$\_\_\_\_\_ for the Oregon Youth Conservation Corps for grants for the**  
17 **Oregon Community Stewardship Corps and the Summer Conservation Corps.**

18 **SECTION 4. In addition to and not in lieu of any other appropriation, there is appropri-**  
19 **ated to the Department of Education, for the biennium beginning July 1, 2017, out of the**  
20 **General Fund, the amount of \$\_\_\_\_\_, which may be expended for Youth Development**  
21 **Council programs that support youth employment.**

22 **SECTION 5. In addition to and not in lieu of any other appropriation, there is appropri-**  
23 **ated to the Department of Education, for the biennium beginning July 1, 2017, out of the**  
24 **General Fund, the amount of \$\_\_\_\_\_, which may be expended for career and technical ed-**  
25 **ucation programs that offer employment experiences for students.**

26 **SECTION 6. This 2017 Act being necessary for the immediate preservation of the public**  
27 **peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect**  
28 **July 1, 2017.**
