SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

[Reduces crime classification of unlawful possession of controlled substance in Schedule I. Pun-ishes by maximum of one year's imprisonment, \$6,250 fine, or both, except in specified circumstances. Retains current crime classification if possession is commercial drug offense or if person possesses substantial quantity of controlled substance.]

[Reduces crime classification of unlawful possession of controlled substance in Schedule II. Punishes by maximum of one year's imprisonment, \$6,250 fine, or both, except in specified circumstances. Retains current crime classification if possession is commercial drug offense or if person possesses substantial quantity of controlled substance.] Establishes Task Force on Public Safety.

Directs Department of Human Services to, upon request, create racial and ethnic impact statement on effect of proposed legislation or state measure on racial and ethnic composition of recipients of human services.

Requires Oregon Criminal Justice Commission to, upon request by member of Legislative Assembly from each major political party, create racial and ethnic impact statement for either proposed legislation or state measure that is related to crime and likely to have impact on criminal justice system. Requires that statement pertaining to state measure be printed in voters' pamphlet. Declares emergency, effective on passage.

6 SECTION 1. (1) The Task Force on Public Safety is established, consisting of 13 members appointed to two-year terms as follows: 7

- (a) The President of the Senate shall appoint two members from among members of the 8
- Senate. 9

- (b) The Speaker of the House of Representatives shall appoint two members from among 10
- members of the House of Representatives. 11
- (c) The Chief Justice of the Supreme Court shall appoint two members. 12
- (d) The Governor shall appoint seven members as follows: 13
- (A) One member shall be a county commissioner. 14
- (B) One member shall be a district attorney. 15
- (C) One member shall be a criminal defense attorney. 16
- 17 (D) Two members shall be representatives of law enforcement.
- (E) One member shall be a representative of community corrections directors who is not 18
- a sheriff. 19

(F) One member shall be a representative of a community-based organization that pro-1 vides services to victims of crime. 2 (2) The task force shall: 3 (a) Study security release in Oregon, focusing on reducing racial and ethnic disparity in 4 pretrial incarceration, including: $\mathbf{5}$ (A) Repealing statutes authorizing security release in favor of courts, or another entity 6 with delegated authority, making release decisions; 7 (B) Utilizing pretrial release risk assessments; and 8 9 (C) Methods of reducing failure to appear at court hearings; (b) Study the impact of criminal fines and fees; and 10 (c) Review the implementation of the Justice Reinvestment Program. 11 12(3) No later than September 15, 2018, the task force shall submit to the Legislative As-13 sembly, in the manner provided by ORS 192.245, a report that describes the findings of the task force. The report may include recommendations for legislation. The task force shall 14 15 provide a copy of the report to the Governor. (4) A majority of the members of the task force constitutes a quorum for the transaction 16 17 of business. 18 (5) Official action by the task force requires the approval of a majority of the members of the task force. 19 (6) The task force shall elect one of its members to serve as chairperson. 20(7) If there is a vacancy for any cause, the appointing authority shall make an appoint-21 22ment to become immediately effective. 23(8) The task force shall meet at times and places specified by the call of the chairperson or of a majority of the members of the task force. 24 (9) The task force may adopt rules necessary for the operation of the task force. 25(10) Upon request, the Oregon Criminal Justice Commission, the Department of Cor-2627rections and the Oregon Department of Administrative Services shall provide staff support to the task force. 28(11) Members of the task force who are not members of the Legislative Assembly are not 2930 entitled to compensation or reimbursement for expenses and serve as volunteers on the task 31 force. (2)(a) Upon written request from a member of the Legislative Assembly from each major 39 political party, the Oregon Criminal Justice Commission shall prepare a racial and ethnic 40 impact statement on proposed legislation that is related to crime and likely to have an effect 41 on the criminal justice system. 42 (b) The statement shall describe the effects of the proposed legislation on the racial and 43 ethnic composition of the criminal offender population. 44 (3) A racial and ethnic impact statement must be impartial, simple and understandable 45

and must include, for racial and ethnic groups for which data are available, the following: 1 2 (a) An estimate of how the proposed legislation would change the racial and ethnic composition of those likely to be convicted of a criminal offense created or modified by the 3 4 proposed legislation; (b) An estimate of the average length of incarceration that each racial and ethnic com-5 position group receives as a sentence, if applicable; 6 (c) A statement of the methodologies and assumptions used in preparing the estimate; 7 and 8 9 (d) An estimate of the racial and ethnic composition of the crime victims who may be 10 affected by the proposed legislation. (4) The commission shall adopt rules to carry out the provisions of this section. 11 12SECTION 3. (1)(a) Upon written request from a member of the Legislative Assembly from 13 each major political party, the Oregon Criminal Justice Commission shall prepare a racial and ethnic impact statement for a state measure that is related to crime and likely to have 14 15 an effect on the criminal justice system. (b) The racial and ethnic impact statement must: 16 17 (A) Describe the effects of the state measure on the racial and ethnic composition of the criminal offender population as defined in section 2 of this 2017 Act; 18 (B) Include the information described in section 2 (3) of this 2017 Act; and 19 (C) Be impartial, simple and understandable. 20(2) If the commission has prepared a racial and ethnic impact statement for a state 21 22measure, not later than the 110th day before a special election held on the date of a primary election or any general election at which the state measure is to be submitted to the people, 23the commission shall file the statement with the Secretary of State. 24 (3) Not later than the 100th day before the election at which the measure is to be voted 25upon, the Secretary of State shall hold a hearing in Salem upon reasonable statewide notice 2627to receive suggestions for changes to the statement or to receive other information. At the hearing, any person may submit suggested changes or other information orally or in writing. 28Written suggestions and any other information also may be submitted at any time before the 2930 hearing. 31 (4) The commission shall consider suggestions and any other information submitted under subsection (3) of this section and may file a revised statement with the Secretary of 32State not later than the 90th day before the election at which the measure is to be voted 33 34 upon. 35(5) The Secretary of State shall certify the statement not later than the 90th day before the election at which the measure is to be voted upon. 36 37 (6) All statements prepared under this section shall be made available to the public. 38 (7) A failure to prepare, file or certify a statement does not prevent inclusion of the measure in the voters' pamphlet. 39

Upon receipt of 3 the written request, the [Oregon Criminal Justice Commission] Department of Human Services 4 shall prepare a racial and ethnic impact statement that describes the effects of proposed legislation 5 on the racial and ethnic composition of[:] 6 [(a) The criminal offender population; or] 7 [(b)] recipients of human services. 8 9 (3) A racial and ethnic impact statement must be impartial, simple and understandable and must include, for racial and ethnic groups for which data are available, the following: 10 (a) An estimate of how the proposed legislation would change the racial and ethnic composition 11 12 of the [criminal offender population or] recipients of human services; and 13 (b) A statement of the methodologies and assumptions used in preparing the estimate.[; and] [(c) If the racial and ethnic impact statement addresses the effect of proposed legislation on the 14 15 criminal offender population, an estimate of the racial and ethnic composition of the crime victims who may be affected by the proposed legislation.] 16 (4) The [commission] department shall adopt rules to carry out the provisions of this section. 17 18 SECTION 5. (1) To obtain a racial and ethnic impact statement described in this section, one member of the Legislative Assembly from each major political party must sign a written request. (1) The purpose of the Oregon Criminal Justice Commission is to improve the effec-4 tiveness and efficiency of state and local criminal justice systems by providing a centralized and 5 impartial forum for statewide policy development and planning. 6 (2) The primary duty of the commission is to develop and maintain a state criminal justice policy 7 and comprehensive, long-range plan for a coordinated state criminal justice system that encompasses 8 9 public safety, offender accountability, crime reduction and prevention and offender treatment and rehabilitation.
