SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Adds peer support specialist, family support specialist and youth support specialist to membership of Traditional Health Workers Commission. Modifies definition of "peer support specialist" and "peer wellness specialist," and adds definitions for "family support specialist" and "youth support specialist." Requires coordinated care organizations to ensure members have access to peer support specialists. Authorizes Oregon Health Authority to adopt qualification criteria for traditional health workers utilized by coordinated care organizations.

Requires Attorney General and Director of Oregon Health Authority to collaborate with coordinated care organizations and groups that advocate for survivors of intimate partner violence to develop and implement plan to incorporate advocates for domestic and sexual violence survivors into workforce of traditional health workers serving medical assistance recipients.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 413.600 is amended to read:

6 413.600. (1) There is established within the Oregon Health Authority the Traditional Health
7 Workers Commission.

8 (2) The Director of the Oregon Health Authority shall appoint the following 19 members to serve
9 on the commission:

10 (a) Ten members, at least six of whom must be appointed from nominees provided by the Oregon
11 Community Health Workers Association, who represent traditional health workers, including at
12 least one member to represent each of the following:

13 (A) Community health workers, **as defined in ORS 414.025;**

14 (B) Personal health navigators, **as defined in ORS 414.025;**

15 (C) Peer wellness specialists, **including family support specialists and youth support spe-**
16 **cialists, all as defined in ORS 414.025; [and]**

17 **(D) Peer support specialists, including family support specialists and youth support spe-**
18 **cialists, all as defined in ORS 414.025; and**

19 [(D)] **(E) Doulas;**

20 (b) One member who represents the Office of Community Colleges and Workforce Development;

21 (c) One member who is a community health nurse who represents the Oregon Nurses Associ-
22 ation;

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (d) One member who is a physician who represents the Oregon Medical Association;

2 (e) One member selected from nominees provided by the Home Care Commission;

3 (f) One member who represents coordinated care organizations;

4 (g) One member who represents a labor organization;

5 (h) One member who supervises traditional health workers at a community-based organization,
6 local health department, as defined in ORS 433.235, or agency, as defined in ORS 183.310;

7 (i) One member who represents community-based organizations or agencies, as defined in ORS
8 183.310, that provide for the training of traditional health workers; and

9 (j) One member who represents a consumer of services provided by health workers who are not
10 licensed by this state.

11 (3) In appointing members under subsection (2) of this section, the director shall consider
12 whether the composition of the Traditional Health Workers Commission represents the geographic,
13 ethnic, gender, racial, disability status, gender identity, sexual orientation and economic diversity
14 of traditional health workers.

15 (4) The term of office of each member of the commission is three years, but a member serves
16 at the pleasure of the director. Before the expiration of the term of a member, the director shall
17 appoint a successor whose term begins on January 1 next following. A member is eligible for re-
18 appointment. If there is a vacancy for any cause, the director shall make an appointment to become
19 immediately effective for the unexpired term.

20 (5) A majority of the members of the commission constitutes a quorum for the transaction of
21 business.

22 (6) Official action by the commission requires the approval of a majority of the members of the
23 commission.

24 (7) The commission shall elect one of its members to serve as chairperson.

25 (8) The commission shall meet at times and places specified by the call of the chairperson or
26 of a majority of the members of the commission.

27 (9) The commission may adopt rules necessary for the operation of the commission.

28 (10) A member of the commission is entitled to compensation and expenses as provided in ORS
29 292.495.

15 414.635. (1) The Oregon Health Authority shall adopt by rule safeguards for members enrolled
16 in coordinated care organizations that protect against underutilization of services and inappropriate
17 denials of services. In addition to any other consumer rights and responsibilities established by law,
18 each member:

19 (a) Must be encouraged to be an active partner in directing the member’s health care and ser-
20 vices and not a passive recipient of care.

21 (b) Must be educated about the coordinated care approach being used in the community and how
22 to navigate the coordinated health care system.

23 (c) Must have access to advocates, including qualified peer wellness specialists, [*where appro-*
24 *priate*] **peer support specialists**, personal health navigators, and qualified community health work-
25 ers who are part of the member’s care team to provide assistance that is culturally and linguistically
26 appropriate to the member’s need to access appropriate services and participate in processes af-
27 fecting the member’s care and services.

28 (d) Shall be encouraged within all aspects of the integrated and coordinated health care delivery
29 system to use wellness and prevention resources and to make healthy lifestyle choices.

30 (e) Shall be encouraged to work with the member’s care team, including providers and commu-
31 nity resources appropriate to the member’s needs as a whole person.

32 (2) The authority shall establish and maintain an enrollment process for individuals who are
33 dually eligible for Medicare and Medicaid that promotes continuity of care and that allows the
34 member to disenroll from a coordinated care organization that fails to promptly provide adequate
35 services and:

36 (a) To enroll in another coordinated care organization of the member’s choice; or

37 (b) If another organization is not available, to receive Medicare-covered services on a fee-for-
38 service basis.

39 (3) Members and their providers and coordinated care organizations have the right to appeal
40 decisions about care and services through the authority in an expedited manner and in accordance
41 with the contested case procedures in ORS chapter 183.

42 (4) A health care entity may not unreasonably refuse to contract with an organization seeking
43 to form a coordinated care organization if the participation of the entity is necessary for the or-
44 ganization to qualify as a coordinated care organization.

45 (5) A health care entity may refuse to contract with a coordinated care organization if the re-

1 imbursement established for a service provided by the entity under the contract is below the rea-
2 sonable cost to the entity for providing the service.

3 (6) A health care entity that unreasonably refuses to contract with a coordinated care organ-
4 ization may not receive fee-for-service reimbursement from the authority for services that are
5 available through a coordinated care organization either directly or by contract.

6 (7)(a) The authority shall adopt by rule a process for resolving disputes involving:

7 (A) A health care entity's refusal to contract with a coordinated care organization under sub-
8 sections (4) and (5) of this section.

9 (B) The termination, extension or renewal of a health care entity's contract with a coordinated
10 care organization.

11 (b) The processes adopted under this subsection must include the use of an independent third
12 party arbitrator.

13 (8) A coordinated care organization may not unreasonably refuse to contract with a licensed
14 health care provider.

15 (9) The authority shall:

16 (a) Monitor and enforce consumer rights and protections within the Oregon Integrated and Co-
17 ordinated Health Care Delivery System and ensure a consistent response to complaints of violations
18 of consumer rights or protections.

19 (b) Monitor and report on the statewide health care expenditures and recommend actions ap-
20 propriate and necessary to contain the growth in health care costs incurred by all sectors of the
21 system.

36 care organizations;

37 [(b) *Education and training requirements for such individuals;*]

38 [(c)] (b) Appropriate professional designations for supervisors of [*such individuals*] **the tradi-**

31 (b) Notwithstanding paragraph (a) of this subsection, of a crime described in ORS 163.465,
32 163.467, 163.700, 163.701, 164.055, 164.125 or 164.377, the date of conviction for which was within the
33 five years immediately preceding employment in any capacity of an individual, other than a mental
34 health or substance abuse treatment provider, having contact with a recipient of support services,
35 a resident of a residential facility or a resident of an adult foster home, when the recipient or resi-
36 dent is 65 years of age or older;
