

HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2356

- 1 On page 1 of the printed A-engrossed bill, delete lines 20 and 21.
- 2 On page 2, delete lines 1 and 2 and insert:
- 3 “(D) The amount and rate of interest, any fees and any charges that the original creditor im-
- 4 posed, if the debt buyer or debt collector knows the amount, rate, fee or charge;
- 5 “(E) The amount and rate of interest, any fees and any charges that the debt buyer or any
- 6 previous owner of the debt imposed, if the debt buyer or debt collector knows the amount, rate, fee
- 7 or charge;”.
- 8 Delete lines 7 through 30.
- 9 In line 31, delete “(3)(a)” and insert “(2)(a)”.
- 10 In line 37, delete “(4)” and insert “(3)”.
- 11 In line 40, delete “subsection (2)(b) of this section” and insert “ORS 646.639 (4)(b)”.
- 12 In line 44, delete “(5)” and insert “(4)”.
- 13 In line 45, delete “subsection (2) of this section, other than the af-” and insert “ORS 646.639
- 14 (4)(b)”.
- 15 On page 3, delete line 1.
- 16 On page 5, delete lines 42 and 43 and insert:
- 17 “(t) Collects or attempts to collect a debt before providing to a debtor, within 30 days after the
- 18 date of the debtor’s request, all of the documents listed in subsection (4)(b) of this section.”.
- 19 On page 6, line 5, delete the first “Brings” and insert “Files” and delete the second “brings” and
- 20 insert “files”.
- 21 In line 9, delete “attempts” and insert “brings a legal action to attempt”.
- 22 Delete lines 26 through 29 and insert:
- 23 “(iv) The amount and rate of interest, any fees and any charges that the original creditor im-
- 24 posed, if the debt buyer or debt collector knows the amount, rate, fee or charge;
- 25 “(v) The amount and rate of interest, any fees and any charges that the debt buyer or any pre-
- 26 vious owner of the debt imposed, if the debt buyer or debt collector knows the amount, rate, fee or
- 27 charge;”.
- 28 On page 7, line 4, delete “or”.
- 29 In line 6, delete “section 1 (5) of this 2017 Act” and insert “paragraph (b) of this subsection”.
- 30 In line 9, delete the period and insert “; or”.
- 31 On page 9, line 14, after “enforcing” insert “ORS 646.639 and”.
- 32 On page 14, line 21, delete “or decline to renew”.
- 33 On page 15, line 15, delete “sections 1 and 2 (4)(b)”.
- 34 In line 16, delete “and (d) of this 2017 Act” and insert “section 1 of this 2017 Act and ORS
- 35 646.639 (4)(b) and (d)”.

1 After line 26, insert:

2 **“SECTION 16. Notwithstanding any other law limiting expenditures, the limitation on**
3 **expenditures established by section 1 (5), chapter 372, Oregon Laws 2017 (Enrolled Senate**
4 **Bill 5512), for the biennium beginning July 1, 2017, as the maximum limit for payment of ex-**
5 **penses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding**
6 **lottery funds and federal funds, collected or received by the Department of Consumer and**
7 **Business Services for the Division of Financial Regulation, is increased by \$165,351 for the**
8 **purpose of carrying out the provisions of sections 1 and 3 to 13 of this 2017 Act and the**
9 **amendments to ORS 646.639 by section 2 of this 2017 Act.”.**

10 In line 27, delete “16” and insert “17”.
