# **B-Engrossed** House Bill 2432

Ordered by the Senate May 10 Including House Amendments dated March 6 and Senate Amendments dated May 10

# SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs Health Licensing Office to issue license to engage in practice of art therapy to qualified applicant. Requires person licensed to practice art therapy to comply with rules adopted by office. Allows office to impose discipline on person practicing art therapy for certain violations. Directs office to provide administrative and regulatory oversight to art therapy program. Directs office to adopt rules relating to art therapy. Declares emergency, effective on passage.

6	SECTION 1. As used in sections 1 to 7 of this 2017 Act:
7	(1) "Art therapy" means the integrated use of psychotherapeutic principles, visual art
8	media and the creative process to assist clients in increasing awareness of self and others,
9	coping with symptoms, stress and traumatic experiences, enhancing cognitive abilities and
10	identifying and implementing therapeutic interventions to meet developmental, behavioral,
11	cognitive and emotional needs.
12	(2) "Board certified art therapist" means a person who is credentialed by the Art Therapy
13	Credentials Board, Inc., or its successor organization, as a board certified art therapist.
14	(3) "Licensed art therapist" means a person licensed by the Health Licensing Office to

45 practice of art therapy unless the person is licensed under section 2 or 3 of this 2017 Act.

1 (2) Subsection (1) of this section does not apply to:

(a) The practice of art therapy as an integral part of a supervised course of study in art
 therapy;

4 (b) A person who holds a master's degree in art therapy and who is engaged in the 5 practice of art therapy under supervision as part of clinical training to fulfill the supervised 6 experience requirement to be credentialed as a registered art therapist;

7 (c) A person licensed under the laws of this state in a profession or occupation other
8 than art therapy who uses art in a manner incidental to the person's practice;

(e) A person who is employed by a state, local or federal government agency or by a

this state, if the person provides services within the person's scope of employment and the
person does not use the term "art therapy" in connection with the services; or

(f) A person who is authorized by this state to provide mental health services if the person provides those services within the person's authorized scope of practice and does not use the title "art therapist" in connection with the services.

19 <u>SECTION 6.</u> In the manner prescribed in ORS chapter 183 for contested cases, the Health 20 Licensing Office may impose a form of discipline as specified in ORS 676.612 against any 21 person practicing art therapy for any of the grounds listed in ORS 676.612 and for any vio-22 lation of sections 1 to 7 of this 2017 Act, or the rules adopted under sections 1 to 7 of this 23 2017 Act.

SECTION 7. The Health Licensing Office shall adopt rules to:

At the time the summary of the complaint or the matter being investigated is provided, the office shall provide the authorization holder with a current summary of documents or alleged facts that the office has acquired as a result of the investigation. The name of the complainant may be withheld from the authorization holder.

(9) An authorization holder who is the subject of an investigation, and any person acting on
behalf of the authorization holder, may not contact the complainant until the authorization holder
has requested a contested case hearing and the office has authorized the taking of the complainant's
deposition pursuant to ORS 183.425.
