SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Allows Department of Transportation and person, under certain circumstances, to enter into agreement that enables person to transact [any function] certain functions of department on behalf of department.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to integrators; amending ORS 802.600; and declaring an emergency.

3 Be It Enacted by the People of the State of Oregon:

4 **SECTION 1.** ORS 802.600 is amended to read:

- 5 802.600. (1) The Department of Transportation may enter into an agreement with any person
- 6 who is not an employee of the department, including but not limited to an integrator, enabling the

7 person to transact on behalf of the department the following functions of the department:

8 [(a) Electronic issuance of vehicle title.]

- 9 [(b) Immediate issuance of title and registration, including registration plates or stickers, to a per-10 son who buys a vehicle.]
- 11 (a) Any vehicle-related transaction for which the department is responsible.

(b) Processing of fees or taxes for a vehicle-related transaction for which the department
is responsible.

14 (c) Written and skills testing for driver licenses and permits, including commercial driver li-15 censes.

16 [(d) Issuance of identification cards.]

17 (2) An agreement described in subsection (1) of this section may be in any form and may contain 18 any provisions that the department determines to be in the best interests of the public and conven-19 ient for the department, including but not necessarily limited to provisions that allow the depart-20 ment to:

21 (a) Ensure product quality control.

- (b) Audit activities of the person entering into the agreement to ensure compliance with the agreement.
- 24 (c) Impose sanctions on a person for violation of the agreement.

(3) A person authorized to transact business for the department under this section, including but
not limited to a person who transacts business under contract with an integrator, may charge a fee

for the services provided. Fees authorized under this subsection are in addition to any charges or 1 2 fees that the department is authorized by statute to collect for the transaction. (4)(a) The department may adopt such rules as are necessary to carry out the provisions of this 3 section, including but not limited to rules that: 4 (A) Specify criteria for eligibility of a person to enter into an agreement with the department $\mathbf{5}$ under this section. 6 (B) Specify the manner in which fees authorized by this section will be collected and establish 7 any notification the person is required to give the public about the fees. 8

9 (C) Require a bond in an amount determined by the department from a person acting under an 10 agreement described in this section.

(D) Prohibit disclosure of personal information from driver or vehicle records except in accord-ance with applicable laws.

(b) The department may not adopt rules establishing the amount of a fee to be charged by aperson acting under this section.

(c) Rules adopted under this subsection shall be developed in consultation with persons who might enter into agreements with the department under this section, including but not limited to integrators and vehicle dealers.

(5) As used in this section, "integrator" means a person who enters into a contract with theDepartment of Transportation:

(a) To provide information and supplies to a person who transacts business for the department
under an agreement described in this section; and

(b) To collect moneys due from persons who transact the business and remit the moneys to thedepartment.

24 <u>SECTION 2.</u> This 2017 Act being necessary for the immediate preservation of the public 25 peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect 26 on its passage.

27
