

# House Bill 2463

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Transportation and Economic Development)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Allows Department of Transportation and person, under certain circumstances, to enter into agreement that enables person to transact any function of department on behalf of department.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

1  
2 Relating to integrators; amending ORS 802.600; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 802.600 is amended to read:

5 802.600. (1) The Department of Transportation may enter into an agreement with any person  
6 who is not an employee of the department, including but not limited to an integrator, enabling the  
7 person to transact on behalf of the department [*the following functions*] **any function** of the de-  
8 partment.[.]

9 [*(a) Electronic issuance of vehicle title.*]

10 [*(b) Immediate issuance of title and registration, including registration plates or stickers, to a per-*  
11 *son who buys a vehicle.*]

12 [*(c) Written and skills testing for driver licenses and permits, including commercial driver*  
13 *licenses.*]

14 [*(d) Issuance of identification cards.*]

15 (2) An agreement described in subsection (1) of this section may be in any form and may contain  
16 any provisions that the department determines to be in the best interests of the public and conven-  
17 ient for the department, including but not necessarily limited to provisions that allow the depart-  
18 ment to:

19 (a) Ensure product quality control.

20 (b) Audit activities of the person entering into the agreement to ensure compliance with the  
21 agreement.

22 (c) Impose sanctions on a person for violation of the agreement.

23 (3) A person authorized to transact business for the department under this section, including but  
24 not limited to a person who transacts business under contract with an integrator, may charge a fee  
25 for the services provided. Fees authorized under this subsection are in addition to any charges or  
26 fees that the department is authorized by statute to collect for the transaction.

27 (4)(a) The department may adopt such rules as are necessary to carry out the provisions of this  
28 section, including but not limited to rules that:

29 (A) Specify criteria for eligibility of a person to enter into an agreement with the department  
30 under this section.

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (B) Specify the manner in which fees authorized by this section will be collected and establish  
2 any notification the person is required to give the public about the fees.

3 (C) Require a bond in an amount determined by the department from a person acting under an  
4 agreement described in this section.

5 (D) Prohibit disclosure of personal information from driver or vehicle records except in accord-  
6 ance with applicable laws.

7 (b) The department may not adopt rules establishing the amount of a fee to be charged by a  
8 person acting under this section.

9 (c) Rules adopted under this subsection shall be developed in consultation with persons who  
10 might enter into agreements with the department under this section, including but not limited to  
11 integrators and vehicle dealers.

12 (5) As used in this section, "integrator" means a person who enters into a contract with the  
13 Department of Transportation:

14 (a) To provide information and supplies to a person who transacts business for the department  
15 under an agreement described in this section; and

16 (b) To collect moneys due from persons who transact the business and remit the moneys to the  
17 department.

18 **SECTION 2. This 2017 Act being necessary for the immediate preservation of the public**  
19 **peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect**  
20 **on its passage.**
