

House Bill 2481

Sponsored by Representative BENTZ (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires gas station owner or operator to print, on any receipt that owner or operator provides to customer after customer purchases gasoline, cost to customer per gallon of gasoline of low carbon fuel standards.

Requires Environmental Quality Commission to calculate cost to retail customer, per gallon of gasoline, of low carbon fuel standards that commission adopts by rule and to furnish gas stations with formula commission used for calculation and results of calculation.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to indicating the cost per gallon of gasoline of the low carbon fuel standards; creating new
3 provisions; amending ORS 646.932; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 646.932 is amended to read:

6 646.932. (1) As used in this section, "gas station" includes a filling station, service station, ga-
7 rage or any other place where gasoline is sold for use in motor vehicles.

8 (2) The owner or operator of a gas station shall post, in a manner visible to customers, the fol-
9 lowing information:

10 (a) The amount of the price per gallon that is federal tax;

11 (b) The amount of the price per gallon that is state tax;

12 (c) The amount of the price per gallon that is local tax; and

13 (d) The total amount of federal, state and local taxes per gallon.

14 (3) The Department of Transportation shall furnish the information described in subsection (2)
15 of this section to each gas station in *[the]* **this** state.

16 (4)(a) **The owner or operator of a gas station shall print on any receipt that the owner**
17 **or operator provides to a customer after the customer purchases gasoline, the cost to the**
18 **customer, per gallon of gasoline, of the low carbon fuel standards described in ORS 468A.275.**

19 (b) **The Environmental Quality Commission shall calculate the cost to the retail cus-**
20 **tomer, per gallon of gasoline, of the low carbon fuel standards that the commission adopts**
21 **by rule under ORS 468A.275. The commission shall post the formula the commission used for**
22 **the calculation and the results of the calculation on the commission's website or otherwise**
23 **furnish the formula and results of the calculation to each gas station in this state so that**
24 **the gas station's owners and operators may meet the requirement set forth in paragraph (a)**
25 **of this subsection.**

26 **SECTION 2.** **The amendments to ORS 646.932 by section 1 of this 2017 Act apply to any**
27 **transaction for a purchase of gasoline in this state that occurs on or after the operative date**
28 **set forth in section 3 of this 2017 Act.**
