House Bill 2560

Sponsored by Representative NEARMAN (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Provides that any right to sue or to appeal or other judicial review related to public charter schools or provided by other law may not be waived by contract. Declares emergency, effective on passage.
