

House Bill 2609

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Judiciary)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Updates laws that govern nonprofit corporations in this state.

12 **Be It Enacted by the People of the State of Oregon:**

13 **SECTION 1. Section 2 of this 2017 Act is added to and made a part of ORS 65.201 to 65.254.**

14 **SECTION 2. (1) Unless a corporation's articles of incorporation or bylaws provide other-**
15 **wise:**

16 **(a) The corporation's board of directors may, without a meeting, use electronic mail or**
17 **other electronic means to take action that this chapter otherwise requires or permits the**
18 **board of directors to take at a board of directors' meeting if the corporation complies with**
19 **this section.**

20 **(b) The board of directors may, without complying with all of the requirements of this**
21 **section, use electronic mail to discuss, but not take action on, an issue that comes before**
22 **the board.**

23 **(2)(a) Before taking an action under subsection (1) of this section, a corporation shall**
24 **send to the electronic mail address that each director provided to the corporation for re-**
25 **ceiving communications from the corporation an electronic mail announcement that states**
26 **that the board of directors will take the action.**

27 **(b) The electronic mail announcement the corporation sends under paragraph (a) of this**
28 **subsection must include a description of the matter on which the board of directors will take**
29 **action. The electronic mail announcement must specify a deadline of not less than 48 hours**
30 **after the time the corporation sends the announcement in which a director may record the**
31 **director's vote.**

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (c) The corporation shall include the electronic mail announcement described in this
 2 subsection and a record of the directors' votes in the minutes for the directors' meeting or
 3 shall file the announcement and record of the directors' votes in documents that reflect the
 4 action that the board took.

5 (3) Notwithstanding subsection (1) of this section, a corporation's board of directors may
 6 not use electronic mail or other electronic means to take action if the corporation does not
 7 have a record of an electronic mail address for a director.

8 (4) A director may change the director's vote at any time before the deadline set forth
 9 in the electronic mail announcement described in subsection (2) of this section.

10 (5) An affirmative vote of the majority of the directors who hold office at the time the
 11 board of directors takes an action by means of electronic mail or by other electronic means
 12 is an act of the board, unless a corporation's articles of incorporation or bylaws require an
 13 affirmative vote of a greater number of directors. The board's action under this subsection
 14 has the effect of a meeting vote and the corporation may describe the action as a meeting
 15 vote in any document.

16 (6) The board's action under subsection (5) of this section is effective on the deadline
 17 specified in the electronic mail announcement described in subsection (2) of this section,
 18 unless the announcement specifies a different effective date or time.

19 **SECTION 3.** Section 4 of this 2017 Act is added to and made a part of ORS 65.431 to 65.467.

20 **SECTION 4.** If a public benefit corporation has not conducted a meeting of the members
 21 and if members have not actively participated in the public benefit corporation's affairs for
 22 three years or more, the public benefit corporation's board of directors may act in accord-
 23 ance with ORS 65.434 to amend the articles of incorporation to state that the public benefit
 24 corporation does not have members if:

25 (1) The board first notifies any known members and posts a notice on the public benefit
 26 corporation's website or otherwise gives comparable notice to the public of the proposed
 27 amendment to the articles of incorporation; and

28 (2) The board does not receive an objection from any member within 30 days after the
 29 date of the notice.

30 **SECTION 5.** ORS 65.001 is amended to read:

31 65.001. As used in this chapter:

32 (1)(a) "Anniversary" means, **except as provided in paragraph (b) of this subsection**, the day
 33 each year that is exactly one or more years after the date on which [*the Office of*] the Secretary of
 34 State files:

35 (A) The articles of incorporation for a domestic corporation; or [*the date on which the office*
 36 *files*]

37 (B) An application for authority to transact business for a foreign corporation.

38 (b) "Anniversary" means **February 28** if an event **occurs** that would otherwise cause an an-
 39 niversary to fall on February 29 [*will cause the anniversary to fall on February 28*].

40 (2) "Appointed director" means a director who is appointed by a person other than the
 41 board of directors.

42 [(2)] (3) "Approved by the members" or "approval by the members" means approved or ratified
 43 by [*the*] members entitled to vote on [*the*] an issue through either:

44 (a) The affirmative vote of a majority of the votes of the members represented and voting at a
 45 duly held meeting at which a quorum is present or the affirmative vote of a greater proportion in-

1 cluding the votes of any required proportion of the members of any class as the articles, bylaws or
 2 this chapter may provide for specified types of member action; or

3 (b) A written ballot or written consent in conformity with this chapter.

4 [(3)] (4) “Articles of incorporation” [or “*articles*”] means the articles of **incorporation** described
 5 in ORS 65.047[,] **and corrected**, amended and restated articles of incorporation [or *articles of*
 6 *merger, and corrections to the articles*].

7 (5) “**Articles of merger**” means the **articles of merger described in ORS 65.491 and cor-**
 8 **rected, amended and restated articles of merger.**

9 [(4)] (6) [“*Board*” or] “Board of directors” means the individual or individuals vested with over-
 10 all management of the affairs of [*the*] a domestic **corporation** or foreign corporation, irrespective
 11 of the name [*by which*] **that designates** the individual or individuals. [*are designated, except that an*
 12 *individual or a group of individuals is not the board of directors because of powers delegated to the*
 13 *individual or group under ORS 65.301.*]

14 [(5)] (7) “Bylaws” means [*the code or codes of rules, other than the articles adopted under this*
 15 *chapter or the laws governing a foreign corporation, for regulating or managing the affairs of the do-*
 16 *mestic or foreign corporation, irrespective of the name or names by which the rules are designated*] a
 17 **set of provisions for managing and regulating a corporation’s affairs that the corporation**
 18 **must adopt under ORS 65.061.**

19 [(6)] (8) “Class” means a group of memberships that have the same rights, **including rights that**
 20 **are determined by a formula that is applied uniformly**, with respect to voting, dissolution, re-
 21 demption and transfer. [*For the purpose of this section, rights are the same if the rights are determined*
 22 *by a formula applied uniformly.*]

23 [(7)] “Contact address” means a mailing address at which a person affiliated with the organization
 24 will receive and transmit to the organization notices intended for the foreign or domestic corporation
 25 either when sending the notices to the registered agent is not practical or when a duplicate notice is
 26 desirable. The contact address may be the principal place of business, if any, or the business or resi-
 27 dence address of any person associated with the corporation or foreign corporation who has consented
 28 to serve, but may not be the address of the registered agent.]

29 (9) “**Contact information**” means a **street address, a mailing address or an electronic**
 30 **address at which a member or director elects to receive notices and other messages from**
 31 **the corporation, including the corporation’s address if the corporation permits the member**
 32 **or director to receive notices and messages at the corporation’s address.**

33 (10) “**Corporation**” means a **domestic corporation or a foreign corporation.**

34 [(8)] “Corporation” or “domestic corporation” means a nonprofit corporation that is not a foreign
 35 corporation, and that is incorporated under or subject to the provisions of this chapter.]

36 [(9)] (11) [“*Delegates*” means those persons] “**Delegate**” means a **person who is** elected or ap-
 37 pointed to vote in a representative assembly for electing a director or directors or on other matters.

38 [(10)] (12) “Deliver” means **to transfer by** any method of delivery used in conventional com-
 39 mercial practice, including delivery by hand, mail, commercial delivery and electronic transmission.

40 [(11)] “*Directors*” means *individuals whom the articles or bylaws designate or whom the*
 41 *incorporators elect to act as members of the board, and the successors to the individuals.*]

42 (13) “**Designated director**” means a **director that the articles of incorporation or the by-**
 43 **laws designate as a director in a manner that identifies a specific individual or a group of**
 44 **individuals.**

45 (14) “**Director**” means an individual who acts as a member of the board of directors, who

1 **has a right to vote on questions concerning the management and regulation of a**
 2 **corporation's affairs and who is:**

3 **(a) An appointed director;**

4 **(b) A designated director; or**

5 **(c) A director elected by the incorporators, directors or members.**

6 [(12)] **(15) "Distribution"** means *[paying a dividend or any part of the income or profit of a cor-*
 7 *poration to the corporation's members, directors or officers, other than paying value for property re-*
 8 *ceived or services performed or paying benefits to further the corporation's purposes]* **a payment to**
 9 **a person from the income or assets of a corporation, other than a payment of reasonable**
 10 **value to a person for property received or services performed or a payment that furthers the**
 11 **corporation's purposes.**

12 **(16) "Document" means:**

13 **(a) A medium that embodies information in tangible form, including any writing or**
 14 **written instrument; or**

15 **(b) An electronic medium that embodies information that a person may retain, retrieve**
 16 **and reproduce, in tangible form or otherwise.**

17 [(13)] **(17) "Domestic business corporation"** means a for profit corporation that is incorporated
 18 under ORS chapter 60.

19 **(18) "Domestic corporation" means a nonprofit corporation that is not a foreign corpo-**
 20 **ration and that is incorporated under or subject to the provisions of this chapter.**

21 [(14)] **(19) "Domestic limited liability company"** means an unincorporated association that has
 22 one or more members and that is organized under ORS chapter 63.

23 [(15)] **(20) "Domestic professional corporation"** means a corporation that is organized under ORS
 24 chapter 58 for the purpose of rendering professional services and for the purposes provided under
 25 ORS chapter 58.

26 [(16)] *"Effective date of notice" has the meaning given that term in ORS 65.034.]*

27 [(17)] **(21) "Employee" [includes] means an individual that a corporation employs, including**
 28 **an officer or director whom the corporation employs with compensation for services beyond [those**
 29 **encompassed by] the services of board membership.**

30 [(18)] **(22) "Entity"** means a **domestic** corporation, foreign corporation, business corporation and
 31 foreign business corporation, profit and nonprofit unincorporated association, corporation sole,
 32 business trust, partnership, two or more persons that have a joint or common economic interest, any
 33 state, the United States, a federally recognized Native American or American Indian tribal govern-
 34 ment and any foreign government.

35 [(19)] *"File," "filed" or "filing" means reviewed, accepted and entered in the Office of the Secretary*
 36 *of State.]*

37 [(20)] **(23) "Foreign business corporation"** means a for profit corporation that is incorporated
 38 under laws other than the laws of this state.

39 [(21)] **(24) "Foreign corporation"** means a corporation that is organized under laws other than
 40 the laws of this state and that would be a nonprofit corporation if *[formed]* **organized** under the
 41 laws of this state.

42 [(22)] **(25) "Foreign limited liability company"** means an unincorporated association that is or-
 43 ganized under laws other than the laws of this state and *[that is organized]* under a statute *[under*
 44 *which]* **that permits** an *[association may be formed]* **entity to organize and** that affords to each of
 45 the entity's members limited liability with respect to liabilities of the entity.

1 [(23)] **(26)** “Foreign professional corporation” means a professional corporation that is organized
2 under laws other than the laws of this state.

3 **(27) “Gift instrument” means a record, including a record of a solicitation, under which**
4 **a corporation holds property or under which property is granted or transferred to the cor-**
5 **poration.**

6 [(24)] **(28)** “Governmental subdivision” *[includes]* **means a unit of government, including** an
7 authority, county, district and municipality.

8 [(25)] **(29)** “Individual” means a natural person, including the guardian of an incompetent indi-
9 vidual.

10 [(26)(a)] **(30)(a)** “Member” means a person that is entitled, under a domestic **corporation’s** or
11 foreign corporation’s articles **of incorporation** or bylaws, **to exercise any of the rights described**
12 **in ORS 65.144[.]** without regard to *[what the person is called in the articles or bylaws,]* **whether the**
13 **articles of incorporation or the bylaws identify the person as a member or which other title**
14 **or identity the domestic corporation or foreign corporation gives to the person** *[to vote on*
15 *more than one occasion to elect a director or directors].*

16 **(b) “Member” does not include:**

17 [(b)] **(A)** A person *[is not a member by virtue of any of]* **that does not have the rights described**
18 **in ORS 65.144 or that has only** the following rights *[the person has]:*

19 [(A)] **(i)** *[As]* **Rights granted to** a delegate;

20 [(B)] **(ii)** **A right** to designate or appoint a director or directors;

21 **(iii)** **A right to vote on only one occasion to elect a director or directors;**

22 [(C)] **(iv)** *[As]* **Rights that** a director **has;** or

23 [(D)] **(v)** *[As a holder of an]* **Rights that a person has as a consequence of holding** evidence
24 of indebtedness the corporation has issued or will issue.

25 [(c)] **(B)** *[Notwithstanding the provisions of paragraph (a) of this subsection, a person is not a*
26 *member if the person’s]* **A person for which** membership rights have been eliminated as provided in
27 ORS 65.164 or 65.167.

28 [(27)] **(31)** “Membership” means the rights and obligations a member has under this chapter.

29 [(28)] **(32)** “Mutual benefit corporation” means a domestic corporation that is *[formed as a mu-*
30 *tual benefit corporation under ORS 65.044 to 65.067 and is designated a mutual benefit corporation by*
31 *a statute or does not come within the definition of]* **organized to serve and operates primarily to**
32 **serve the mutual interests of a group of persons, but is not a public benefit corporation or**
33 **religious corporation.**

34 [(29)] **(33)** “Nonprofit corporation” means a mutual benefit corporation, a public benefit corpo-
35 ration or a religious corporation.

36 [(30)] **(34)** “Notice” *[has the meaning given that term]* **means a notice described** in ORS 65.034.

37 [(31) “Office,” when used to refer to the administrative unit directed by the Secretary of State,
38 means the Office of the Secretary of State.]

39 [(32)] **(35)** “Person” means **an** individual or **an** entity.

40 [(33)] **(36)** “Principal office” means the physical street address of the place, in or out of this
41 state, where the principal executive offices of a domestic **corporation** or foreign corporation are
42 located and that is designated as the principal office in the most recent annual report filed pursuant
43 to ORS 65.787 or, if no annual report is on file, in the articles of incorporation or the application
44 for authority to transact business in this state.

45 [(34)] **(37)** “Proceeding” means a civil, criminal, administrative or investigatory action.

1 [(35)] **(38)** “Public benefit corporation” means a domestic corporation that:

2 (a) Is formed as a public benefit corporation under ORS 65.044 to 65.067, is designated as a
3 public benefit corporation by a statute, is recognized as tax exempt under section 501(c)(3) of the
4 Internal Revenue Code [*of 1986*] or is otherwise organized for a public or charitable purpose;

5 (b) Is restricted so that on dissolution the corporation must distribute the corporation’s assets
6 to an organization **that is** organized for a public or charitable purpose, a religious corporation, the
7 United States, a state or a person that is recognized as exempt under section 501(c)(3) of the Inter-
8 nal Revenue Code [*of 1986*]; and

9 [(c) *Does not come within the definition of “religious corporation.”*]

10 **(c) Is not a religious corporation.**

11 [(36)] **(39)** “Record date” means the date established under ORS 65.131 to 65.177 or 65.201 to
12 65.254 on which a corporation determines the identity of the corporation’s members and the
13 members’ membership rights for the purposes of this chapter.

14 [(37)] **(40)** “Religious corporation” means a domestic corporation that is formed as a religious
15 corporation under ORS 65.044 to 65.067, is designated a religious corporation by a statute or is or-
16 ganized primarily or exclusively for religious purposes.

17 [(38)] **(41)** “Remote communication” means any method by which a person that is not physically
18 present at the location at which a meeting occurs may nevertheless hear or otherwise communicate
19 at substantially the same time with other persons at the meeting and have access to materials nec-
20 essary to participate or vote in the meeting to the extent of the person’s authorization to participate
21 or vote.

22 [(39)] **(42)** “Secretary,” when used in the context of a corporate official, means the corporate
23 officer to whom the board of directors has delegated responsibility under ORS 65.371 for preparing
24 the minutes of the **board of directors’ meetings** and [*members’*] **membership** meetings and for
25 authenticating the records of the corporation.

26 **(43) “Sign” means to indicate a present intent to authenticate or adopt a document by:**

27 **(a) Affixing a symbol to the document;**

28 **(b) Inscribing or affixing a manual, facsimile or conformed signature on the document;**

29 **or**

30 **(c) Attaching to, or logically associating with, an electronic transmission any electronic
31 sound, symbol or process, including an electronic signature.**

32 [(40)] **(44)** “State,” when referring to a part of the United States, means a state, commonwealth,
33 territory or insular possession of the United States and the agencies and governmental subdivisions
34 of the state, commonwealth, territory or insular possession.

35 [(41)] **(45)** “Uncompensated officer” means an individual who serves in an office without com-
36 pensation [*for personal service. For purposes of this subsection,*] **other than** payment solely for ac-
37 tual expenses **the individual incurs** in performing duties of the [*officer or a stipend that is paid only*
38 *to compensate*] **individual’s office or payment for** the average expenses the individual incurs over
39 the course of a year [*is not compensation*].

40 [(42)] **(46)** “United States” means **the federal government and** a district, authority, bureau,
41 commission, department or any other agency of the United States.

42 [(43)] **(47)** “Vote” means **an** authorization by written ballot [*and*] **or** written consent, where
43 permitted, **or by another method that a corporation specifies as an authorization.**

44 [(44)] **(48)** “Voting power” means the total number of votes entitled to be cast on an issue at the
45 time the determination of voting power is made, excluding a vote that is contingent upon a condition

1 or event occurring that has not occurred at the time.

2 **(49) “Written” means embodied as a document.**

3 **SECTION 6.** ORS 65.004 is amended to read:

4 65.004. (1) For the Secretary of State to file a document under this chapter, the document must
5 satisfy the requirements set forth in this section and any other requirements in this chapter that
6 supplement or modify the requirements set forth in this section.

7 *[(2) The document must be one required or permitted to be filed in the Office of the Secretary of*
8 *State.]*

9 **(2) The document must be a type of document that this chapter or another law requires**
10 **or permits a person to file with the Secretary of State.**

11 (3) The document must contain the information required by this chapter and may contain other
12 information.

13 (4) The document must be legible.

14 (5) The document must be written in the alphabet used to write the English language, but may
15 include Arabic or Roman numerals and incidental punctuation. The certificate of existence required
16 of foreign corporations need not be in English if accompanied by a reasonably authenticated English
17 translation.

18 (6) The document must be executed:

19 (a) By a fiduciary, receiver or trustee, if the corporation is in the hands of a receiver, trustee
20 or other court-appointed fiduciary;

21 (b) By an incorporator, if directors have not been selected or the execution of the document
22 occurs before the organizational meeting;

23 (c) By the person specified in any section of this chapter that required the document be filed;

24 (d) By the chairperson of the board of directors of a domestic or foreign corporation, by the
25 president or otherwise by another of the officers of the corporation; or

26 (e) By an agent of a person identified in this subsection, if the person authorizes the agent to
27 execute the document.

28 (7) The document must state beneath or opposite the signature the person’s name and the ca-
29 pacity in which the person signs. The document may, but is not required to, contain:

30 (a) The corporate seal;

31 (b) An attestation by the secretary or an assistant secretary; or

32 (c) An acknowledgment, verification or proof.

33 (8) If the Secretary of State has prescribed a mandatory form for a document under ORS 65.016,
34 the document must be in or on the prescribed form.

35 (9) The document must be delivered to *[the Office of]* the Secretary of State for filing and must
36 be accompanied by the correct filing fee.

37 (10) **A filing is** *[A document is deemed filed or]* effective only as provided in ORS 56.080,
38 *[65.001,]* 65.011, 65.014 and 65.017.

39 **SECTION 7.** ORS 65.017 is amended to read:

40 65.017. (1) If a document delivered to *[the Office of]* the Secretary of State for filing satisfies the
41 requirements of ORS 65.004, the Secretary of State shall file *[it]* **the document.**

42 (2) The Secretary of State files a document by *[indicating thereon that it has been filed by the*
43 *Secretary of State and the date of filing]* **accepting, reviewing and entering the document into**
44 **the Secretary of State’s files, indicating on the document the date of filing and that the**
45 **Secretary of State has filed the document.** The time of filing *[shall be deemed to be]* is 12:01 a.m.

1 on *[that date]* **the date of filing**. After filing a document, except *[those referred to]* **a document**
 2 **described** in ORS 65.114, 65.671, 65.674, 65.724 and 65.787, the Secretary of State shall return an
 3 acknowledgment of filing to the *[domestic or foreign]* corporation **that filed the document** or *[its]*
 4 **to a representative of the corporation**.

5 (3) If the Secretary of State refuses to file a document, the Secretary of State shall return *[it]*
 6 **the document** to the *[domestic or foreign]* corporation **that sought to file the document** or *[its]*
 7 **to a representative of the corporation** within 10 business days after *[the document was received by*
 8 *the Office of]* the Secretary of State **received the document**, together with a brief written expla-
 9 nation of the reason or reasons for the refusal.

10 (4) The Secretary of State's duty to file documents under this section is ministerial. The Secre-
 11 tary of State is not required to verify or inquire into the legality or truth of any matter included
 12 in any document delivered to *[the Office of]* the Secretary of State for filing. *[Except as provided*
 13 *elsewhere in this chapter,]* The Secretary of State's filing or refusing to file a document does not:

14 (a) Affect the validity or invalidity of the document in whole or in part except as provided in
 15 ORS 65.051; or

16 (b) Relate to the correctness or incorrectness of information contained in the document.

17 (5) The Secretary of State's refusal to file a document does not create a presumption that the
 18 document is invalid or that information contained in the document is incorrect.

19 **SECTION 8.** ORS 65.034 is amended to read:

20 65.034. (1) Notice may be oral or written unless otherwise specified for a particular kind of no-
 21 tice.

22 (2) Notice may be communicated in person, by telephone, *[telegraph, teletype or other form of wire*
 23 *or wireless communication,]* **electronically** or by mail or private carrier, including publication in a
 24 newsletter or similar document mailed to a member's or director's address. If *[these forms of]* per-
 25 sonal notice *[are impracticable]* **is not possible**, notice may be communicated by a newspaper of
 26 general circulation in the area where the meeting is to be held, or by radio, television or other form
 27 of public broadcast communication.

28 *[(3) Written notice by a domestic or foreign corporation to its member, if in a comprehensible form,*
 29 *is effective when mailed if it is mailed postpaid and is correctly addressed to the member's address*
 30 *shown in the corporation's current records of members.]*

31 **(3) A notice is effective only if the notice is communicated in a comprehensible form.**

32 (4) Oral notice is effective when communicated *[if communicated in a comprehensible manner]*.

33 *[(5) Except as provided in subsection (3) of this section, personal written notice, if in a compre-*
 34 *hensible form, is effective at the earliest of the following:]*

35 *[(a) When received;]*

36 **(5)(a) Electronic notice in writing is effective at the earlier of:**

37 **(A) When the notice is received; or**

38 **(B) Two days after the notice is sent, if the notice is correctly addressed.**

39 **(b) Notice by mail or private carrier is effective at the earlier of:**

40 *[(b)] (A) Five days after [its postmark] the notice is deposited in the United States mail, if*
 41 *[mailed by United States mail] the notice is correctly addressed and [with] has first class postage*
 42 *affixed;*

16 271.330. (1) Any political subdivision is granted express power to relinquish the title to any of
17 the political subdivision's property not needed for public use to any governmental body, providing
18 the property *[shall be]* **is** used for not less than 20 years for a public purpose by the governmental
19 body in the State of Oregon. These transfers for public purposes may include transfers without
20 consideration of property held by counties as a result of tax foreclosures.

21 (2)(a) Any political subdivision is granted express power to relinquish the title to any of the
22 political subdivision's property to a qualifying nonprofit corporation or a municipal corporation for
23 the purpose of providing any of the following:

24 (A) Low income housing;

25 (B) Social services; or

26 (C) Child care services.

27 (b) As used in this subsection:

28 (A) "Qualifying nonprofit corporation" means a corporation that is a public benefit corporation
29 as defined in ORS 65.001 *[(35)]* and that has obtained a ruling from the federal Internal Revenue
30 Service providing that the corporation is exempt from federal income taxes under section 501(c)(3)
31 of the Internal Revenue Code.

32 (B) "Social services" and "child care services" include but are not limited to education, training,
33 counseling, health and mental health services and the provision of facilities and administrative ser-
34 vices to support social services and child care services.

35 (3) Any political subdivision is granted express power to convey real property to a nonprofit or
36 municipal corporation to be used by the nonprofit or municipal corporation for the creation of open
37 space, parks or natural areas for perpetual public use. The instrument conveying the real property
38 *[shall]* **must** include a restriction on the use of the property that limits the uses of the property to
39 those uses described in this subsection. The instrument conveying the property *[shall]* **must** also
40 contain a provision for the reversion of the property to the political subdivision if the property is
41 not used in conformance with the restriction. Real property conveyed under this subsection may
42 include real property held by a political subdivision as a result of tax foreclosures.

43 (4) Transfers under this section may include transfers without consideration of property held by
44 counties as a result of tax foreclosures.

45 (5) Before any county court or board of county commissioners may transfer, under subsection

1 (1) of this section, any tax foreclosed lands in which the state or a political subdivision has repres-
2 ented delinquent and uncollected taxes, liens or assessments, the county court or board of county
3 commissioners shall advertise in a newspaper of general circulation in the county for two successive
4 weeks the court's or the board's intention to so transfer the property. The notice [*shall*] **must** state
5 when the county court will hear objections to the transfer and must specifically describe the prop-
6 erty intended to be transferred. After the hearing set in the notice is held and objections are heard,
7 the court may, in the court's sound discretion, proceed with the transfer. Except in the case of a
8 transfer for low income housing, real property [*shall*] **must** be conveyed by deed, subject to a
9 reversionary interest retained by the granting political subdivision in the event that the property
10 is used for a purpose that is inconsistent with the grant. The granting political subdivision may
11 waive the subdivision's right to a reversionary interest at the time the property is conveyed. After
12 the transfer the interests of the state or any political subdivision in the land on account of uncol-
13 lected taxes, liens or assessments are extinguished, and the county is relieved of the necessity to
14 account for uncollected taxes, liens or assessments.

15 **SECTION 110. ORS 65.501 is repealed.**
