

HOUSE AMENDMENTS TO HOUSE BILL 2701

- 1 On page 1 of the printed bill, line 3, delete “345.995” and insert “345.325”.
2 Delete lines 5 through 31 and delete pages 2 and 3 and insert:
3 “**SECTION 1.** ORS 345.120 is amended to read:
4 “345.120. (1) On the written complaint of any person, the Higher Education Coordinating Com-
5 mission shall, and on the commission’s own motion may, investigate the actions of any career school
6 or agent, or any person who assumes to act in either capacity within this state.
7 “(2) As a result of the investigation, and in addition to any penalty that may be imposed under
8 ORS 345.992, the commission may [*place a licensee on probation*] **issue a notice for corrective**
9 **action** or may suspend or revoke any license issued under ORS 345.010 to 345.450 when the licensee
10 has:
11 “(a) Obtained a license by misrepresentation.
12 “(b) Violated ORS 345.010 to 345.450 or any applicable rule.
13 “(c) Ceased to engage in the business authorized by the license.
14 “(d) Willfully used or employed any method, act or practice declared unlawful by ORS 646.608.
15 “(3) When notice of suspension or revocation is issued, the licensee shall be notified and, upon
16 request, shall be granted a contested case hearing under ORS 183.310 (2).
17 “(4) A licensee [*placed on probation*] **that is issued a notice for corrective action** must be
18 formally notified by the commission that it has deficiencies that must be corrected within a time
19 specified in the notice.
20 “(5) A licensee whose license is suspended is prohibited from advertising, recruiting or enrolling
21 students but may remain in operation to complete training of students enrolled on the effective date
22 of the suspension.
23 “(6) A licensee whose license has been revoked is not authorized to continue in operation on
24 and after the effective date of the revocation.
25 “**SECTION 2.** ORS 345.030 is amended to read:
26 “345.030. (1) A person may not open, conduct or do business as a career school in this state
27 without obtaining a license under ORS 345.010 to 345.450.
28 “(2) Except as provided in subsection (8) of this section, the Higher Education Coordinating
29 Commission may issue a license to conduct a career school only after the applicant has presented
30 proof satisfactory to the commission that the applicant complies with applicable standards adopted
31 under ORS 345.325 and 670.280. For the purpose of this subsection, ORS 670.280 applies to individ-
32 uals who hold positions of authority or control in the operation of the school and to its faculty
33 members and agents.
34 “(3) A career school licensed in any other state must be licensed in this state before establishing
35 a physical presence in this state such as offices or agents, or both, for the purpose of solicitation

1 of students.

2 “(4) In determining whether to issue a license to a career school, the commission may consider
3 the prior history of the applicant in operating other career schools. The prior history of operating
4 other career schools includes, but is not limited to:

5 “(a) Conduct by the applicant that is cause for [*probation of a licensee*] **a notice of corrective**
6 **action** or for suspension or revocation of a license as provided in ORS 345.120 (2);

7 “(b) Failure to comply with ORS 345.010 to 345.450 or rules adopted under ORS 345.010 to
8 345.450; and

9 “(c) The history of the applicant in operating career schools in other states.

10 “(5) The commission may not issue a license to or renew the license of a career school until the
11 applicant provides all of the following to the commission:

12 “(a) A financial statement, certified true and accurate and signed by the owner of the school;

13 “(b) Proof of compliance with the tuition protection policy established by the commission pur-
14 suant to ORS 345.110; and

15 “(c) Fingerprints of individuals as described in subsection (6) of this section.

16 “(6)(a) Except as provided in paragraph (c) of this subsection, an applicant for an initial issuance
17 of a license or a renewal of a license must provide to the commission the fingerprints of faculty
18 members and agents of the school and individuals who hold positions of authority or control in the
19 operation of the school if the career school will be enrolling or does enroll persons under 18 years
20 of age.

21 “(b) In addition to requirements provided under paragraph (a) of this subsection, the commission
22 may require a career school to provide the fingerprints of any agents of the school who will have
23 contact with persons under 18 years of age on behalf of the career school.

24 “(c) An applicant is not required to provide fingerprints under paragraph (a) or (b) of this sub-
25 section if the commission has conducted a state or nationwide criminal records check on the person
26 within the three years preceding the date of the application.

27 “(d) Fingerprints acquired under this subsection may be used only for the purpose of requesting
28 a state or nationwide criminal records check under ORS 181A.195.

29 “(7) Notwithstanding ORS 345.325 (10), the commission may [*place a school on probation*] **issue**
30 **a notice for corrective action** or deny, suspend or revoke a license if the commission finds that
31 an individual who holds a position of authority or control in the operation of the school was con-
32 victed of a crime listed in ORS 342.143.

33 “(8) The commission may issue a conditional license to a career school that meets the require-
34 ments of subsection (5) of this section but that does not comply with the applicable standards
35 adopted by rule under ORS 345.325. A conditional license issued under this subsection is effective
36 for a period prescribed by the commission, which may not exceed 90 days.

37 “(9)(a) Except as provided in paragraph (b) of this subsection, a career school license is
38 nontransferable. The licensee must give 30 days of notice to the commission when transferring
39 ownership of a career school.

40 “(b) The commission may transfer a career school license or allow the ownership of a career
41 school to transfer with less than 30 days of notice if:

42 “(A) The owner of the school dies, is incapacitated or is incarcerated; or

43 “(B) Other circumstances render the owner unable to operate the career school.

44 “(10) Each career school shall display its license in a prominent place.

45 “**SECTION 3.** ORS 345.325 is amended to read:

1 “345.325. The Higher Education Coordinating Commission shall adopt by rule minimum stan-
2 dards for the licensing of career schools under ORS 345.010 to 345.450 that are reasonably calcu-
3 lated to ensure that:

4 “(1) The quality and content of each course or program of instruction can achieve its stated
5 objective;

6 “(2) The facilities, instructional equipment and materials are sufficient to enable students to
7 achieve the program goals and are adequate for the purposes of the program;

8 “(3) The directors, administrators and instructors are properly qualified;

9 “(4) Prior to an applicant signing an enrollment agreement, the school provides the applicant
10 with a catalog or brochure that includes an accurate description of the program for which the ap-
11 plicant is enrolling, total costs of tuition and fees and other information specified by rule;

12 “(5) Upon satisfactory completion of instruction and training, the student is given appropriate
13 educational credentials;

14 “(6) Adequate records and standard transcripts are maintained;

15 “(7) The career school is maintained and operated in compliance with all applicable ordinances
16 and laws;

17 “(8) The career school is financially sound and capable of fulfilling its commitments to students;

18 “(9) Neither the career school nor its agents engage in advertising, sales, collection, credit or
19 other practices of any type which are unlawful under ORS 646.608;

20 “(10) The directors, administrators, supervisors and instructors of the school are of good repu-
21 tation and character, except that a school shall not be [*placed on probation*] **issued a notice for**
22 **corrective action** or a license shall not be denied, suspended or revoked because a faculty member
23 has been convicted of a crime except as authorized under ORS 670.280;

24 “(11) Any student housing owned, maintained or approved by the career school is appropriate,
25 safe and adequate;

26 “(12) The school has a written placement assistance plan; and

27 “(13) A license application from a new school or an application for approval of a new program
28 from an existing school shall include labor market information that identifies the need for the new
29 school or program.

30 “**SECTION 4. The amendments to ORS 345.030, 345.120 and 345.325 by sections 1 to 3 of**
31 **this 2017 Act apply to any action taken by the Higher Education Coordinating Commission**
32 **with respect to a career school or agent on or after the effective date of this 2017 Act.”.**
