SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies provisions relating to administration of estates.

8 **Be It Enacted by the People of the State of Oregon:**

10 **ORS CHAPTER 111**

11
12 **SECTION 1.** ORS 111.005, as amended by section 1, chapter 42, Oregon Laws 2016, is amended
13 to read:

14 111.005. As used in ORS chapters 111, 112, 113, 114, 115, 116 and 117, unless the context requires
15 otherwise:

16 (1) "Abate" means to reduce a devise on account of the insufficiency of the estate to pay all
17 claims, expenses and devises in full.

18 (2) "Action" includes suits and legal proceedings.

19 (3) "Administration" means any proceeding relating to the estate of a decedent, whether the
20 decedent died testate, intestate or partially intestate.

21 (4) "Advancement" means a gift by a decedent to an heir or devisee with the intent that the gift
22 satisfy in whole or in part the heir's share of an intestate estate or the devisee's share of a testate
23 estate.

24 (5) "Assets" includes real, personal and intangible property.

25 (6) "Claim" includes liabilities of a decedent, whether arising in contract, in tort or otherwise.

26 (7) "Court" or "probate court" means the court in which jurisdiction of probate matters, causes
27 and proceedings is vested as provided in ORS 111.075.

28 (8) "Decedent" means a person who has died.

29 (9)(a) "Descendant" means a person who is descended from a specific ancestor and includes an

1 adopted child and the adopted child's descendants.

2 (b) When used to refer to persons who take by intestate succession, "descendant" does not in-
3 clude a person who is the descendant of a living descendant.

4 (10) "Devise," when used as a noun, means property disposed of by a will.

5 (11) "Devise," when used as a verb, means to dispose of property by a will.

6 (12) "Devisee" means a person designated in a will to receive a devise.

7 (13) "Distributee" means a person entitled to any property of a decedent under the will of the
8 decedent or under intestate succession.

9 (14) "Domicile" means the place of abode of a person, where the person intends to remain and
10 to which, if absent, the person intends to return.

11 (15)(a) "Estate" means the real and personal property of a decedent, as from time to time
12 changed in form by sale, reinvestment, substitutions or otherwise, augmented by any accretions or
13 additions or diminished by any decreases or distributions.

14 **(b) "Estate" includes tangible and intangible personal property of a decedent domiciled
15 in Oregon, wherever the property is situated.**

16 (16) "Funeral" includes the burial or other disposition of the remains of a decedent, any plot or
17 tomb and other necessary incidents to the disposition of the remains, any memorial ceremony or
18 other observance and related expenses.

19 (17) "General devise" means a devise chargeable generally on the estate of a testator so that
20 the devise is not distinguishable from other parts of the estate and does not constitute a specific
21 devise.

22 (18) "Heir" means any person who is or would be entitled under intestate succession to property
23 of a person upon that person's death.

24 (19) "Interested person" includes heirs, devisees, children, spouses, creditors and any others
25 having a property right or claim against the estate of a decedent that may be affected by the pro-
26 ceeding. "Interested person" also includes fiduciaries representing interested persons.

27 (20) "Intestate" means one who dies without leaving a valid will, or the circumstance of dying
28 without leaving a valid will, effectively disposing of all the estate.

29 (21) "Intestate succession" means succession to property of a decedent who dies intestate or
30 partially intestate.

31 (22) "Issue" means a descendant or descendants.

32 (23) "Net estate" means the real and personal property of a decedent, except property used for
33 the support of the surviving spouse and children and for the payment of expenses of administration,
34 funeral expenses, claims and taxes.

35 (24) "Net intestate estate" means any part of the net estate of a decedent not effectively dis-
36 posed of by the will.

37 (25) "Personal property" includes all property other than real property.

38 (26) "Personal representative" includes executor, administrator, administrator with will annexed
39 and administrator de bonis non, but does not include special administrator.

40 (27) "Property" includes both real and personal property.

41 (28) "Real property" includes all legal and equitable interests in land, in fee and for life.

42 (29) "Settlement" includes, as to the estate of a decedent, the full process of administration,
43 distribution and closing.

44 (30) "Specific devise" means a devise of a specific thing or specified part of the estate of a
45 testator that is so described as to be capable of identification. A specific devise is a gift of a part

1 of the estate identified and differentiated from all other parts.

2 (31) "Will" includes codicil and also includes a testamentary instrument that merely appoints
3 [an executor] a **personal representative** or that merely revokes or revives another will.

4 **SECTION 2.** ORS 111.085 is amended to read:

5 111.085. (1) The jurisdiction of the probate court includes, but is not limited to:

6 [(1)] (a) Appointment and qualification of personal representatives.

7 [(2)] (b) Probate and contest of wills.

8 [(3)] (c) Determination of heirship.

9 [(4)] (d) Determination of title to and rights in property claimed by or against personal repre-
10 sentatives, guardians and conservators.

11 [(5)] (e) Administration, settlement and distribution of estates of decedents.

12 [(6)] (f) Construction of wills, whether incident to the administration or distribution of an estate
13 or as a separate proceeding.

14 [(7)] (g) Guardianships and conservatorships, including the appointment and qualification of
15 guardians and conservators and the administration, settlement and closing of guardianships and
16 conservatorships.

17 [(8)] (h) Supervision and disciplining of personal representatives, guardians and conservators.

18 [(9)] (i) Appointment of a successor testamentary trustee where the vacancy occurs prior to, or
19 during the pendency of, the probate proceeding.

20 (2) **The distributees of an estate administered in Oregon are subject to the jurisdiction**
21 **of the courts of Oregon regarding any matter involving the distributees' interests in the es-**
22 **tate. By accepting a distribution from an estate, the distributee submits personally to the**
23 **jurisdiction of the courts of this state regarding any matter involving the estate.**

24 (3) **This section does not preclude other methods of obtaining jurisdiction over a person**
25 **to whom assets are distributed from an estate.**

26 **SECTION 3.** ORS 111.215 is amended to read:

27 111.215. (1) Except as otherwise specifically provided in ORS chapters 111, 112, 113, 114, 115,
28 116 and 117, whenever notice is required to be given of a hearing on any petition or other matter
29 upon which an order **or judgment** is sought, the petitioner or other person filing the matter shall
30 cause notice of the date, time and place of the hearing to be given to each person interested in the
31 subject of the hearing or to the attorney of the person, if the person has appeared by attorney or
32 requested that notice be sent to the attorney of the person, in any one or more of the following ways
33 and within the following times:

34 (a) By mailing a copy [thereof] **of the notice** addressed to the person or the attorney of the
35 person at least 14 days before the date set for the hearing.

36 (b) By delivering a copy [thereof] **of the notice** to the person personally or to the attorney of
37 the person at least five days before the date set for the hearing.

38 (c) If the address of any person is not known or cannot be ascertained with reasonable diligence,
39 by publishing a copy [thereof] **of the notice** once in each of three consecutive weeks in a newspaper
40 of general circulation in the county where the hearing is to be held, the last publication of which
41 shall be at least 10 days before the date set for the hearing.

42 (2) Upon good cause shown the court may change the requirements as to the method or time
43 of giving notice for any hearing. **The court may authorize notice by electronic means under this**
44 **subsection.**

45 (3) Proof of the giving of notice must be made at or before the hearing and filed in the pro-

1 ceeding.

2 **(4) The Department of Human Services and the Oregon Health Authority may adopt rules**
3 **allowing for the department or authority to accept electronic notice in lieu of the notice re-**
4 **quired under subsection (1) of this section.**

8 **SECTION 4.** ORS 113.005, as amended by section 20, chapter 42, Oregon Laws 2016, is amended
9 to read:

10 113.005. (1) If, prior to appointment and qualification of a personal representative, property of
11 a decedent is in danger of loss, injury or deterioration, or disposition of the remains of a decedent
12 is required, the court may appoint a special administrator to take charge of the property or the
13 remains. The petition for appointment [*shall*] **must** state the reasons for special administration and
14 specify the property, so far as known, requiring administration, and the danger to which it is sub-
15 ject.

16 [*(2) The special administrator shall qualify by filing a bond in the amount set by the court, con-*
17 *ditioned upon the special administrator faithfully performing the duties of the trust.*]

18 **(2)(a) Except as provided in section 6 of this 2017 Act, the special administrator may not**
19 **act, and letters may not be issued to the special administrator, until the special adminis-**
20 **trator provides a bond to the clerk of the court. The bond must be for the security and**
21 **benefit of all interested persons and must be conditioned upon the special administrator**
22 **faithfully performing the duties of the position. The bond must be executed by a surety**
23 **qualified under ORCP 82 D to G.**

24 **(b) The amount of the bond set by the court under this subsection must be adequate to**
25 **protect interested persons. In setting the amount of the bond, the court shall consider:**

26 **(A) The nature, liquidity and apparent value of the property subject to administration.**

27 **(B) The anticipated income during administration.**

28 **(C) The probable indebtedness and taxes.**

29 **(3) The court may authorize the special administrator [*may*] to:**

30 **(a) Arrange for and incur expenses for the funeral of the decedent [*in a manner suitable to the***
31 ***condition in life of the decedent*];**

32 **(b) Incur expenses for the protection of [*the*] property of the estate; and**

33 **[*c) Sell perishable property of the estate, whether or not listed in the petition, if necessary to pre-***
34 ***vent loss to the estate.*]**

35 **(c) Administer property of the estate.**

36 **(4) The special administrator [*shall*] may not approve or reject claims of creditors or pay claims**
37 **or expenses of administration or take possession of assets of the estate other than those in danger**
38 **of loss, injury or deterioration pending the appointment of a personal representative.**

39 **(5) Upon the appointment and qualification of a personal representative the powers of the spe-**
40 **cial administrator [*shall*] cease. Within 30 days after the issuance of letters testamentary **or letters****
41 ****of administration** to a personal representative, the special administrator shall make and file an**
42 **account and deliver to the personal representative the assets of the estate in the possession of the**
43 **special administrator. If the personal representative objects to the account of the special adminis-**
44 **trator, the court shall hear the objections, and, whether or not objections are made, shall examine**
45 **the account.**

1 (6) To the extent approved by the court, the compensation of the special administrator and ex-
2 penses properly incurred by the special administrator, including a reasonable fee of the attorney of
3 the special administrator, shall be paid as expenses of administration.

4 **SECTION 5. Section 6 of this 2017 Act is added to and made a part of ORS chapter 113.**

5 **SECTION 6. (1) A special administrator is not required to provide a bond to the court**
6 **under ORS 113.005 (2) if a will provides that no bond is required of the person appointed as**
7 **special administrator, but the court may, for good cause, require a bond notwithstanding any**
8 **provision in a will that no bond is required.**

9 (2) Upon a request by the special administrator, the court may waive the requirement
10 of a bond if:

11 (a) The request states the reasons why the waiver is requested; and

12 (b) The request describes the known creditors of the estate, if the special administrator
13 will administer property of the estate.

14 (3) Upon a request by the special administrator, the court may waive or reduce the re-
15 quirement of a bond if the court orders the special administrator to provide written confir-
16 mation from a financial institution that property of the estate is held by the financial
17 institution subject to withdrawal only on order of the court.

18 **SECTION 7.** ORS 113.035 is amended to read:

19 113.035. Any interested person or *[executor]* **the person nominated as personal representative**
20 named in the will may petition for the appointment of a personal representative and for the probate
21 of a will. The petition *[shall]* **must** include the following information, so far as known:

22 (1) The name, age, domicile, post-office address[,] **and** date and place of death[, *and Social Se-*
23 *curity account number or taxpayer identification number*] of the decedent.

24 (2) Whether the decedent died testate or intestate.

25 (3) The facts relied upon to establish venue.

26 (4) The name and post-office address of the person nominated as personal representative and the
27 facts that show the person is qualified to act.

28 (5) The names, relationship to the decedent and post-office addresses of persons who are or
29 would be the heirs of the decedent upon the death of the decedent intestate, and the ages of any
30 who are minors.

31 (6) A statement that reasonable efforts have been made to identify and locate all heirs of the
32 decedent. If the petitioner knows of any actual or possible omissions from the list of heirs, the pe-
33 tition must include a statement indicating that there are omissions from the information relating to
34 heirs.

35 (7) If the decedent died testate, the names and post-office addresses of the devisees, and the ages
36 of any who are minors. If the will devises property to a person who did not survive the decedent
37 or who is otherwise not entitled to receive the devise, the petition must include a statement ex-
38 plaining why the devise failed. If the petitioner knows of any actual or possible omissions from the
39 list of devisees, the petition must include a statement indicating that there are omissions from the
40 information relating to devisees.

41 (8) The name and post-office address of any person asserting an interest in the estate, or on
42 whose behalf an interest has been asserted, based on a contention that:

43 (a) The will alleged in the petition to be the will of the decedent is ineffective in whole or part;

44 (b) There exists a will that has not been alleged in the petition to be the will of the decedent;

45 or

1 (c) The decedent agreed, promised or represented that the decedent would make or revoke a
2 will or devise, or not revoke a will or devise, or die intestate.

3 (9) The name and post-office address of any person asserting an interest in the estate, or on
4 whose behalf an interest has been asserted, based on a contention that a parent of the decedent
5 willfully deserted the decedent or neglected without just and sufficient cause to provide proper care
6 and maintenance for the decedent, as provided by ORS 112.047.

7 (10) Whether the original of the last will of the decedent is in the possession of the court or
8 accompanies the petition. If the original will is not in the possession of the court or accompanying
9 the petition and an authenticated copy of the will probated in another jurisdiction does not accom-
10 pany the petition, the petition shall also state the contents of the will and indicate that it is lost,
11 destroyed or otherwise unavailable and that it was not revoked.

12 (11) A statement of the extent and nature of assets of the estate, to enable the court to set the
13 amount of bond of the personal representative.

14 **SECTION 8. Section 9 of this 2017 Act is added to and made a part of ORS chapter 113.**

15 **SECTION 9. (1) A petition for the appointment of a personal representative under ORS
16 113.035 may include a request for the compensation of the personal representative to be de-
17 termined by a different method than as provided in ORS 116.173 (3). The petition must set
18 forth specific facts showing that the compensation calculated under ORS 116.173 (3) would
19 be inadequate to compensate the personal representative for the reasonable value of the
20 personal representative's services. The court may grant the request if the court finds that
21 compensation as provided in ORS 116.173 (3) would be inadequate.**

22 **(2) If the petition includes a request for a different method of compensation under this
23 section:**

24 **(a) The petitioner shall give notice and a copy of the petition to the distributees of the
25 estate, the Department of Human Services and the Oregon Health Authority. The notice
26 shall allow 20 days for filing objections to the petition unless the court allows a different
27 time.**

28 **(b) A judgment appointing a personal representative under ORS 113.035 may not be en-
29 tered until the court has held a hearing on the petition including the request or the time for
30 filing objections to the petition has expired without an objection being filed.**

31 **(3) If the court allows the petitioner's request for a different method of compensation
32 under this section, the personal representative may, at any time prior to or at the time of
33 the filing of the final account or the statement in lieu of the final account under ORS 116.083,
34 elect to be compensated as provided in ORS 116.173 (3).**

35 **(4) Failure by the department, the authority or a distributee to object to a request for a
36 different method of compensation under this section does not preclude the department, the
37 authority or a distributee from objecting to the amount of the personal representative's
38 compensation set forth in the final account filed under ORS 116.083 on the basis that the
39 compensation exceeds the reasonable value of the services actually provided by the personal
40 representative.**

41 **SECTION 10. ORS 113.045 is amended to read:**

42 113.045. (1) Upon appointment, a personal representative shall deliver or mail to [*an estate ad-*
43 *ministrator of*] the Department of State Lands [*appointed under ORS 113.235*] a copy of the petition
44 filed under ORS 113.035, and a copy of any last will of the decedent, if the personal representative
45 has not identified and found all heirs and devisees of the decedent. The personal representative shall

1 file proof of the delivery or mailing with the court.

2 (2) If at any time after the appointment of a personal representative it appears that any heir
3 or devisee of the decedent cannot be identified and found, the personal representative shall promptly
4 deliver or mail to [*an estate administrator of*] the Department of State Lands [*appointed under ORS*
5 *113.235*] a notice indicating that an heir or devisee cannot be identified and found. The personal
6 representative shall file proof of the delivery or mailing with the court.

7 (3) This section does not affect the requirements of ORS 113.085 [(2)] (3).

8 **SECTION 11.** ORS 113.055 is amended to read:

9 113.055. (1) Upon [*an ex parte hearing*] **the ex parte review** of a petition for the probate of a
10 will, an affidavit of an attesting witness may be used instead of the personal presence of the witness
11 in court. The witness may give evidence of the execution of the will by attaching the affidavit to
12 the will or to a photographic or other facsimile copy of the will[,] and may identify the signature
13 of the testator and witnesses to the will by use of the will or the copy. The affidavit shall be re-
14 ceived in evidence by the court and have the same weight as to matters contained in the affidavit
15 as if the testimony were given by the witness in open court. The affidavit of the attesting witness
16 may be made at **or after** the time of execution of the will [*or at any time thereafter*].

17 (2) However, upon motion of any person interested in the estate filed within 30 days [*after the*
18 *order admitting the will to probate is made*] **from the date the personal representative first de-**
19 **livers or mails information under ORS 113.145 (1)**, the court may require that the witness making
20 the affidavit be brought before the court. If the witness is outside the reach of a subpoena, the court
21 may order that the deposition of the witness be taken.

22 (3) If the evidence of none of the attesting witnesses is available, the court may allow proof of
23 the will by testimony or other evidence that the signature of the testator or at least one of the
24 witnesses is genuine.

25 (4) In the event of contest of the will or of probate [*thereof*] **of the will** in solemn form, proof
26 of any facts shall be made in the same manner as in an action tried without a jury.

27 **SECTION 12.** ORS 113.075 is amended to read:

28 113.075. (1) Any interested person may contest the probate of the will or the validity of the will
29 or assert an interest in the estate for the reason that:

30 (a) The will alleged in the petition **for probate** to be the will of the decedent is ineffective in
31 whole or part;

32 (b) There exists a will that has not been alleged in the petition to be the will of the decedent;
33 or

34 (c) The decedent agreed, promised or represented that the decedent would make or revoke a
35 will or devise, or not revoke a will or devise, or die intestate.

36 (2) An action described in subsection (1) of this section [*shall*] **must** be commenced by the filing
37 of a petition in the probate proceedings, except that an action described in subsection (1)(c) of this
38 section may be commenced by the filing of a separate action in any court of competent jurisdiction.

39 (3) An action described in subsection (1) of this section [*shall*] **must** be commenced before the
40 later of:

41 (a) Four months after the date of delivery or mailing of the information described in ORS 113.145
42 if that information was required to be delivered or mailed to the person on whose behalf the
43 [*petition*] **action under subsection (1) of this section** is filed; or

44 (b) Four months after the first publication of notice to interested persons if the person on whose
45 behalf the [*petition*] **action under subsection (1) of this section** is filed was not required to be

1 named in the petition **for probate** as an interested person.

2 **(4)(a) A person who commences an action under subsection (1) of this section shall give**
3 **notice of the action to heirs and devisees identified in the petition for probate or amended**
4 **petition for probate, and to the Department of State Lands if the personal representative has**
5 **delivered or mailed information to the department under ORS 113.045.**

6 **(b) If any devisee under the contested will is a charitable trust as described in ORS**
7 **130.170, a public benefit corporation as defined in ORS 65.001 or a religious organization, a**
8 **person who commences an action under subsection (1) of this section shall give notice to the**
9 **Attorney General of the action.**

10 [(4)] (5) A cause of action described in subsection (1)(c) of this section [shall] **may** not be pre-
11 sented as a claim under ORS chapter 115.

12 **SECTION 13.** ORS 113.085 is amended to read:

13 113.085. (1) Except as provided in subsection [(2)] (3) of this section, upon the filing of the peti-
14 tion **under ORS 113.035**, if there is no will or **if** there is a will and it has been proved, the court
15 shall appoint a qualified person [it] **the court** finds suitable as personal representative, giving
16 preference in the following order:

17 (a) The [executor] **personal representative** named in the will.

18 (b) **If the surviving spouse of the decedent is a distributee of the estate**, the surviving
19 spouse of the decedent or the nominee of the surviving spouse of the decedent.

20 [(c) *The nearest of kin of the decedent or the nominee of the nearest of kin of the decedent.*]

21 (c) **If the person is a distributee of the estate, a person who would be entitled to property**
22 **of the decedent under intestate succession.**

23 (d) **Any other distributee of the estate.**

24 [(d)] (e) The Director of Human Services or the Director of the Oregon Health Authority, or an
25 attorney approved under ORS 113.086, if the decedent received public assistance as defined in ORS
26 411.010, received medical assistance as defined in ORS 414.025 or received care at an institution
27 described in ORS 179.321 (1) and it appears that the assistance or the cost of care may be recovered
28 from the estate of the decedent.

29 [(e)] (f) The Department of Veterans' Affairs, if the decedent was a protected person under ORS
30 406.050 (10)[,] and the department has joined in the petition for such appointment.

31 [(f)] (g) Any other person.

32 **(2) Before the court appoints a personal representative under subsection (1)(b) to (g) of**
33 **this section, the court may require the petitioner to make a reasonable attempt to notify**
34 **persons of higher priority than the proposed personal representative under subsection (1)(b)**
35 **to (g) of this section.**

36 [(2)] (3) Except as provided in subsection [(3)] (4) of this section, the court shall appoint the
37 Department of State Lands as personal representative if it appears that the decedent died wholly
38 intestate and without known heirs. The Attorney General shall represent the Department of State
39 Lands in the administration of the estate. Any funds received by the Department of State Lands in
40 the capacity of personal representative may be deposited in accounts, separate and distinct from the
41 General Fund, established [with] **in** the State [Treasurer] **Treasury**. Interest earned by such ac-
42 count shall be credited to that account.

43 [(3)] (4) The court may appoint a person other than the Department of State Lands to administer
44 the estate of a decedent who died wholly intestate and without known heirs if the person filing a
45 petition under ORS 113.035 attaches written authorization from [an estate administrator of] the De-

1 partment of State Lands [*appointed under ORS 113.235*] approving the filing of the petition by the
2 person. Except as provided by rule adopted by the Director of the Department of State Lands, [*an*
3 *estate administrator*] **the department** may consent to the appointment of another person to act as
4 personal representative only if it appears after investigation that the estate is insolvent.

5 **SECTION 14.** ORS 113.095 is amended to read:

6 113.095. A person is not qualified to act as personal representative if the person is:

7 [(1) *An incompetent.*]

8 **(1) Incapacitated or financially incapable, as those terms are defined in ORS 125.005.**

9 **(2)** A minor.

10 **(3)** A person suspended for misconduct or disbarred from the practice of law, during the period
11 of suspension or disbarment.

12 **(4)** A person who has resigned from the Oregon State Bar when charges of professional mis-
13 conduct are under investigation or when disciplinary proceedings are pending against the person,
14 until the person is reinstated.

15 **(5)** A licensed funeral service practitioner unless the decedent was:

16 **(a)** A relative of the licensed funeral service practitioner; or

17 **(b)** A licensed funeral service practitioner who was a partner, employee or employer in the
18 practice of the licensed funeral service practitioner who is petitioning for appointment as personal
19 representative.

20 **SECTION 15.** ORS 113.105 is amended to read:

21 113.105. [(1) *Unless a testator provides in a will that no bond shall be required of the executor of*
22 *the estate, or unless the personal representative is the sole heir or devisee or is the Department of State*
