

HOUSE AMENDMENTS TO HOUSE BILL 3139

By COMMITTEE ON ECONOMIC DEVELOPMENT AND TRADE

1 On page 1 of the printed bill, line 2, after the semicolon delete the rest of the line and insert
2 “creating new provisions; and amending ORS 359.010, 359.025, 359.030, 359.050, 359.135 and
3 359.142.”.

4 Delete lines 4 through 31.

5 On page 2, delete lines 1 through 19 and insert:

6 “**SECTION 1.** ORS 359.010 is amended to read:

7 “359.010. As used in ORS 359.010 to 359.137, unless the context requires otherwise:

8 “[*(1)* ‘Administrator’ means the Administrator of the Arts Program of the Oregon Business De-
9 velopment Department.]

10 “[*(2)*] (1) ‘Arts’ includes, but is not limited to[,];

11 “(a) Instrumental and vocal music;

12 “(b) Dance, drama[,] **and** folk art[,];

13 “(c) Creative writing and poetry;

14 “(d) Architecture and landscaping design and the fields allied to them;

15 “(e) **Museum-related activities including, but not limited to:**

16 “(A) **Exhibitions;**

17 “(B) **Curation and maintenance of art work collections; and**

18 “(C) **Education relating to works of art, artists and art history;**

19 “(f) Painting, sculpture[,] **and** photography;

20 “(g) Graphic and craft arts;

21 “(h) Industrial design;

22 “(i) Costume and fashion design;

23 “(j) Motion pictures, television[,] **and** radio;

24 “(k) Tape and sound recording;

25 “(L) The history, criticism, theory and practice of the arts; and

26 “(m) The [*arts related to the*] presentation, performance, execution and exhibition of [*such*] art
27 forms **described in this subsection.**

28 “[*(3)*] (2) ‘Association’ means a nonprofit, private, incorporated or unincorporated institution,
29 foundation, museum, organization, society or group, whether local, state, regional or national, that
30 is operating, or doing business, in Oregon.

31 “[*(4)* ‘Commission’ means the Oregon Arts Commission.]

32 “[*(5)* ‘Department’ means the Oregon Business Development Department.]

33 “[*(6)* ‘Director’ means the Director of the Oregon Business Development Department.]

34 “[*(7)* ‘Program’ means the Arts Program of the Oregon Business Development Department.]

35 “[*(8)*] (3) ‘Local agencies’ includes cities, counties and other public corporations and their offi-

1 cers, boards and commissions.

2 “[9] ‘Public agencies’ means state agencies and local agencies.]

3 “[10] (4) ‘Private corporation’ means a corporation organized for profit and authorized to do
4 business in this state.

5 “(5) ‘Public agencies’ means state agencies and local agencies.

6 “[11] (6) ‘State agencies’ includes state officers, departments, boards and commissions.

7 “**SECTION 2.** ORS 359.025 is amended to read:

8 “359.025. (1) The Oregon Arts Commission shall perform the following duties:

9 “(a) Serve as a body to advise governmental bodies and agencies and private persons on the
10 development and implementation of state policies and programs relating to the arts, heritage, his-
11 toric preservation, humanities and culture, and to assist in the coordination of these activities.

12 “(b) Advise the Governor, the Director of the Oregon Business Development Department and the
13 Oregon Business Development Commission on all matters relating to the arts that pertain to the
14 powers, duties and functions of the Arts Program of the Oregon Business Development Department.

15 “(c) Develop a recommended biennial budget for the operation of the Arts Program that will be
16 submitted to the director and the Governor.

17 “(d) Seek and receive the views of all levels of government and the private sector with respect
18 to state programs and policies for the promotion and assistance of the arts.

19 “(e) Prepare and submit suggested administrative rules to the director that the Oregon Arts
20 Commission determines are necessary for the operation of the programs of the Arts Program.

21 “(f) Establish [*policy*] **policies** and procedures for grant programs administered by the Arts
22 Program **consistent with rules adopted under ORS 359.142.**

23 “(2)(a) In addition to the duties imposed by subsection (1) of this section, the Oregon Arts
24 Commission shall establish policies and provide management and operational staff support for the
25 Trust for Cultural Development Board.

26 “(b) Notwithstanding paragraph (a) of this subsection, the Trust for Cultural Development Board
27 shall make any decisions relating to the investment and disbursement of moneys in the Trust for
28 Cultural Development Account.

29 “**SECTION 3.** ORS 359.135 is amended to read:

30 “359.135. (1) The Director of the Oregon Business Development Department, upon consultation
31 with and the approval of the Oregon Arts Commission, shall appoint [*an*] **the** Administrator of the
32 Arts Program who shall serve at the pleasure of the director.

33 “(2) The administrator shall receive such salary as may be provided by law or as fixed by the
34 director.

35 “(3) The administrator shall be the administrative head of the program.

36 “(4) The administrator may suggest rules to the director for the government of the program, the
37 conduct of its employees and the assignment and performance of its business and the custody, use
38 and preservation of its records, papers and property.

39 “**SECTION 4.** ORS 359.050 is amended to read:

40 “359.050. (1) In performing its duties, the Arts Program of the Oregon Business Development
41 Department, within the limits of available funds, may:

42 “(a) Conduct hearings and conferences to develop facts, to explain programs and activities, and
43 to obtain advice.

44 “(b) Enter into agreements with other public agencies and with associations and individuals for
45 services that will assist the Oregon Arts Commission or the Trust for Cultural Development Board.

1 “(c) Enter into agreements with other public agencies of Oregon or with agencies of other states
2 or the federal government, and with private corporations, associations and individuals in Oregon or
3 other states for cooperative endeavors which further the objectives and programs of the commission.

4 “(d) Make grants to local agencies, to associations or to individuals for the development and
5 conservation of programs in the arts, such grants to be made in accordance with policies and pro-
6 cedures adopted by the commission **under ORS 359.025.**

7 “(2) In carrying out the purposes of ORS 359.010 to 359.137, the Arts Program, in addition to the
8 other powers granted:

9 “(a) Shall as needed appoint committees, consultants, artists and other persons expert in sub-
10 jects of concern to the program to advise and assist the commission.

11 “(b) May obtain from any state agency necessary assistance and data.

12 “(c) May perform other acts necessary to carry out its duties.

13 “**SECTION 5. ORS 359.142 is added to and made a part of ORS 359.010 to 359.137.**

14 “**SECTION 6.** ORS 359.142 is amended to read:

15 “359.142. (1) The Director of the Oregon Business Development Department, in accordance with
16 ORS chapter 183, may adopt such rules for the operation of the Arts Program as the director de-
17 termines necessary or convenient for the program to perform its duties and functions.

18 “(2) **The director shall adopt rules for grant programs administered by the Arts Program,**
19 **including rules that:**

20 “(a) **Ensure that the criteria used to determine eligibility for grant awards are designed**
21 **to take into consideration the regional differences in public access to, or in opportunities for**
22 **engagement in, arts and cultural development in this state; and**

23 “(b) **Promote investment in communities where opportunities for engagement in arts and**
24 **cultural development is limited.”.**

25 In line 20, delete “3” and insert “7”.
