SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires state agencies, departments and political subdivisions to grant to persons who are blind priority to establish and operate vending facilities in public buildings **and preference to operate cafeterias in public buildings and vending facilities in community colleges**. Clarifies that state agencies, departments and political subdivisions shall procure certain services from Commission for the Blind. Requires commission to collect percentage of net proceeds earned by vending facility and use moneys collected for specified purposes. Allows vendor who is blind to enter into agreement with subcontractor, approved by commission, to operate vending facility. Requires commission to submit annual report to interim committees of Legislative Assembly.

Requires commission to decrease percentage of net proceeds collected if vending facility offers certain vending items or employs person who is blind, person with disability or veteran. Sunsets December 31, 2019.

Takes effect on 91st day following adjournment sine die.

2 Relating to persons who are blind; creating new provisions; amending ORS 293.701, 346.290, 346.510,
3 346.520, 346.530, 346.540, 346.550 and 346.560; repealing ORS 346.210 and 346.220; and prescribing
4 an effective date.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1. Sections 2 to 8 of this 2017 Act are added to and made a part of ORS 346.510**
7 **to 346.570.**

8 **SECTION 2. (1) The Commission for the Blind shall establish in the State Treasury a fund**
9 **from the net proceeds of the operation of vending facilities. Moneys deposited into the fund,**
10 **including the interest earned, shall be credited to a special checking account, separate and**
11 **distinct from the General Fund. Disbursement from the account may be made by check**
12 **signed by the person designated by the commission. Interest earned by the account shall be**
13 **credited to the account.**

14 **(2) Moneys in the fund shall be used for the purposes of, and are continuously appropri-**
15 **ated to the commission for:**

16 **(a) Maintaining and replacing equipment;**

17 **(b) Purchasing new equipment;**

18 **(c) Management services, including but not limited to management training services;**

19 **(d) Ensuring a fair minimum of return to vending facility managers; and**

20 **(e) Retirement or pension funds, health insurance contributions and, if determined by a**
21 **vote of vending facility managers, paid sick leave and vacation time.**

22 **(3) The commission shall provide to the Governor and to vending facility managers**

1 quarterly reports of the account established under this section.

2 **SECTION 3.** (1) The Commission for the Blind shall collect a percentage of net proceeds
3 earned by a vending facility. The moneys collected under this section shall be deposited into
4 the fund established under section 2 of this 2017 Act.

5 (2) The commission shall determine by rule the standard percentage of net proceeds to
6 be collected under this section. The commission shall provide in an agreement with a vending
7 facility manager the percentage of net proceeds that the commission will collect from the
8 vending facility manager under this section. The commission shall reduce, but not below a
9 percentage determined by the commission by rule, the percentage collected by the following
10 amounts:

11 (a)(A) Four percentage points if the vending facility offers exclusively healthy vending
12 items or local vending items;

13 (B) Three percentage points if at least 75 percent but less than 100 percent of the offer-
14 ings at the vending facility are healthy vending items or local vending items; or

15 (C) Two percentage points if at least 50 percent but less than 75 percent of the offerings
16 at the vending facility are healthy vending items or local vending items;

17 (b) Two percentage points if the vending facility employs at least one person who is blind,
18 in addition to the vending facility manager;

19 (c) One percentage point for each person who is blind and is employed by the vending
20 facility in addition to the persons described in paragraph (b) of this subsection;

21 (d) One percentage point if the vending facility employs at least one person with a disa-
22 bility, as defined in ORS 174.107, or who is a veteran, as defined in ORS 408.225, in addition
23 to the vending facility manager; and

24 (e) One-half of one percentage point for each person with a disability or veteran employed
25 by the vending facility in addition to the persons described in paragraph (d) of this sub-
26 section.

27 **SECTION 4.** Section 3 of this 2017 Act is amended to read:

28 **Sec. 3.** (1) The Commission for the Blind shall collect a percentage of net proceeds earned by
29 a vending facility. The moneys collected under this section shall be deposited into the fund estab-
30 lished under section 2 of this 2017 Act.

31 (2) The commission shall determine by rule, **and shall state in an agreement with a vending**
32 **facility manager,** the [standard] percentage of net proceeds to be collected under this section.
33 [The commission shall provide in an agreement with a vending facility manager the percentage of net
34 proceeds that the commission will collect from the vending facility manager under this section. The
35 commission shall reduce, but not below a percentage determined by the commission by rule, the per-
36 centage collected by the following amounts:]

37 [(a)(A) Four percentage points if the vending facility offers exclusively healthy vending items or
38 local vending items;]

39 [(B) Three percentage points if at least 75 percent but less than 100 percent of the offerings at the
40 vending facility are healthy vending items or local vending items; or]

41 [(C) Two percentage points if at least 50 percent but less than 75 percent of the offerings at the
42 vending facility are healthy vending items or local vending items;]

43 [(b) Two percentage points if the vending facility employs at least one person who is blind, in ad-
44 dition to the vending facility manager;]

45 [(c) One percentage point for each person who is blind and is employed by the vending facility in

1 addition to the persons described in paragraph (b) of this subsection;]

2 [(d) One percentage point if the vending facility employs at least one person with a disability, as
3 defined in ORS 174.107, or who is a veteran, as defined in ORS 408.225, in addition to the vending
4 facility manager; and]

5 [(e) One-half of one percentage point for each person with a disability or veteran employed by the
6 vending facility in addition to the persons described in paragraph (d) of this subsection.]

7 **SECTION 5. (1) The Commission for the Blind shall adopt by rule a vending facility
8 manager statement of full-time employment with which a vending facility manager shall
9 comply. The statement must describe the responsibilities of a vending facility manager, in-
10 cluding, but not limited to, responsibilities regarding:**

11 (a) Weekly contact requirements with employees or subcontractors of the manager;

12 (b) Vending facility inspections; and

13 (c) The development and maintenance of work logs.

14 (2) The commission shall include the active participation, as described in section 8 of this
15 2017 Act, of the commission's business enterprise consumer committee, in developing the
16 statement described in this section.

17 **SECTION 6. (1) With written approval from the Commission for the Blind, a vending fa-
18 cility manager may enter into an agreement with a subcontractor included on the list of
19 approved subcontractors described in subsection (4) of this section in order to enable the
20 manager to operate the vending facility.**

21 (2) In determining whether to approve an agreement with a subcontractor, the commis-
22 sion shall consider:

23 (a) The quality of service that the vending facility manager and subcontractor are able
24 to provide; and

25 (b) Any product storage requirements.

26 (3) The commission may provide in an agreement with a vending facility manager that
27 the commission may increase the percentage of net proceeds collected under section 3 of this
28 2017 Act from a vending facility manager who enters into an agreement with a subcontractor
29 under this section.

30 (4)(a) The commission shall establish a list of approved subcontractors with which a
31 vending facility manager may enter into an agreement.

32 (b) The business enterprise consumer committee shall actively participate in developing
33 the criteria for approval of subcontractors.

34 (c) The commission shall consult with the Department of Administrative Services in es-
35 tablishing the list.

36 (d) The commission may, through a procurement process with the department, revise the
37 list as necessary.

38 (e) The commission may, in approving subcontractors, give preference to subcontractors
39 that provide healthy vending items or local vending items and that employ persons with
40 disabilities, as defined in ORS 174.107, and veterans, as defined in ORS 408.225.

41 (f) An agreement with an approved subcontractor is subject to ORS chapter 279A and
42 ORS chapter 279B.

43 (5) The commission may determine by rule the services or products that a subcontractor
44 may provide and the extent to which a subcontractor may perform the duties of a vending
45 facility manager, consistent with the vending facility manager statement of full-time em-

1 ployment described in section 5 of this 2017 Act.

2 (6)(a) A vending facility manager who enters into an agreement with a subcontractor
3 under this section is solely responsible for fulfilling the requirements of the vending facility
4 manager statement described in section 5 of this 2017 Act and for meeting any obligations
5 arising from agreements into which the vending facility manager has entered for the purpose
6 of managing the vending facility. Unless the commission gives written approval, an agree-
7 ment between a vending facility manager and a subcontractor may not include any provision
8 that imposes liability on the commission or that obligates the commission to the subcon-
9 tractor.

10 (b) The commission may not be held liable for claims of any nature, including claims for
11 injunctive or declaratory relief, that arise out of any agreement or subcontract between a
12 vending facility manager and a subcontractor.

13 (7) The commission, with the active participation of the business enterprise consumer
14 committee, may adopt rules relating to the assignment of a vending facility manager to
15 manage a vending facility.

16 SECTION 7. The surviving spouse or domestic partner of a vending facility manager who
17 is deceased or who becomes incapacitated by a physical or mental illness may continue to
18 operate the vending facility formerly operated by the original vending facility manager for
19 up to six months after the date of death or incapacitation, or until the date on which the
20 operating agreement expires, whichever is sooner, for the purpose of winding down the op-
21 erations of the vending facility.

22 SECTION 8. (1) The Commission for the Blind shall ensure the active participation of the
23 commission's business enterprise consumer committee in the commission's major adminis-
24 trative, policy and program development decisions that impact the commission's business
25 enterprise program.

26 (2) The commission shall provide relevant data and information to the committee in a
27 timely manner in order to effectuate the committee's active participation.

28 (3) The commission has final authority and responsibility for the administration and op-
29 eration of the business enterprise program.

30 (4) If the commission does not follow a recommendation of the committee regarding a
31 matter on which the committee actively participates, the commission shall provide to the
32 committee a written explanation as to the reason the committee's recommendation was not
33 followed.

34 SECTION 9. (1) The Commission for the Blind may, in the discretion of the commission
35 or if requested by a vending facility manager licensed under ORS 346.510 to 346.570, aid per-
36 sons with visual impairments by supplying to a person with a visual impairment materials,
37 equipment or machinery, or by allowing the manager to subcontract with a third party to
38 obtain materials, equipment or machinery, in order to enable the operation of a vending fa-
39 cility.

40 (2) The commission may transfer to the person with a visual impairment ownership of
41 any materials, equipment or machinery owned by the commission and supplied to the person.

42 SECTION 10. (1) As used in this section:

43 (a) "Political subdivision" has the meaning given that term in ORS 346.510.

44 (b) "Vending facility" has the meaning given that term in ORS 346.510.

45 (2) This state shall grant to persons who are blind a:

1 (a) Priority to establish and operate vending facilities, other than cafeterias and in com-
2 munity colleges, in public buildings in this state.

3 (b) Preference to operate cafeterias, and vending facilities in community colleges, in
4 public buildings in this state.

5 (3) If a state agency, department or political subdivision constructs a new public building
6 or facility, modifies an existing public building or facility, enters into or modifies a contract
7 for, or otherwise seeks to procure, products or services that are customarily provided by the
8 business enterprise program of the Commission for the Blind, including the operation of
9 vending facilities, the agency, department or political subdivision complies with:

10 (a) Subsection (2)(a) of this section if the agency, department or political subdivision:

11 (A) Notifies the commission of the intended action and allows the commission to deter-
12 mine whether a vending facility manager licensed under ORS 346.510 to 346.570 is able to
13 provide the product or service;

14 (B) Offers to the commission a right of first refusal;

15 (C) Does not charge the commission or vending facility manager any amount prohibited
16 under ORS 346.520 (2); and

17 (D) Procures the vending service from the commission if the service:

18 (i) Is offered by the commission or by persons with visual impairments under the direc-
19 tion and supervision of the commission; and

20 (ii) Meets the requirements of the agency, department or political subdivision for quality
21 and quantity of food stuffs and beverages available through the vending facility.

22 (b) Subsection (2)(b) of this section if the agency, department or political subdivision:

23 (A) Notifies the commission of the intended action and allows the commission to deter-
24 mine whether a vending facility manager licensed under ORS 346.510 to 346.570 is able to
25 provide the product or service; and

26 (B) Procures the vending service from the commission if the service:

27 (i) Is offered by the commission or by persons with visual impairments under the direc-
28 tion and supervision of the commission;

29 (ii) Meets the requirements of the agency, department or political subdivision for quality
30 and quantity of food stuffs and beverages available through the vending facility; and

31 (iii) Is offered in a bid that is equal to any other bids submitted.

32 **SECTION 11.** ORS 346.290 is amended to read:

33 346.290. (1) There is established in the General Fund of the State Treasury an account to be
34 known as the Commission for the Blind Account. Except for funds made available to the Commission
35 for the Blind under ORS 346.270 or deposited pursuant to [ORS 346.540] **section 2 of this 2017**
36 **Act**, all moneys received by the commission for promoting the welfare of persons with visual
37 impairments shall be paid into the State Treasury and credited to the Commission for the Blind
38 Account.

39 (2) All moneys in the Commission for the Blind Account are continuously appropriated to the
40 commission for use by the commission for the respective purposes authorized by law.

41 (3) The commission shall keep a record of all moneys deposited in the Commission for the Blind
42 Account. The record shall indicate by separate cumulative accounts the source from which the
43 moneys are derived and the individual activity or program against which each withdrawal is
44 charged.

45 **SECTION 12.** ORS 346.510 is amended to read:

1 346.510. As used in ORS 346.510 to 346.570[, *the term*]:

2 (1) **“Cafeteria” means a food-dispensing facility:**

3 (a) **That can provide a variety of prepared foods and beverages;**

4 (b) **Where a patron may move through a self-service line;**

5 (c) **That may employ some servers to wait on patrons; and**

6 (d) **That provides seating suitable for patrons to consume meals.**

7 (2) **“Healthy vending item” and “local vending item” have the meanings given those terms**
8 **by rules adopted by the Commission for the Blind in consultation with the Public Health Di-**
9 **rector and the business enterprise consumer committee.**

10 [(1) *“Operator” means the individual person who is blind and who is responsible for the day-to-day*
11 *conduct of the vending facility operation.*]

12 [(2)] (3) **“Person who is blind” means a person [having] who has not more than 20/200 visual**
13 **acuity in the better eye with best correction or whose visual acuity, if better than 20/200, is ac-**
14 **companied by a limit to the field of vision to such a degree that its widest diameter subtends an**
15 **angle of no greater than 20 degrees[. *Such blindness shall be*] and whose blindness is certified by**
16 **a licensed physician who specializes in diseases of the eye.**

17 (4) **“Political subdivision” means a local government as defined in ORS 174.116, a**
18 **municipality, town or village of this state.**

19 [(3)] (5) **“Public building” or “property” means [any] a building, land or other real property, or**
20 **a portion of a building, land or other real property, that is owned, leased, managed or occupied**
21 **by [any] a department or an agency of the State of Oregon or [any of its political subdivisions] by**
22 **a political subdivision, except for a public elementary [and] school, a secondary [schools] school,**
23 **a public university listed in ORS 352.002 or a public corporation created pursuant to ORS**
24 **353.020.**

25 [(4)] (6) **“Vending facility” means:**

26 (a) [*Such*] **Shelters, counters, shelving, display and wall cases, refrigerating apparatus and other**
27 **appropriate auxiliary equipment [as] that are necessary or customarily used for the vending of [such**
28 **articles as may be] articles, including an established mix of healthy vending items approved by**
29 **the Commission for the Blind and the agency [having care, custody and control of the building or**
30 **property in or on which], department or political subdivision charged with maintaining the**
31 **public building or property where the vending facility is located;**

32 (b) **Manual or coin-operated vending machines or similar devices for vending [such] articles,**
33 **including machines or devices that accept electronic payment; or**

34 (c) **Cafeterias or snack bars for the dispensing of food stuffs and beverages.**

35 (7) **“Vending facility manager” means a person who is:**

36 (a) **Blind;**

37 (b) **Responsible for the day-to-day conduct of the vending facility operation; and**

38 (c) **Licensed under ORS 346.510 to 346.570.**

39 **SECTION 13.** ORS 346.520 is amended to read:

40 346.520. (1) For [*the*] purposes of providing persons who are blind with remunerative employ-
41 ment, enlarging the economic opportunities of [*those*] persons **who are blind** and stimulating [*them*]
42 **persons who are blind** to greater efforts to make themselves self-supporting with independent
43 livelihoods, persons who are blind and who are licensed under [*the provisions of*] ORS 346.510 to
44 346.570 by the Commission for the Blind[, *as set forth in ORS 346.510 to 346.570, shall operate*] **have**
45 **priority in managing** vending facilities in or on any public buildings or properties where, in the

1 discretion of the *[head of the department or agency]* **agency, department or political subdivision**
2 in charge of the maintenance of *[such]* **the public** buildings or properties, *[such]* vending facilities
3 may properly and satisfactorily operate.

4 (2) Notwithstanding ORS 276.385, the *[department or agency in charge of the maintenance of]*

20 (c) Consumer and Business Services Fund referred to in ORS 705.145;

21 (d) Employment Department Special Administrative Fund referred to in ORS 657.822;

22 (e) Insurance Fund referred to in ORS 278.425;

23 (f) Funds under the control and administration of the Department of State Lands;

24 (g) Oregon Student Assistance Fund referred to in ORS 348.570;

25 (h) Moneys made available to the Commission for the Blind under ORS 346.270 and *[346.540]*
26 **section 2 of this 2017 Act** or rules adopted thereunder;

27 (i) Forest Development Revenue Bond Fund referred to in ORS 530.147 and State Forestry
28 General Obligation Bond Fund referred to in ORS 530.280;

29 (j) Oregon War Veterans' Fund referred to in ORS 407.495;

30 (k) Oregon War Veterans' Bond Sinking Account referred to in ORS 407.515;

31 (L) World War II Veterans' Compensation Fund;

32 (m) World War II Veterans' Bond Sinking Fund;

33 (n) Funds in the hands of the State Treasurer that are not required to meet current demands
34 and that are invested in the Oregon Short Term Fund established under ORS 293.728 or in another
35 commingled investment vehicle;

36 (o) State funds that are not subject to the control and administration of officers or bodies spe-
37 cifically designated by law;

38 (p) Funds derived from the sale of state bonds;

39 (q) Social Security Revolving Account referred to in ORS 237.490;

40 (r) Public University Fund established by ORS 352.450;

41 (s) Local Government Employer Benefit Trust Fund referred to in ORS 657.513;

42 (t) Elderly and Disabled Special Transportation Fund established by ORS 391.800;

43 (u) Education Stability Fund established by ORS 348.696;

44 (v) Deferred Compensation Fund established under ORS 243.411;

45 (w) Trust for Cultural Development Account established under ORS 359.405; and

1 (x) The State Library Donation Fund and the Talking Book and Braille Library Endowment
2 Fund subaccount established under ORS 357.195.

3 (3) "Investment officer" means the State Treasurer in the capacity as investment officer for the
4 council.

5 **SECTION 19.** (1) The Commission for the Blind shall provide in any agreement with a
6 vending facility manager that the commission shall increase the percentage of net proceeds
7 collected under section 3 of this 2017 Act by four percent if a vending facility manager li-
8 censed under ORS 346.510 to 346.570 does not operate in compliance with the requirements
9 of the vending facility manager statement described in section 5 of this 2017 Act.

10 (2) A vending facility manager who is party to an agreement for the operation of a
11 vending facility that is in effect on or before the effective date of this 2017 Act is not subject
12 to sections 5 and 6 of this 2017 Act and may continue to operate pursuant to the agreement
13 until December 31, 2019.

14 **SECTION 20.** Section 19 of this 2017 Act is repealed on December 31, 2019.

15 **SECTION 21.** The requirements of sections 5 and 6 of this 2017 Act and the amendments
16 to ORS 346.530 by section 14 of this 2017 Act apply to agreements entered into on or after
17 January 1, 2018.

18 **SECTION 22.** Not later than November 15, 2017, the Commission for the Blind shall adopt
19 the rules required under sections 3, 5 and 6 of this 2017 Act and ORS 346.510 and 346.540 by
20 sections 12 and 15 of this 2017 Act, and may amend the rules thereafter.

21 **SECTION 23.** ORS 346.210 and 346.220 are repealed.

22 **SECTION 24.** (1) Sections 2, 3, 5 to 8 and 19 of this 2017 Act and the amendments to ORS
23 293.701, 346.290, 346.510, 346.520, 346.530, 346.540, 346.550 and 346.560 by sections 11 to 18 of this
24 2017 Act become operative on January 1, 2018.

25 (2) The Commission for the Blind may take any action before the operative date specified
26 in subsection (1) of this section that is necessary to enable the commission to exercise, on
27 and after the operative date specified in subsection (1) of this section, all of the duties,
28 functions and powers conferred on the commission by sections 2, 3, 5 to 8 and 19 of this 2017
29 Act and the amendments to ORS 293.701, 346.290, 346.510, 346.520, 346.530, 346.540, 346.550 and
30 346.560 by sections 11 to 18 of this 2017 Act.

31 **SECTION 25.** The amendments to section 3 of this 2017 Act by section 4 of this 2017 Act
32 become operative on January 1, 2020.

33 **SECTION 26.** This 2017 Act takes effect on the 91st day after the date on which the 2017
34 regular session of the Seventy-ninth Legislative Assembly adjourns sine die.

35
