- On page 2, delete lines 1 and 2 and insert:
- 4 "(a) The State Board of Psychologist Examiners shall appoint:
- 5 "(A) Three licensed psychologists, one of whom is a member of the State Board of Psychologist 6 Examiners and one of whom has completed a clinical residency program; and
- 7 "(B) One member of the public who is a consumer of the services provided by a licensed psy-8 chologist.
  - "(b) The Oregon Medical Board shall appoint four prescribing physicians, at least one of whom is a psychiatrist, one of whom practices as a primary care physician and one of whom has expertise in the treatment of children.
- "(c) The State Board of Pharmacy shall appoint one pharmacist licensed under ORS chapter 689 who has expertise in psychotropic medications.".
  - Delete lines 9 through 40 and insert:
  - "(3) The members of the committee shall elect one of the licensed psychologists appointed under subsection (1)(a) of this section as the chairperson of the committee.
    - "(4) The committee shall:
  - "(a) Review and make recommendations to the State Board of Psychologist Examiners on clinical residency programs proposed by applicants seeking a conditional certificate of prescriptive authority;
  - "(b) Review and make recommendations to the State Board of Psychologist Examiners on applications submitted for certificates of prescriptive authority;
  - "(c) Develop and make recommendations to the State Board of Psychologist Examiners regarding the formulary and make recommendations for annual revisions of the formulary;
    - "(d) Develop and make recommendations to the State Board of Psychologist Examiners regarding standards, examinations and continuing education for prescribing psychologists; and
  - "(e) Report to the State Board of Psychologist Examiners regarding the use of prescriptive authority by prescribing psychologists.
  - "(5) A majority of the members of the committee constitutes a quorum for the transaction of business.
- 31 "(6) Official action by the committee requires the approval of a majority of the members of the 32 committee.
  - "(7) The committee may seek the assistance of a neutral third party in resolving disagreements among the committee members and facilitating the collaborative process.
    - "(8) The committee shall meet at times and places specified by the call of the chairperson or a

- 1 majority of the members of the committee.
- 2 "(9) The committee may adopt rules necessary for the operation of the committee.
- 3 "(10) The State Board of Psychologist Examiners shall provide staff support to the committee.
- "(11) Members of the committee are not entitled to compensation, but may be reimbursed from funds available to the State Board of Psychologist Examiners for actual and necessary travel and other expenses incurred by committee members in the performance of their official duties in the manner and amount provided in ORS 292.495.".

- 9 On page 4, line 7, delete "two" and insert "12".
- On page 6, line 38, delete "Two" and insert "Three".
- In line 39, delete "Two" and insert "Three".
