SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Defines "housing with services project" and requires project to register with Department of Human Services [*and meet certain requirements. Subjects projects to oversight by Long Term Care Ombudsman*]. **Provides exceptions to registration requirement.**

Directs Department of Human Services to provide information to housing with services projects and collaborate with Housing and Community Services Department and federal Department of Housing and Urban Development to collect certain data.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to housing with services projects; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) As used in this section:**

5 (a) "Coordinate" means to provide proactive and systematic assistance in obtaining, fa-
6 cilitation of and connection with health and social services, through communication, collab-
7 oration and sharing of information among providers of health and social services.

8 (b) "Health and social services" means:

9 (A) Case management;

10 (B) Health navigation;

11 (C) Mental health and addiction supports and services;

12 (D) In-home supports, including housekeeping, personal care, meal preparation, laundry
13 services and transportation; and

14 (E) Food insecurity interventions.

15 (c)(A) "Housing with services project" means an entity that coordinates two or more
16 health and social services for senior citizens and people with disabilities who are living in
17 publicly subsidized or private congregate settings.

18 (B) "Housing with services project" does not include:

19 (i) A health care facility licensed under ORS 441.015.

20 (ii) A residential facility licensed under ORS 443.410.

21 (iii) An adult foster home licensed under ORS 443.725.

22 (iv) A continuing care retirement community as defined in ORS 101.020.

23 (v) A program of all-inclusive care for the elderly as described in 42 C.F.R. 460.6.

24 (vi) Transient lodging as defined in ORS 320.300.

25 (vii) A hotel as defined in ORS 699.005.

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 **(2) Except as provided in subsection (3) of this section, a housing with services project**
2 **shall register with the Department of Human Services by submitting the name, address and**
3 **primary contact of the housing with services project to the department.**

4 **(3)(a) A housing with services project is not required to register with the Department**
5 **of Human Services under this section if the housing with services project is regulated by the**
6 **Housing and Community Services Department or the federal Department of Housing and**
7 **Urban Development.**

8 **(b) The Department of Human Services and the Housing and Community Services De-**
9 **partment shall collaborate to develop a joint inventory of the names and addresses of housing**
10 **with services projects that are not required to register under this section.**

11 **(c) The Department of Human Services shall collaborate with the federal Department of**
12 **Housing and Urban Development to obtain the names and addresses of subsidized senior**
13 **housing properties regulated by or on record at the federal Department of Housing and Ur-**
14 **ban Development.**

15 **(4) The Department of Human Services shall provide housing with services projects with**
16 **information on resources available for tenants, including but not limited to:**

17 **(a) Information about the Aging and Disability Resource Connection.**

18 **(b) Information about hotlines for reporting abuse.**

19 **(5) The Department of Human Services may adopt rules implementing this section.**

20 **SECTION 2. (1) Section 1 of this 2017 Act becomes operative on January 1, 2018.**

21 **(2) The Department of Human Services and the Housing and Community Services De-**
22 **partment may take any action before the operative date specified in subsection (1) of this**
23 **section that is necessary to enable the departments, on and after the operative date specified**
24 **in subsection (1) of this section, to exercise the duties, functions and powers conferred on**
25 **the departments by section 1 of this 2017 Act.**

26 **SECTION 3. This 2017 Act being necessary for the immediate preservation of the public**
27 **peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect**
28 **on its passage.**
