## HOUSE AMENDMENTS TO HOUSE BILL 3370

(1) As used in this section: 5 "(a) 'Coordinate' means to provide proactive and systematic assistance in obtaining, fa-6 cilitation of and connection with health and social services, through communication, collab-7 oration and sharing of information among providers of health and social services. "(b) 'Health and social services' means: 8 "(A) Case management; 9 10 "(B) Health navigation; 11 "(C) Mental health and addiction supports and services; 12 "(D) In-home supports, including housekeeping, personal care, meal preparation, laundry 13 services and transportation; and 14 "(E) Food insecurity interventions. 15 "(c)(A) 'Housing with services project' means an entity that coordinates two or more 16 health and social services for senior citizens and people with disabilities who are living in 17 publicly subsidized or private congregate settings. 18 "(B) 'Housing with services project' does not include: "(i) A health care facility licensed under ORS 441.015. 19 20 "(ii) A residential facility licensed under ORS 443.410. 21 "(iii) An adult foster home licensed under ORS 443.725. "(iv) A continuing care retirement community as defined in ORS 101.020. 22 "(v) A program of all-inclusive care for the elderly as described in 42 C.F.R. 460.6. 23 94 "(vi) Transient lodging as defined in ORS 320.300. 25 "(vii) A hotel as defined in ORS 699.005. "(2) Except as provided in subsection (3) of this section, a housing with services project 26
  - "(3)(a) A housing with services project is not required to register with the Department of Human Services under this section if the housing with services project is regulated by the Housing and Community Services Department or the federal Department of Housing and Urban Development.

"(b) The Department of Human Services and the Housing and Community Services Department shall collaborate to develop a joint inventory of the names and addresses of housing with services projects that are not required to register under this section.

- "(c) The Department of Human Services shall collaborate with the federal Department of Housing and Urban Development to obtain the names and addresses of subsidized senior housing properties regulated by or on record at the federal Department of Housing and Urban Development.
- "(4) The Department of Human Services shall provide housing with services projects with information on resources available for tenants, including but not limited to:
  - "(a) Information about the Aging and Disability Resource Connection.
  - "(b) Information about hotlines for reporting abuse.

- "(5) The Department of Human Services may adopt rules implementing this section.
- "SECTION 2. (1) Section 1 of this 2017 Act becomes operative on January 1, 2018.
- "(2) The Department of Human Services and the Housing and Community Services Department may take any action before the operative date specified in subsection (1) of this section that is necessary to enable the departments, on and after the operative date specified in subsection (1) of this section, to exercise the duties, functions and powers conferred on the departments by section 1 of this 2017 Act.

"SECTION 3. This 2017 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect on its passage."
