

HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 3391

June 30

- 1 On page 2 of the printed A-engrossed bill, line 40, delete “contraception”.
- 2 In line 41, delete “method” and insert “contraceptive drug, device or product”.
- 3 On page 3, line 11, after “identified” delete the rest of the line.
- 4 In line 13, before the period insert “as of January 1, 2017”.
- 5 In line 31, delete “or”.
- 6 In line 32, after “efficacy” insert “; or
- 7 “(e) Abortion if the insurer offering the health benefit plan excluded coverage for abortion in
- 8 all of its individual, small employer and large employer group plans during the 2017 plan year”.
- 9 On page 5, after line 26, insert:
- 10 **“SECTION 10. (1) As used in this section, ‘health benefit plan’ has the meaning given that**
- 11 **term in section 2 of this 2017 Act.**
- 12 **“(2) In consultation with the Department of Consumer and Business Services, the Oregon**
- 13 **Health Authority shall design a program to provide statewide access to abortion coverage for**
- 14 **Oregon residents enrolled in health benefit plans described in section 2 (7)(e) and (9) of this**
- 15 **2017 Act.**
- 16 **“(3) In developing the design of the program described in subsection (2) of this section,**
- 17 **the authority and the department shall consult with consumer advocates, insurers trans-**
- 18 **acting insurance in this state that offer the health benefit plans described in section 2 (7)(e)**
- 19 **and (9) of this 2017 Act and other stakeholders.**
- 20 **“(4) The authority, in collaboration with the department, shall:**
- 21 **“(a) If funding is available, take any actions authorized by state law to implement the**
- 22 **program described in subsection (2) of this section; and**
- 23 **“(b) Not later than November 1, 2017, report to the Speaker of the House of Represen-**
- 24 **tatives, the President of the Senate and the interim committees of the Legislative Assembly**
- 25 **related to health:**
- 26 **“(A) Any actions taken by the authority under paragraph (a) of this subsection; and**
- 27 **“(B) Recommendations for legislative changes necessary to fully implement the program**
- 28 **described in subsection (2) of this section.”.**
- 29 In line 27, delete “10” and insert “11”.
- 30 In line 29, delete “\$____” and insert “\$10,195,935”.
- 31 In line 31, delete “11” and insert “12”.
- 32 In line 33, delete “12” and insert “13”.
- 33 After line 36, insert:
- 34 **“SECTION 14. Section 10 of this 2017 Act is repealed on January 2, 2019.”.**
- 35 In line 37, delete “13” and insert “15”.
