

HOUSE AMENDMENTS TO HOUSE BILL 3398

By JOINT COMMITTEE ON WAYS AND MEANS

June 13

1 In line 2 of the printed bill, after the semicolon insert “creating new provisions; amending ORS
2 735.612 and sections 26, 27 and 42, chapter 698, Oregon Laws 2013; repealing ORS 735.612;”.

3 Delete lines 4 through 10 and insert:

4 “**SECTION 1. The Oregon Medical Insurance Pool Account is abolished. Any unexpended**
5 **balance remaining in the Oregon Medical Insurance Pool Account on the operative date of**
6 **this section shall be refunded to insurers in a manner determined by the Department of**
7 **Consumer and Business Services to be fair and equitable.**

8 “**SECTION 2.** Section 26, chapter 698, Oregon Laws 2013, is amended to read:

9 “**Sec. 26.** The Oregon Medical Insurance Pool [*and the Oregon Medical Insurance Pool Account*
10 *are*] **is** abolished. On the operative date of this section, the tenure of office of the members of the
11 Oregon Medical Insurance Pool Board ceases.

12 “**SECTION 3.** Section 27, chapter 698, Oregon Laws 2013, is amended to read:

13 “**Sec. 27.** Before the operative date of section 26, [*of this 2013 Act*] **chapter 698, Oregon Laws**
14 **2013**, the Oregon Medical Insurance Pool Board shall pay all valid outstanding claims against the
15 Oregon Medical Insurance Pool. [*Any balances of amounts remaining in the Oregon Medical Insur-*
16 *ance Pool Account after the payment of claims shall be refunded to insurers in a manner determined*
17 *by the board to be fair and equitable.*]

18 “**SECTION 4.** Section 42, chapter 698, Oregon Laws 2013, as amended by section 20, chapter
19 640, Oregon Laws 2013, is amended to read:

20 “**Sec. 42.** [(1) *ORS 414.868, 414.872, 735.614, 735.640 and 746.222 and section 1, chapter 803,*
21 *Oregon Laws 2009, are repealed January 1, 2014.*]

22 “[*(2)*] Sections 1, 2, 4 and 4a, chapter 698, Oregon Laws 2013, and ORS 735.600, 735.605, 735.610,
23 [735.612,] 735.615, 735.616, 735.620, 735.625, 735.630, 735.635, 735.645 and 735.650 are repealed July
24 1, 2017.

25 “**SECTION 5.** ORS 735.612 is amended to read:

26 “735.612. (1) There is established in the State Treasury, the Oregon Medical Insurance Pool
27 Account, which shall consist of:

28 “(a) Moneys appropriated to the account by the Legislative Assembly.

29 “(b) Interest earnings from the investment of moneys in the account.

30 “(c) Assessments and other revenues collected or received by the Oregon Medical Insurance
31 Pool Board.

32 “(2) All moneys in the Oregon Medical Insurance Pool Account are continuously appropriated
33 to the [*Oregon Medical Insurance Pool Board to carry out the provisions of ORS 735.600 to 735.650*
34 *and sections 1, 2 and 4, chapter 698, Oregon Laws 2013, and for the program, administered by the*
35 *Oregon Health Authority and overseen by the board, that facilitates health insurance coverage through*

1 *March 31, 2014, for individuals who were enrolled in pool coverage under ORS 735.600 to 735.650 on*
2 *December 31, 2013]* **Department of Consumer and Business Services.**

3 *“(3) The Oregon Medical Insurance Pool Board shall transfer to the Oregon Health Authority*
4 *Fund established in ORS 413.101 an amount equal to the operating budget authorized by the Legisla-*
5 *tive Assembly or as that budget may be modified by the Emergency Board or the Oregon Department*
6 *of Administrative Services, for operation of the Oregon Medical Insurance Pool Board.]*

7 **“SECTION 6. ORS 735.612 is repealed on January 2, 2018.**

8 **“SECTION 7. Section 1 of this 2017 Act becomes operative on November 1, 2017.**

9 **“SECTION 8. This 2017 Act being necessary for the immediate preservation of the public**
10 **peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect**
11 **on its passage.”.**
