House Bill 3448

Sponsored by Representative HACK; Representative LIVELY

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Directs Oregon Health Authority to require by rule, with respect to testing cannabis and cannabis-derived products for pesticides, inspection of usable marijuana in batches of 15 pounds or less from same harvest lot, and inspection of cannabinoid concentrates or extracts in batches of amount identified by authority by rule from same processing lot.

Becomes operative January 1, 2018.

Takes effect on 91st day following adjournment sine die.

2	Relating to cannabis; and prescribing an effective date.
3	Be It Enacted by the People of the State of Oregon:
4	SECTION 1. Section 2 of this 2017 Act is added to and made a part of ORS 475B.550 to
5	475B.590.
6	SECTION 2. (1) In adopting rules under ORS 475B.555 (1) with respect to testing for
7	pesticides, the Oregon Health Authority shall require inspection of:
8	(a) Usable marijuana in batches of 15 pounds or less from the same harvest lot; and
9	(b) Cannabinoid concentrates or extracts in batches of an amount identified by the au-
10	thority by rule from the same processing lot.
11	(2) For purposes of subsection (1)(a) of this section, a harvest lot is harvested marijuana
12	that is:
13	(a) Grown at the same location;
14	(b) Uniform in strain;
15	(c) Cultivated using the same growing practices;
16	(d) Harvested within a 48-hour period; and
17	(e) Cured under the same conditions.
18	(3) For purposes of subsection (1)(b) of this section, a processing lot is cannabinoid con-
19	centrates and extracts that are:
20	(a)(A) Processed with usable marijuana from the same harvest lot;
21	(B) Uniform in type;
22	(C) Processed using the same extraction practices; and
23	(D) Processed using the same operating procedures; or
24	(b)(A) Processed with usable marijuana from the same harvest lot;
25	(B) Processed using the same ingredients; and
26	(C) Processed using the same operating procedures.
27	SECTION 3. (1) Section 2 this 2017 Act becomes operative on January 1, 2018.

NOTE: Matter in boldfaced type in an amended section is new; matter [italic and bracketed] is existing law to be omitted. New sections are in **boldfaced** type.

(2) The Oregon Health Authority may take any action before the operative date specified

in subsection (1) of this section that is necessary to enable the authority to exercise, on and

- after the operative date specified in subsection (1) of this section, all the duties, powers and functions conferred on the authority by section 2 of this 2017 Act.
- SECTION 4. This 2017 Act takes effect on the 91st day after the date on which the 2017 regular session of the Seventy-ninth Legislative Assembly adjourns sine die.
