House Bill 5017

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Legislative Administration Committee, Legislative Assembly, Legislative Counsel Committee, Legislative Fiscal Officer, Legislative Revenue Officer, Commission on Indian Services and Legislative Policy and Research Committee for biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by certain legislative branch agencies.

Authorizes specified nonlimited expenditures. Declares emergency, effective July 1, 2017.

A BILL FOR AN ACT

2 Relating to the financial administration of legislative branch agencies; and declaring an emergency.

3 Be It Enacted by the People of the State of Oregon:

4 <u>SECTION 1.</u> There are appropriated to the Legislative Administration Committee, for the 5 biennium beginning July 1, 2017, out of the General Fund, the following amounts for payment

6 of the expenses of the Legislative Administration Committee, for the following purposes:

7 (1) General program...... \$ 16,985,377

8 (2) Debt service \$ 12,873,776

9 <u>SECTION 2.</u> Notwithstanding any other law limiting expenditures, the amount of 10 \$2,947,536 is established for the biennium beginning July 1, 2017, as the maximum limit for 11 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, 12 but excluding lottery funds and federal funds, collected or received by the Legislative Ad-13 ministration Committee.

<u>SECTION 3.</u> For the biennium beginning July 1, 2017, expenditures by the Legislative
Administration Committee from the Stores Revolving Account and the Property and Supplies
Stores Account established by ORS 173.790 are not limited.

17 <u>SECTION 4.</u> There is appropriated to the Legislative Assembly, for the biennium begin-18 ning July 1, 2017, out of the General Fund, the amount of \$42,934,412 for payment of ex-19 penses.

<u>SECTION 5.</u> Notwithstanding any other law limiting expenditures, the amount of \$26,520 is established for the biennium beginning July 1, 2017, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Legislative Assembly.

24 <u>SECTION 6.</u> For the biennium beginning July 1, 2017, expenditures by the Legislative 25 Assembly from the Lounge Revolving Account established by ORS 171.117 for the costs of 26 food served in members' lounges and reimbursed through receipts on the basis of sales or 27 by payroll deductions from members are not limited.

1 <u>SECTION 7.</u> There is appropriated to the Legislative Counsel Committee, for the 2 biennium beginning July 1, 2017, out of the General Fund, the amount of \$12,712,881.

3 <u>SECTION 8.</u> Notwithstanding any other law limiting expenditures, the amount of 4 \$1,638,283 is established for the biennium beginning July 1, 2017, as the maximum limit for 5 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, 6 but excluding lottery funds and federal funds, collected or received by the Legislative Counsel 7 Committee.

8 <u>SECTION 9.</u> For the biennium beginning July 1, 2017, expenditures by the Legislative 9 Counsel Committee from the ORS Revolving Account established by ORS 171.305 and from 10 the Legislative Publications Account established by ORS 171.245, for services and supplies 11 connected with printing and distributing legislative publications and the Oregon Revised 12 Statutes, are not limited.

<u>SECTION 10.</u> (1) There is appropriated to the Legislative Fiscal Officer, for the biennium
beginning July 1, 2017, out of the General Fund, the amount of \$4,972,830.

(2) Notwithstanding any other law limiting expenditures, the amount of \$3,778,407 is es tablished for the biennium beginning July 1, 2017, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding
lottery funds and federal funds, collected or received by the Legislative Fiscal Office.

<u>SECTION 11.</u> There is appropriated to the Legislative Revenue Officer, for the biennium
beginning July 1, 2017, out of the General Fund, the amount of \$3,279,279.

21 <u>SECTION 12.</u> There is appropriated to the Commission on Indian Services, for the 22 biennium beginning July 1, 2017, out of the General Fund, the amount of \$536,993.

23 <u>SECTION 13.</u> Notwithstanding any other law limiting expenditures, the amount of \$6,924 24 is established for the biennium beginning July 1, 2017, as the maximum limit for payment of 25 expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-26 cluding lottery funds and federal funds, collected or received by the Commission on Indian 27 Services.

28 <u>SECTION 14.</u> There is appropriated to the Legislative Policy and Research Committee, 29 for the biennium beginning July 1, 2017, out of the General Fund, the amount of \$9,792,462.

30 <u>SECTION 15.</u> This 2017 Act being necessary for the immediate preservation of the public 31 peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect 32 July 1, 2017.
