

HOUSE AMENDMENTS TO HOUSE BILL 5031

1 On page 1 of the printed bill, delete lines 5 through 27 and delete page 2 and insert:

2 “**SECTION 1.** There are appropriated to the Department of State Police, for the biennium
3 beginning July 1, 2017, out of the General Fund, the following amounts, for the following
4 purposes:

17 “**SECTION 2.** Notwithstanding any other law limiting expenditures, the following amounts
18 are established for the biennium beginning July 1, 2017, as the maximum limits for payment
19 of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-
20 cluding lottery funds and federal funds, collected or received by the Department of State
21 Police, for the following purposes:

- 22 (1) Patrol services, criminal
23 investigations and gaming
24 enforcement \$ 60,338,541
25 (2) Fish and wildlife enforcement... \$ 24,233,764
26 (3) Forensic services and
27 State Medical Examiner..... \$ 1,856,371
28 (4) Administrative services,

31 and office of the State Fire
32 Marshal \$ 49,405,725
33 (5) Debt service \$ 149,632

34 “**SECTION 3.** Notwithstanding any other law limiting expenditures, the following amounts
are established for the biennium beginning July 1, 2017, as the maximum limits for payment

1 of expenses from federal funds collected or received by the Department of State Police for
2 the following purposes:

- 3 (1) Patrol services and criminal
4 investigations \$ 2,119,841
- 5 (2) Fish and wildlife enforcement... \$ 2,533,536
- 6 (3) Forensic services \$ 2,618,845
- 7 (4) Administrative services,
8 agency support, criminal
9 justice information services
10 and office of the State Fire
11 Marshal \$ 5,120,134

12 “SECTION 4. Notwithstanding any other law limiting expenditures, the amount of
13 \$8,309,518 is established for the biennium beginning July 1, 2017, as the maximum limit for
14 payment of expenses from moneys allocated from the Parks and Natural Resources Fund to
15 the Department of State Police for fish and wildlife enforcement activities.

16 “SECTION 5. This 2017 Act being necessary for the immediate preservation of the public
17 peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect
18 July 1, 2017.”.
