

A-Engrossed House Bill 5039

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Department of Veterans' Affairs for certain biennial expenses.

Limits biennial expenditures by department from lottery moneys for certain purposes.

Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and Oregon War Veterans' Bond Sinking Account, but excluding lottery funds and federal funds, collected or received by department.

Limits biennial expenditures by department from federal funds.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2017.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There are appropriated to the Department of Veterans' Affairs, for the**
6 **biennium beginning July 1, 2017, out of the General Fund, the following amounts, for the**
7 **following purposes:**

8 (1) **For services provided**
9 **by the Department of**
10 **Veterans' Affairs \$ 5,576,273**

11 (2) **For payments to counties**
12 **pursuant to ORS 406.462 \$ 1,805,571**

13 (3) **For payments to veterans'**
14 **service organizations**
15 **pursuant to ORS 406.310 \$ 118,156**

16 (4) **For debt service \$ 1,017,323**

17 **SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts**
18 **are established for the biennium beginning July 1, 2017, as the maximum limits for payment**
19 **of expenses from lottery moneys allocated from the Veterans' Services Fund established**
20 **under section 1, chapter __, Oregon Laws 2017 (Enrolled Senate Bill 140), to the Department**
21 **of Veterans' Affairs, for the following purposes:**

7 **SECTION 3.** (1) Notwithstanding any other law limiting expenditures, the amount of
8 \$100,457,558 is established for the biennium beginning July 1, 2017, as the maximum limit for
9 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts
10 and the Oregon War Veterans' Bond Sinking Account, but excluding lottery funds and fed-
11 eral funds, collected or received by the Department of Veterans' Affairs for administration,
12 grants and services supplied to veterans.

13 (2) This section does not limit expenditures from the Oregon War Veterans' Bond Sinking
14 Account for purposes described in section 5 of this 2017 Act.

15 **SECTION 4.** Notwithstanding any other law limiting expenditures, the amount of \$500,000
16 is established for the biennium beginning July 1, 2017, as the maximum limit for payment of
17 expenses from federal funds collected or received by the Department of Veterans' Affairs.

18 **SECTION 5.** For the biennium beginning July 1, 2017, expenditures by the Department
19 of Veterans' Affairs for the following purposes are not limited:

- 20 (1) Debt service;
- 21 (2) Professional services and related costs associated directly with bond sales;
- 22 (3) Loans to veterans; and
- 23 (4) Payments on behalf of borrowers for property taxes, city liens, fire insurance, mort-
24 gage cancellation insurance and repairs to and miscellaneous charges for borrower-owned
25 property that are charged to the loan account and repaid along with the payment of loan
26 interest and principal.

27 **SECTION 6.** This 2017 Act being necessary for the immediate preservation of the public
28 peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect
29 July 1, 2017.
