House Bill 5040

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Directs Oregon Watershed Enhancement Board to allocate moneys from Watershed Conservation Operating Fund to various state agencies to implement Article XV, section 4b, of Oregon Constitution.

Limits biennial expenditures by board from federal funds and lottery funds.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by board.

Directs board to establish by rule process for allocating available moneys in Natural Resources Subaccount of Parks and Natural Resources Fund.

Declares emergency, effective July 1, 2017.

A BILL FOR AN ACT

Relating to the financial administration of the Oregon Watershed Enhancement Board; and declaring an emergency.

4 Be It Enacted by the People of the State of Oregon:

<u>SECTION 1.</u> Of the moneys deposited into the Watershed Conservation Operating Fund established under ORS 541.945, the Oregon Watershed Enhancement Board shall allocate \$8,321,594 to the Department of State Police for fish and wildlife activities to implement Article XV, section 4b, of the Oregon Constitution.

SECTION 2. Of the moneys deposited into the Watershed Conservation Operating Fund established under ORS 541.945, the Oregon Watershed Enhancement Board shall allocate \$5,590,982 to the State Department of Fish and Wildlife for activities and projects to implement Article XV, section 4b, of the Oregon Constitution.

SECTION 3. Of the moneys deposited into the Watershed Conservation Operating Fund established under ORS 541.945, the Oregon Watershed Enhancement Board shall allocate \$7,072,247 to the State Department of Agriculture for activities and projects to implement Article XV, section 4b, of the Oregon Constitution.

SECTION 4. Of the moneys deposited into the Watershed Conservation Operating Fund established under ORS 541.945, the Oregon Watershed Enhancement Board shall allocate \$4,402,446 to the Department of Environmental Quality for activities and projects to implement Article XV, section 4b, of the Oregon Constitution.

SECTION 5. Of the moneys deposited into the Watershed Conservation Operating Fund established under ORS 541.945, the Oregon Watershed Enhancement Board shall allocate \$391,888 to the Water Resources Department for activities and projects to implement Article XV, section 4b, of the Oregon Constitution.

<u>SECTION 6.</u> Notwithstanding any other law limiting expenditures, the amount of \$6,970,729 is established for the biennium beginning July 1, 2017, as the maximum limit for payment of expenses by the Oregon Watershed Enhancement Board from lottery moneys

SECTION 7. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2017, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Oregon Watershed Enhancement Board, for the following purposes:

(1) Operations...... \$ 39,144

(2) Grants...... \$ 3,742,216

<u>SECTION 8.</u> Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2017, as the maximum limits for payment of expenses from federal funds collected or received by the Oregon Watershed Enhancement Board, for the following purposes:

- (1) Operations...... \$ 2,345,916
- **(2) Grants....... \$ 39,322,808**

SECTION 9. (1) The Oregon Watershed Enhancement Board shall establish by rule a process for allocating on a quarterly basis available moneys in the Natural Resources Subaccount of the Parks and Natural Resources Fund, established under ORS 541.942, to fulfill the biennial allocations made in this 2017 Act. Except as provided in subsection (2) of this section, all quarterly allocations shall be set at one-eighth of the biennial allocations.

(2) If, in any quarter, the moneys transferred from the Oregon State Lottery Fund to the Parks and Natural Resources Fund are insufficient to pay for the quarterly allocations established under subsection (1) of this section, the allocations shall be reduced proportionately by amounts sufficient to accommodate the revenue shortfall.

SECTION 10. This 2017 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect July 1, 2017.
